AMENDMENT TO CHANGE OF DIRECTOR'S INTEREST NOTICES

These additional shares were never issued, and the total issued capital of Azimuth Resources has always been correctly stated. This error has not resulted in Mr Felton being entitled to participate in any pro rata offers or issues.
