# Update on activities at Bundarra gold project

- **CSA Global engaged to assist with scoping activities**
- **Ongoing discussion with Chinese technical institute, BGRIMM**
- **Strong shareholder support for new company strategy**

Gold and manganese exploration company **Bligh Resources Limited (Bligh) (ASX: BGH)** is pleased to provide an update to shareholders on activities at the Bundarra Gold project.

Bligh has recently engaged CSA Global to assist with loading historical drill hole data into a Geotech database (Attachment 1) which will then be used as a starting point for further infill drilling associated with expanding the existing pits. The company has also commenced a scoping study over the Bundarra tenements which will investigate mine feasibility over a number of scenarios.

CSA is a leading geological, mining and management consulting company with 25 years' experience in the international mining industry, covering all stages of the exploration and mining cycles.

Bligh is also pleased to advise that members of the Board have recently undertaken a trip to China, where the Company's Non-Executive Director Mr Hanjing Xu has facilitated discussions with a leading Chinese technical institute, Beijing General Research Institute of Mining and Metallurgy (BGRIMM). Bligh has targeted this group to assist with engineering, procurement and supervision of the proposed milling plant to process the ore at the Bundarra Gold Project.

BGRIMM is a Chinese institute engaged in R&D and engineering services relating to mineral resource development and utilization, including mineral processing and metallurgy. The company ranks as one of the top national institutes in China in terms of engineering capability.

Bligh CEO Mr Robert Benussi said: "Our contract with CSA will enable the company to progress scoping activities at the prospective Bundarra Gold Project and we are pleased to be partnering with such a reputable provider.

"Bligh's shareholders are very supportive of the company's new strategy, and our major shareholders are assisting us in progressing discussions regarding financing opportunities and introductions with leading technical institutes such as Beijing General Research Institute of Mining and Metallurgy. These discussions are ongoing, as we look to form a strategic relationship that will assist us in designing and constructing a milling plant at Bundarra.

"We will continue to update shareholders as our exploration and development plans progress."

Bligh has increased its exposure to resource development through SR Mining Bundarra Project. The JORC Resources at Bundarra offers Bligh a near term gold production opportunity in the Eastern Goldfields of Western Australia.

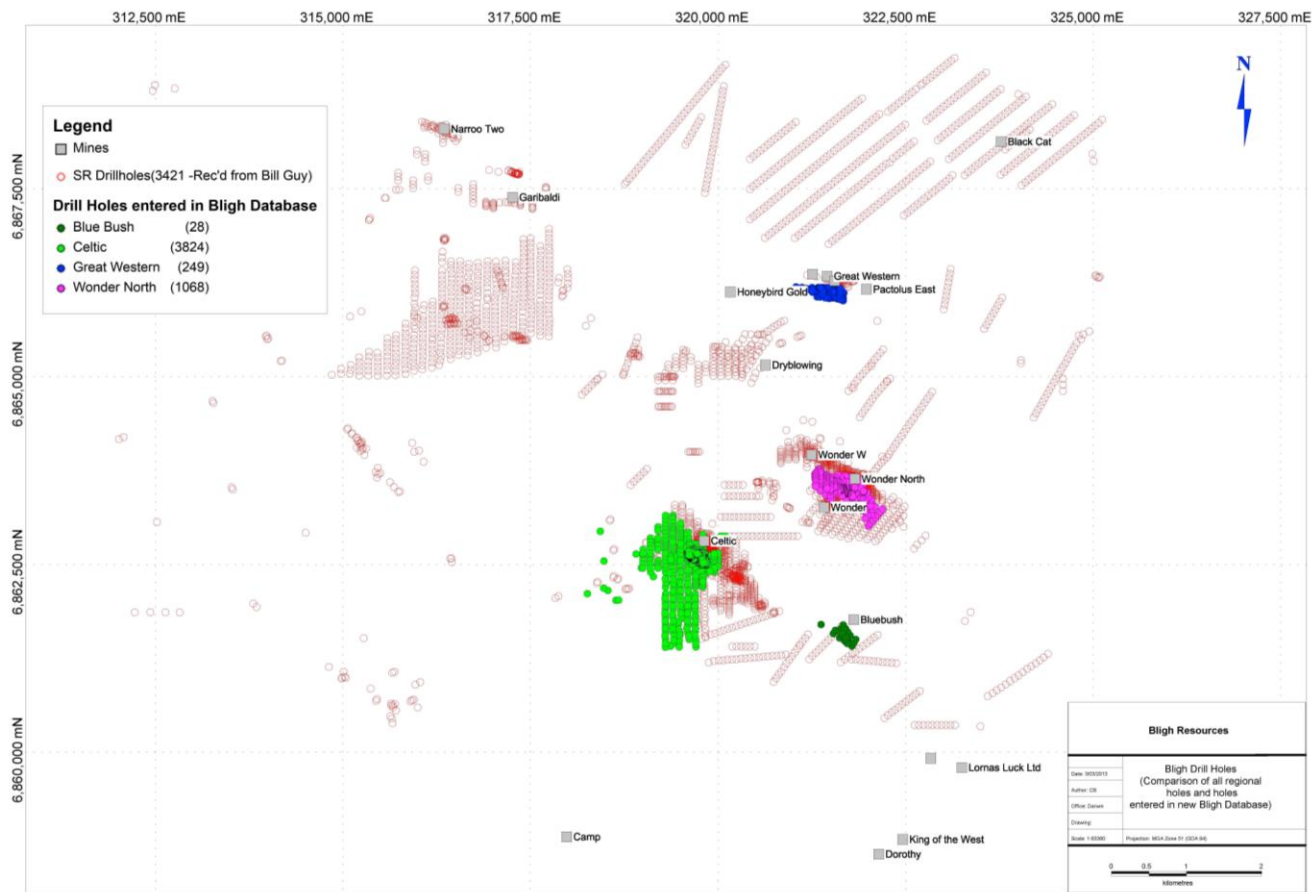
