Eumundi Group Limited - non-renounceable rights issue Notice to shareholder

Eumundi Group Limited (**Company**) is pleased to announce a non-renounceable rights issue to eligible shareholders, on the basis of 1 new share for every 1 share held at a price of \$0.045 per new share (**New Shares**), to raise approximately \$6,387,736 (before costs), based on the Company's undiluted share capital (**Rights Issue**).

Taylor Collison has been appointed underwriter of the Rights Issue.

The Rights Issue will be available to all registered shareholders in Australia and New Zealand who hold shares and are entitled to participate at 7.00pm ADST on Friday 11 October 2013 (**Record Date**). Shares issued under the Rights Issue will rank equally with all shares currently on issue.

In accordance with the Listing Rules of the ASX, the Company has considered the number of shareholders with registered addresses in various jurisdictions outside of Australia and New Zealand and the size of the shareholdings held by those shareholders. Taking this into consideration, as well as the costs of complying with the legal requirements and the requirements of the regulatory authorities relating to the shareholders with registered addresses in various jurisdictions outside of Australia and New Zealand, the Company has formed the view that it is unreasonable to extend the Rights Issue to those shareholders. Taylor Collison Limited has been appointed as Nominee to deal with the entitlements of the Company's foreign shareholders outside of Australia and New Zealand.

The purpose of the Rights Issue is to raise approximately \$6,387,736, excluding the costs of the Rights Issue. The funds raised from the Rights Issue will be used to fund the costs of the Rights Issue, identifying, investigation and facilitating future opportunities and acquisitions that arise, to develop and improve the Company's property investments and to fund general working capital requirements (including managing existing debt obligations pending the identification of opportunities).

The Rights Issue is being made without a disclosure document, under the exemption granted in section 708AA of the *Corporations Act 2001 (Cth)* (**Corporations Act**). The Company will prepare and send an offer document to shareholders on 17 October 2013, as set out in the timetable above.

Excluded information

The Company advises that as at the date of this notice there is no information:

- (a) that has been excluded from a continuous disclosure notice in accordance with the ASX Listing Rules; and
- (b) that investors and their professional advisors would reasonably require for the purpose of making an informed assessment of:
 - (1) the assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
 - (2) the rights and liabilities attaching to the New Shares.

Further information

The Company anticipates that, approximately 141,949,690 New Shares will be issued under the Rights Issue. The New Shares will be issued for \$0.045 each.

On completion of the Rights Issue, the issued capital of the Company will comprise approximately 283,899,380 shares.

The New Shares will rank equally in all respects with the Company's existing shares. If an eligible shareholder's entitlement results in a fraction of a New Share, the shareholder's entitlement will be rounded up to the nearest whole number.

There will be no deferred settlement trading in respect of the New Shares to be issued under the Rights Issue. Trading in the New Shares is expected to commence on 12 November 2013, being the first business day following the expected date of allotment of New Shares.

An Appendix 3B applying for quotation of the New Shares was lodged with ASX on 2 October 2013.

The Company encourages all eligible shareholders to participate in the capital raising.
