On 11 June 2013 the Company announced that holders of expiring listed options as at the close of business on 30 June 2013 would be offered, subject to shareholder approval, the opportunity to take part in a Priority Entitlement Offer (Offer). Under the terms of the Offer, optionholders will be able to subscribe for one New Option for every two expiring options held. New Options will be exercisable at 3.5 cents each and will expire on 30 June 2016. Offer documents will be despatched in due course.
