# Re: Havilah Resources NL (ACN 077 435 520) Substantial Shareholder Notices under section 671B of the Corporations Act

Havilah Resources NL (the Company) recently conducted an independent review of the interests that directors of the Company have in shares in the Company (Shares) and compliance with the disclosure requirements under section 671B of the Corporations Act 2001 (Cth) (Corporations Act) and the ASX Listing Rules.

As a result of that independent review, the Company has become aware that due to an inadvertent administrative oversight, director Christopher Giles has not lodged substantial shareholders notices required under section 671B of the Corporations Act since the Company was listed on 21 March 2002 (Listing Date), in both a personal capacity, and on behalf of Trindal Pty Ltd (Trindal) (a company that he controls).

The attached substantial shareholder notices received today from Dr Giles rectify this unintentional error:

- 1. Form 603 (Notice of Initial Substantial Holder) C Giles;
- 2. Form 604 (Notice of Change in Interests of Substantial Holder) C Giles;
- 3. Form 603 (Notice of Initial Substantial Holder) Trindal; and
- 4. Form 604 (Notice of Change in Interests of Substantial Holder) Trindal.

We confirm that the independent review shows that the Company has complied with ASX Listing Rule 3.19A in respect to Dr Giles' notifiable interests by lodging Appendices 3Y (Change of Directors' Interest Notice) since the Listing Date. The Company has also disclosed Dr Giles' interests in Shares in each Annual Report of the Company since the Listing Date. Further, neither he nor Trindal has had any associates (within the meaning of section 12 of the Corporations Act) at any time since having a relevant interest in Shares.

Accordingly, notwithstanding the abovementioned failure to lodge notices required under section 671B of the Corporations Act, the market has been kept fully informed of Dr Giles' and Trindal's relevant interests in Shares at all times since the Listing Date.
