## DISCOVERY ZONE COPPER-GOLD-IRON

Hannans Reward Ltd (ASX:HNR) (Hannans) advises that further to the ASX Announcement dated 24 December 2012, the proposed sale of its Discovery Zone copper-gold-iron prospect (Discovery Zone) to Avalon Minerals Limited (ASX:AVI) (Avalon) will not be proceeding as the parties were unable to agree terms.

The Discovery Zone located near Kiruna, Sweden has a JORC Inferred Mineral Resource of 10.9Mt @ 0.31% Cu, 38.7% Fe and 0.08g/t Au<sup>1</sup> reported above a 20% Fe cut-off.

Hannans Managing Director, Damian Hicks said, "With the proposed sale transaction coming to an end, we will now assess whether to consolidate the Discovery Zone copper-gold-iron prospect with the Rakkuri Iron Project or the Pahtohavare Copper-Gold Project<sup>2</sup>. Processing the Discovery Zone ore will enable either copper-gold or iron credits to be recovered which will have a very positive impact on the economics of the relevant project."
