Supplementary Prospectus No. 2 dated 17 April 2013 ("Supplementary Prospectus No. 2"), Supplementary Prospectus No. 3 dated 31 May 2013 ("Supplementary Prospectus No. 3"), Supplementary Prospectus No. 4 dated 2 July 2013 ("Supplementary Prospectus No. 4") and Supplementary Prospectus No. 5 dated 2 October 2013 ("Supplementary Prospectus No. 5"), for the iShares MSCI Hong Kong ETF ("Fund"), issued by iShares, Inc. (the "Company") and relating to shares of the Company referable to the Fund and CDIs over such shares. This Supplementary Prospectus No. 6 must be read together with the Prospectus, Supplementary Prospectus No. 1, Supplementary Prospectus No. Supplementary 2. Prospectus No. 3. Supplementary Prospectus No. 4 and Supplementary Prospectus No. 5.

A copy of this Supplementary Prospectus No. 6 has been lodged with the Australian Securities and Investments Commission ("ASIC") and released to the Australian Securities Exchange ("ASX"). Neither ASIC nor ASX take any responsibility for the contents of this Supplementary Prospectus No. 6.

The Company does not consider the modifications in this Supplementary Prospectus No. 6 to be materially adverse from the point of view of an investor.

This Supplementary Prospectus No. 6 is dated 18 December 2013 and was lodged with ASIC on that date and sets out the following changes in respect of the Fund:

# Purpose of this Supplementary Prospectus No. 6

This Supplementary Prospectus No. 6 sets out changes to the Fund's Prospectus.

## Change in Local Agent – Replacement of BlackRock Asset Management Australia Limited with BlackRock Investment Management (Australia) Limited

Effective from 18 December 2013, BlackRock Investment Management (Australia) Limited ACN 006 165 975 ("BIMAL") replaced BlackRock Asset Management Australia Limited ACN 001 804 566 ("BAMAL") as the Company's local agent as a result of an internal corporate re-structure. From that date, BIMAL also performs all other roles previously performed by BAMAL in connection with the Offer, including in relation to the Company's listing on ASX and the quotation and trading of shares (and CDIs) in the Company on ASX, as described in the Prospectus.

The Prospectus, lodged with ASIC, in respect of the Fund is amended as follows:

### CHANGES TO PROSPECTUS

- 1. The words "BlackRock Asset Management Australia Limited (ABN 33 001 804 566, AFSL No. 225398) ("BAMAL")" in section 1.7 are replaced with the words "BlackRock Investment Management (Australia) Limited (ACN 006 165 975, ASFL 230523) ("BIMAL")".
- 2. The definition for "BAMAL" in the Glossary is replaced with the following definition:

"BIMAL" means BlackRock Investment Management (Australia) Limited ACN 006 165 975 (Australian financial service licence number 230523).

 All other references to "BlackRock Asset Management Australia Limited" or "BAMAL" throughout the Prospectus are replaced with references to "BlackRock Investment Management (Australia) Limited" or "BIMAL" respectively.
