Payment of Interim Dividend

The Board of LaserBond is pleased to announce that the fully-franked final 2013 dividend of 0.2 cents per share was paid to shareholders today.

LaserBond also advises that 484,964 new shares were issued today in lieu of cash dividends to participants in the Dividend Reinvestment Plan ('DRP'). The shares were issued at \$0.1099 per share, representing a 5% discount to the 5 day volume weighted market price following the Dividend Record Date, calculated in accordance with the DRP Terms and Conditions. The DRP Terms and Conditions are available on LaserBond's website www.laserbond.com.au.

Following is the Appendix 3B for the issue of the new shares pursuant to the DRP. This issue of shares represents a 0.6% increase in holdings.

Shareholders that have holdings with addresses in Australia are reminded that the cash component of dividends will only be paid by Electronic Funds Transfer to your nominated financial institution account. Accordingly, all Australian based shareholders that have not elected to fully participate in the DRP must at some stage have completed the "Request for Direct Crediting of Payments via EFT" form and returned it to the share registry, Boardroom Pty. Ltd. The EFT form was recently mailed to all shareholders that have not already supplied banking details or elected to fully participate in the DRP. (Shareholders that have already provided banking details need not complete the form again.)
