## **Request for Trading Halt**

Pursuant to Listing Rule 17.1, Mamba Minerals Limited (Mamba) requests an immediate trading halt be granted by the ASX, with respect to Mamba's quoted securities.

In accordance with Listing Rule 17.1, Mamba advises:

- (a) the reason for the request is to facilitate an orderly market in the company's securities pending an announcement by the company in relation to an update on the current drilling programme at Mamba's Snelgrove Lake Project;
- (b) Mamba anticipates the trading halt to remain in place until the earlier of such time as it makes an announcement in relation to the current drilling programme and the expiration of the period permitted under listing rule 17.1.1; and
- (c) Mamba is not aware of any reason why the trading halt should not be granted.
