## **ICAC Report - Operation Acacia**

NuCoal Resources Ltd (ASX: NCR) (**NuCoal**) wishes to inform shareholders that it has now been advised by the Independent Commission Against Corruption (**ICAC**) that any recommendations (if any are made) regarding EL 7270 will now be included in a second report about Operation Acacia to Parliament and not in the first report as advised to shareholders on 19 August 2013.

The first report, which will deal with factual matters surrounding the initial granting of EL 7270 to Doyles Creek Mining Pty Ltd in December 2008, is still expected to be released by the end of August 2013.

NuCoal awaits a media release by the ICAC to confirm the timing of release of the two reports about Operation Acacia.

NuCoal will continue representations to the Premier and other relevant Ministers in the NSW Government regarding a period of consultation with NuCoal after the second report is tabled, but before the Government decides on any action about EL 7270 (if any is recommended).

NuCoal urges Shareholders who have not yet written to Government to express their views before the first ICAC report is published. For relevant addressees please see below.
