## **Quarterly Report**

In the past quarter, the Company has announced agreements regarding five (5) acquisitions.

## 1. LEVEL 91

On 12 April 2013, the Company announced the completion of the acquisition of Level 91. This business has now been fully integrated into the Company's operations and is performing well.

## 2. BRILLIANT COMPANY

On 28 May 2013, the Company announced the acquisition of Brilliant Company, an Online Marketing Services and Consultancy business based in Perth, Western Australia, specialising in website design and search engine optimisation.

#### 3. DREAM CONSULTANCY

On 4 June 2013, the Company announced that it had entered into a Terms Sheet with Dream Ventures Pty Ltd for the acquisition of Dream Consultancy and Search Engine Experts (see separate description below). Dream Consultancy (<a href="www.dreamconsultancy.com.au">www.dreamconsultancy.com.au</a>) is a winner of a 2012 SmartCompany Smart50 award. Dream Consultancy services small business clients through to Fortune 500 companies, providing them with web design and development across a large range of website platforms, mobile website development, e-commerce solutions, content management, online marketing, graphic design, app development, and domain name and hosting services.

## 4. SEARCH ENGINE EXPERTS

Also on 4 June 2013, the Company announced that it had entered into a Terms Sheet for the acquisition of Search Engine Experts. Search Engine Experts (<a href="www.searchx.com.au">www.searchx.com.au</a>) is a dual top 100 winner of the BRW Fast Starters awards, receiving an award in both 2012 and 2013. Search Engine Experts works with some of Australia's leading brands such as Hyundai, and provides Search Engine

Optimisation, Search Engine Marketing, Social Media Management and Online Reputation Management services.

## 5. MANAGED IT SERVICES BUSINESS

On 11 June 2013, the Company announced that it had entered into a Terms Sheet with Eren Enterprises Pty Ltd for the acquisition of their managed IT services business. The business is based in Melbourne, Victoria, and also manages clients in Sydney and in the USA. The business is highly profitable and will form the hub for the amalgamation of all of the Company's IT operations nationally.
