Dear Sir/Madam,

We attach a Form 604 in relation to Transpacific SPS Trust (ARSN 120 322 625) ("Transpacific Trust"), which was not lodged within prescribed timeframes. We now lodge this form with the understanding that your records will be updated to reflect the positions held on the relevant dates. This form was not lodged on the relevant date, as the substantial holding percentage was incorrectly calculated. Once correctly calculated, it showed that The Goldman Sachs Group, Inc. and its subsidiaries ("GSGI") had an interest in 5.62% of Transpacific Trust's share capital on 7 October 2013, representing a change of more than 1% since the previous notice dated 21 February 2013. Accordingly and upon becoming aware of this event, we now lodge Form 604 reflecting that GSGI's interest in Transpacific Trust has changed by more than 1% as of 7 October 2013.
