

SHANDONG STRATEGIC ALLIANCE

TUC Resources Ltd (ASX:TUC) announces that on 6th May 2013 the Company received brief correspondence from The Chief Representative in Australia of the Shandong Provincial Bureau of Geology and Mineral Resources (“Shandong Bureau”) in relation to the Memorandum of Understanding which was signed between the two parties on 15th January 2013.

The correspondence stated that “...we presently are unable to take this (MOU) forward” and continued “we are very hopeful that we may be able to reinstate the MOU in the not too distant (future) as there are still discussions going on in China in regard to this project.”

TUC has now requested meetings with new leadership of the Shandong Bureau in China to better understand this new position and possible solutions to the current impasse.

As of this date, no meetings have been able to be arranged.

TUC directors are extremely disappointed with this development.

The Company will maintain dialogue with the Shandong Bureau, on a non-exclusive basis, whilst opening up discussions with other interested parties and reserving its rights under the executed MOU.


