## Wayne Malouf Appointed Interim CEO of WTR Cost-Cutting and Joint Venture Initiatives Proceeding

World Titanium Resources Ltd (ASX:WTR) announces today the appointment of Mr. Wayne Malouf as interim Chief Executive Office of the Company, succeeding Mr. Bruce Griffin. The Company continues to work on the proposed joint venture with Sichuan Lomon Titanium Co., Ltd., and also announces that a Board committee chaired by Mr. Jeff Williams is implementing immediate cost cuts and conducting a review to implement cost reductions throughout the Company. The notice of general meeting to consider the Lomon transaction is expected to be issued within two weeks.

## **About World Titanium Resources**

World Titanium Resources (ASX:WTR) is an Australian Securities Exchange listed mineral sands company that owns 100% of the Tier 1 Toliara Sands Project in Madagascar, which includes a current Mineral Resource [JORC Code requires disclosure of category – inferred/indicated/measured – or if combined a breakdown of categories] of 959Mt grading 6.10% total heavy mineral (THM) at Ranobe.

Phase 1 will focus on mining a 161Mt Mineral Reserve [JORC Code requires disclosure of category – probable/proved – or if combined a breakdown of categories] at an average grade of 8.20% THM. Phase 1 is estimated to produce 407,000 tonnes of ilmenite and 44,000 tonnes of zircon and rutile rich concentrate per annum over an initial 21 year mine life.

The Toliara Sands Exploration permits at Ranobe, Ankililoaka, Basibasy and Morombe contain a total exploration target in excess of 4,700Mt of mineralisation<sup>1</sup> [JORC Code requires an exploration target to be express as ranges of potential quantity and grade and include a detailed explanation of the basis for the statement].
