Under section 608(8) of the Corporations Act, pursuant to two forward contracts between SKI and Deutsche Bank AG, Sydney Branch (DB) described in the documents attached as Annexure A and Annexure B to the Notice (Forward Contracts) SKI was taken to have a relevant interest in any DUET Securities in which DB has a relevant interest up to a maximum of 157,500,000 DUET Securities. At the time the Notice was given, SKI did not know how many DUET Securities DB held.	11.95%	107,566,666 DUET Securities SKI is not the owner of the DUET Securities. Accordingly, at that time, SKI became aware that it has a relevant interest in 107,566,666 DUET Securities. Nevertheless, under the Forward Contracts, SKI still has an enforceable right to acquire 124,500,000 DUET Securities from DB, and at DB's election SKI will acquire a further 33,000,000 DUET Securities from DB, and after SKI acquires the DUET Securities from DB, SKI will have the ability to vote 124,500,000 DUET Securities if SKI acquires 124,500,000 DUET Securities from DB or 157,500,000 DUET Securities if SKI acquires a total of 157,500,000 DUET Securities from DB.	8.16% Under section 608(8) of the Corporations Act, pursuant to the Forward Contracts, SKI has a relevant interest in the DUET Securities referred to in the DB Notice, having a voting power of 8.16%. Nevertheless, under the Forward Contracts, SKI still has an enforceable right to acquire 124,500,000 DUET Securities from DB, and at DB's election SKI will acquire a further 33,000,000 DUET Securities from DB, and after SKI acquires the DUET Securities from DB, SKI will have the ability to vote DUET Securities with a voting power of 9.45% if SKI acquires 124,500,000 DUET Securities from DB or 11.95% if SKI acquires a total of 157,500,000 DUET Securities from DB.


