NON-RENOUNCEABLE PRO RATA RIGHTS ISSUE – NOTIFICATION OF SHORTFALL

Firestrike Resources Limited (ASX: FIE) (Company) is pleased to advise that the Company's rights issue announced on 12 May 2014 closed at 5pm (WST) on 2 June 2014.

The Rights Issue raised AUD \$119,974 before issue costs.

The Rights Issue was supported by the Company's shareholders, with applications subscribing for 5,998,685 shares representing a take-up of 38%.

The Company is working with the underwriter, Workpower Pty Ltd to place the shortfall of 10,001,315 shares and will advise shareholders as soon as possible.

The Company expects that the new Firestrike shares will be allotted, and holding statements despatched to shareholders, on or before 10 June 2014.
