Titan Energy Services Limited (**Company**) has today announced the completion of the purchase of the Pangaea Rig (**Rig**). Accordingly, the Company has issued 1,539,952 fully paid ordinary shares in the Company (**Shares**) to Pangaea Drilling Pty Limited as part consideration for the Rig. Further details regarding the purchase were announced to the market on 6 May 2014.

As required under section 708A(6) of the Corporations Act 2001 (**Act**), the Company gives notice that:

- 1 The Shares were issued without disclosure to [Pangaea Drilling Pty Ltd] under Part 6D.2 of the Act.
