Description of this fund

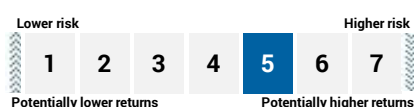
The Australian Property Fund invests in property assets listed on the Australian Securities Exchange and is designed to track the return on the S&P/ASX 200 A-REIT Equal Weight Index.

Total value of the fund: \$36,505,070

The date the fund started: 16 December 2014

What are the risks of investing?

Risk indicator for the Australian Property Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

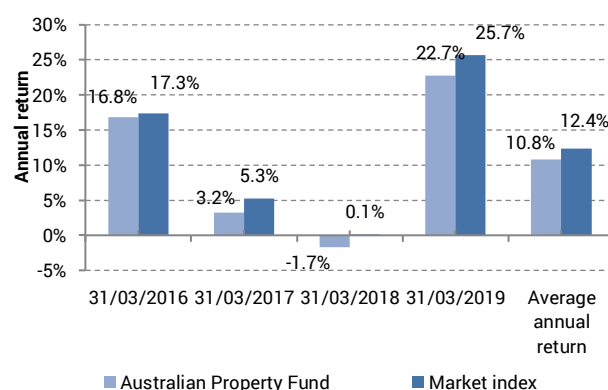
How has the fund performed?

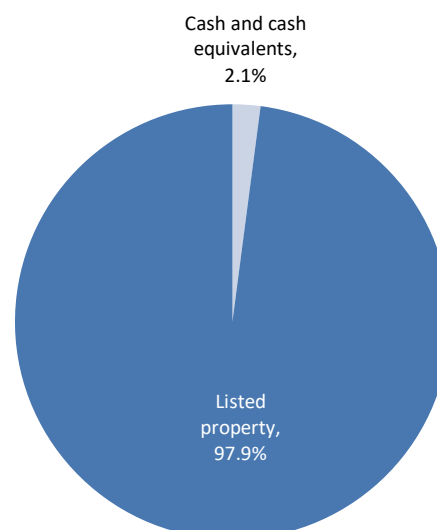
Example of how this applies to an investor

Tara had \$10,000 in the fund and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted of \$2,274 (that is 22.74% of her initial \$10,000). This gives Tara a total return after tax of \$2,274 for the year.
