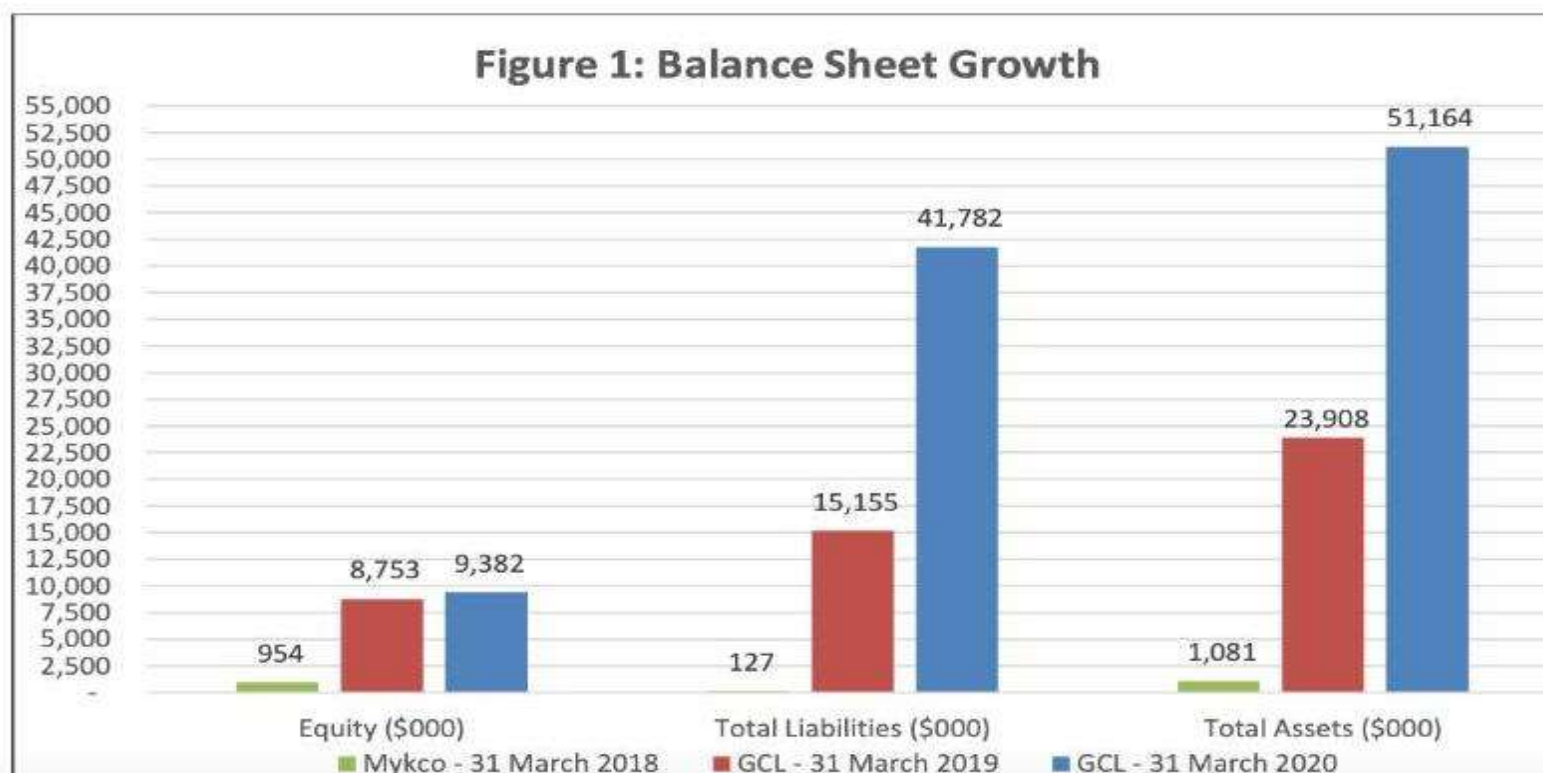
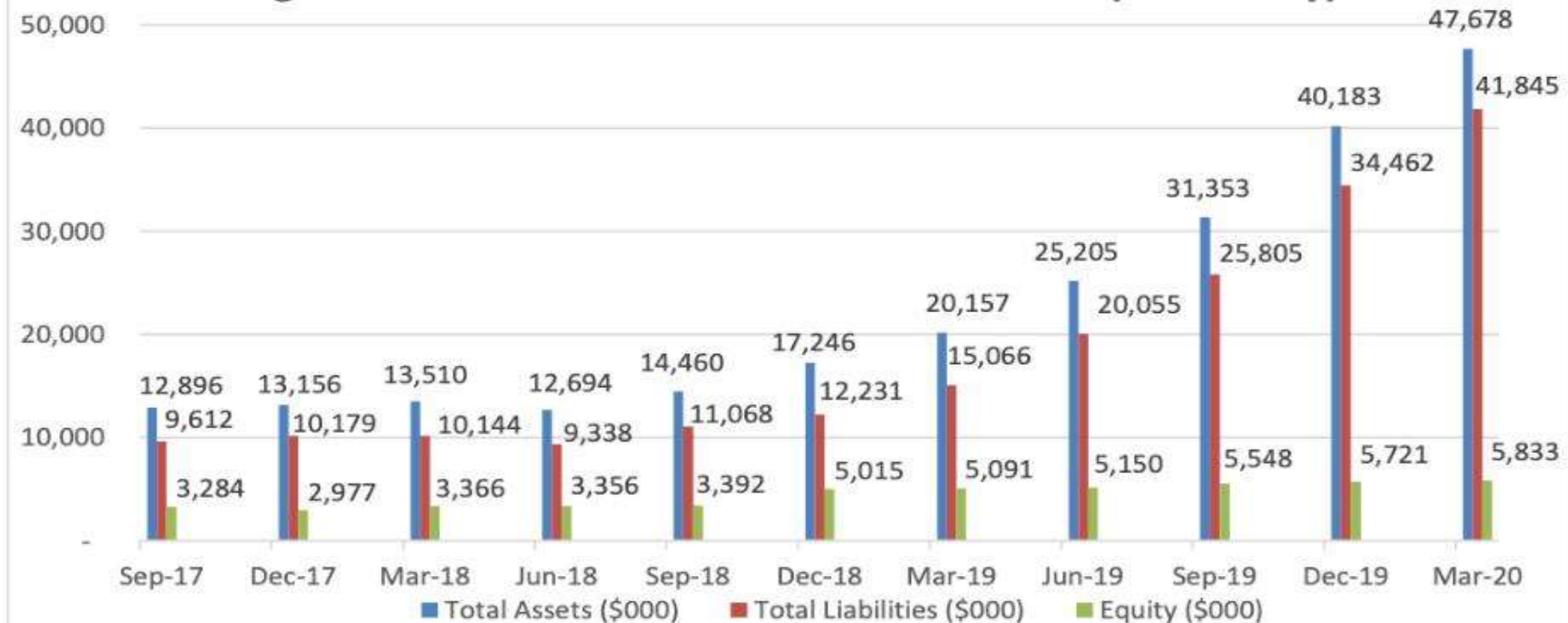
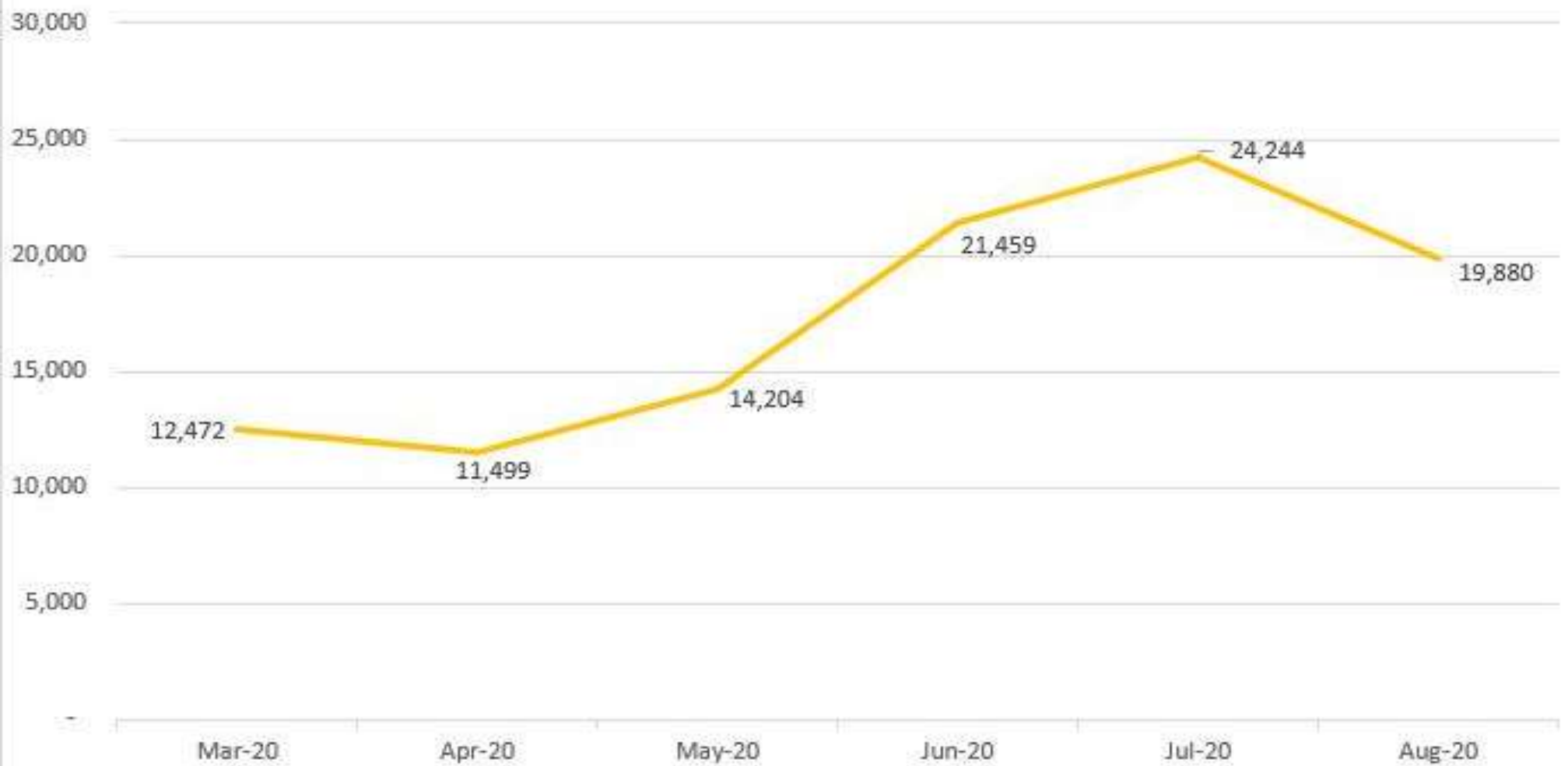


Figure 2: Growth in General Finance Limited (Subsidiary)

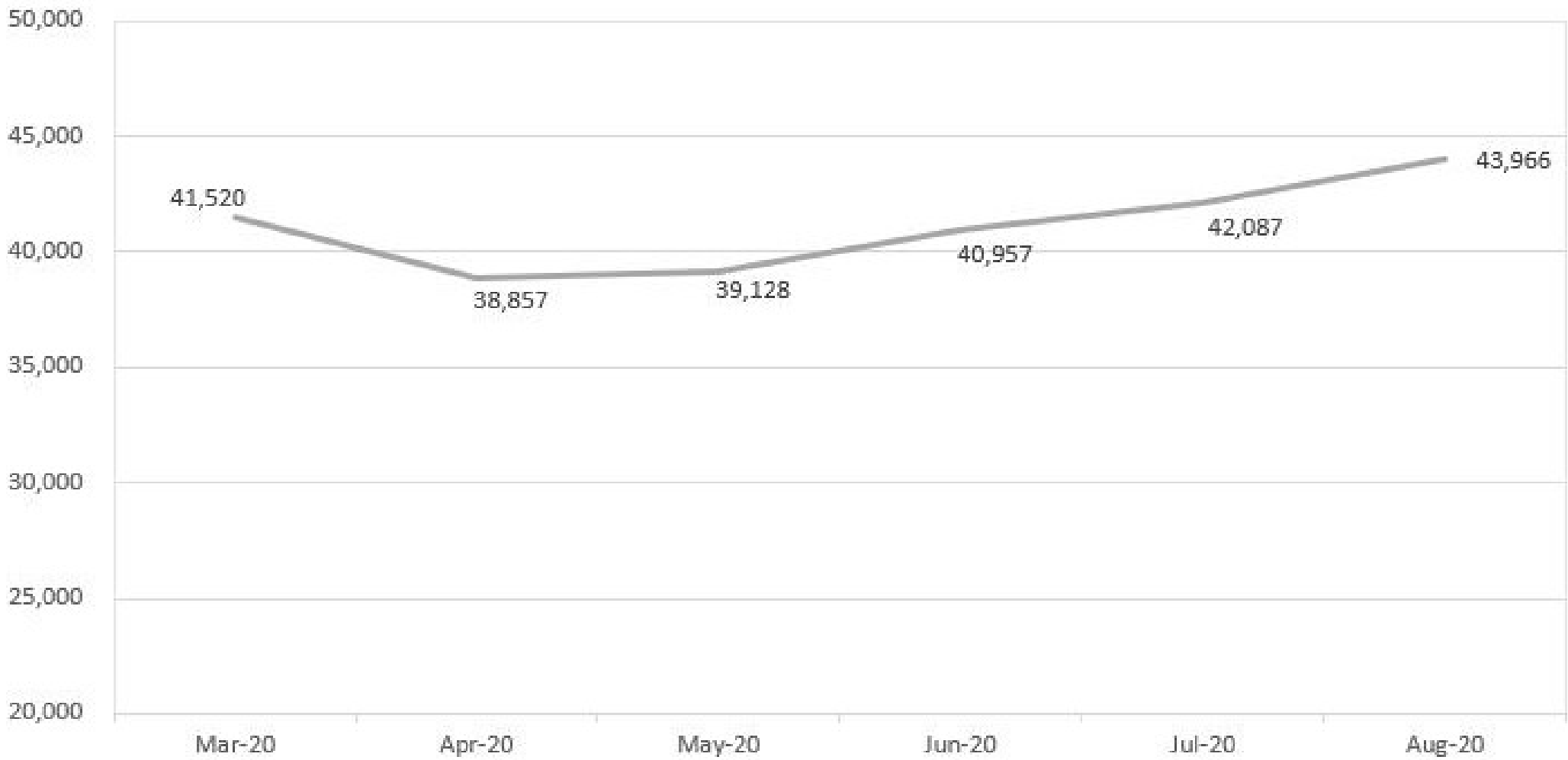

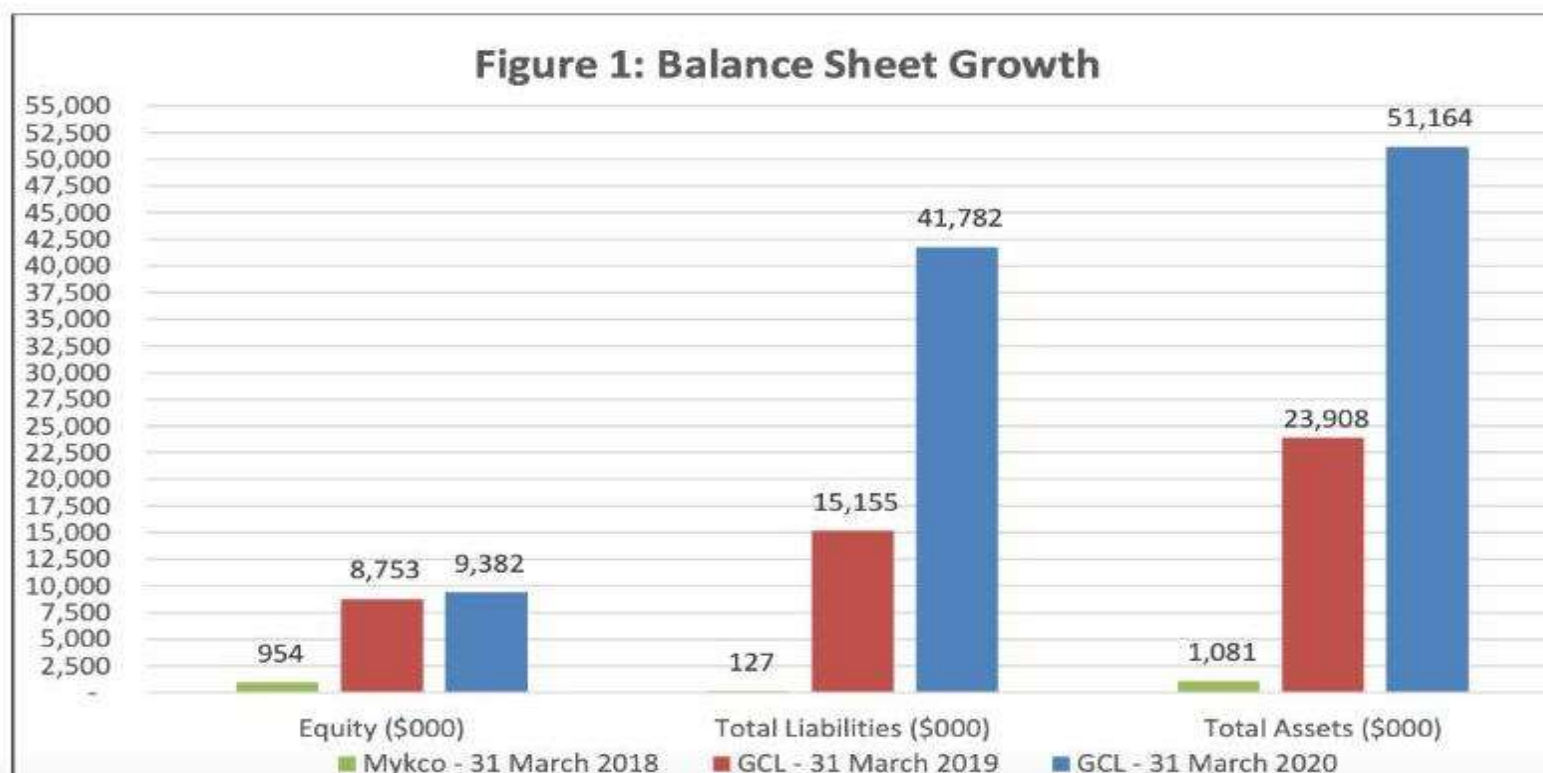
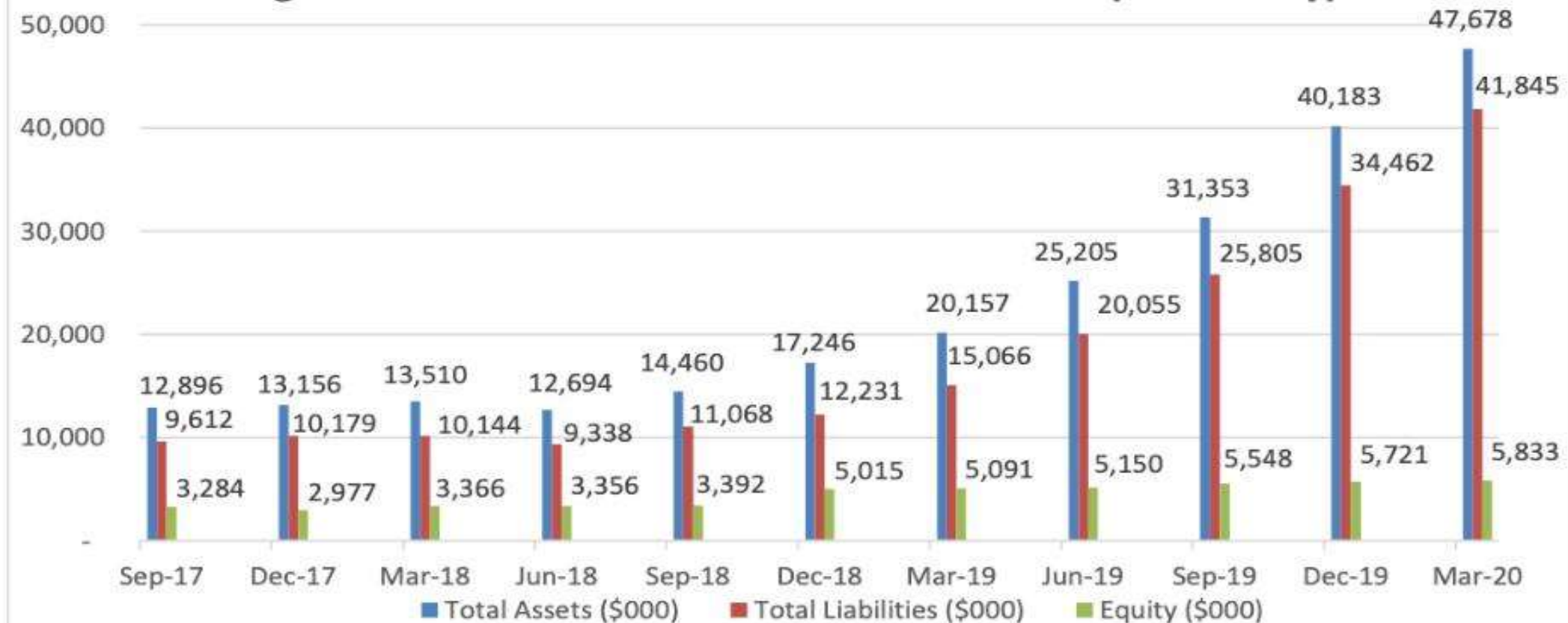
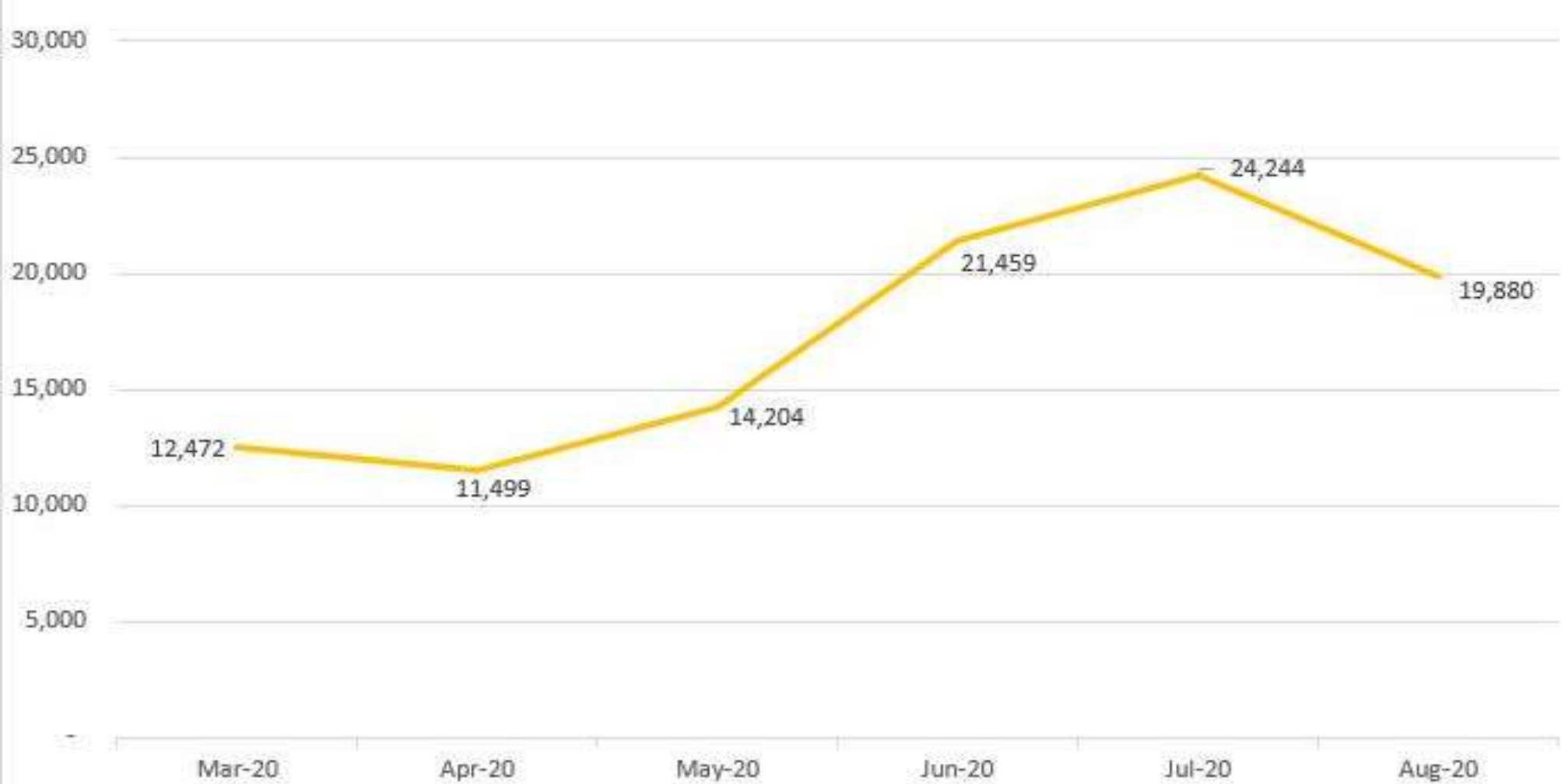


Figure 2: Growth in General Finance Limited (Subsidiary)

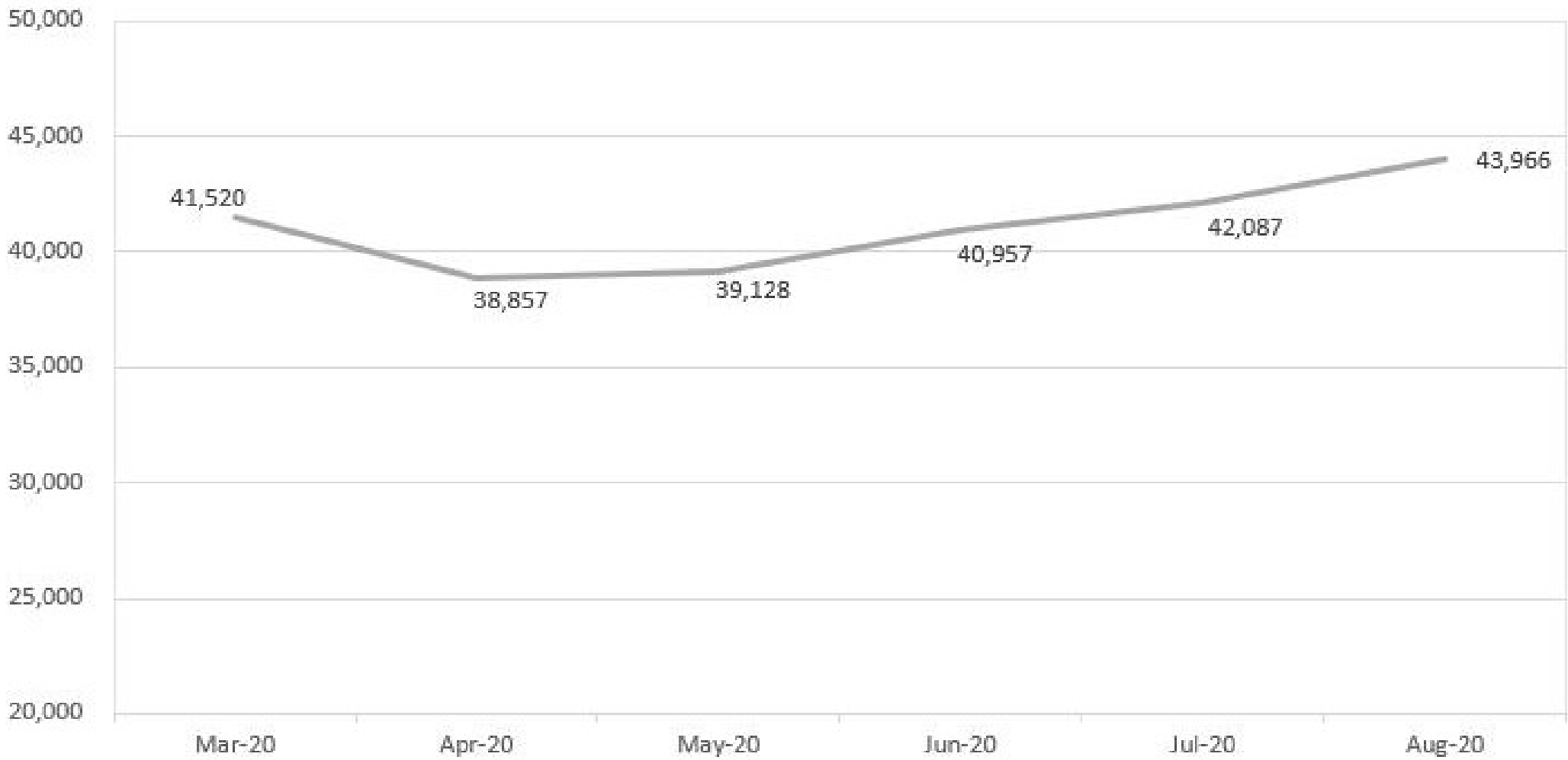

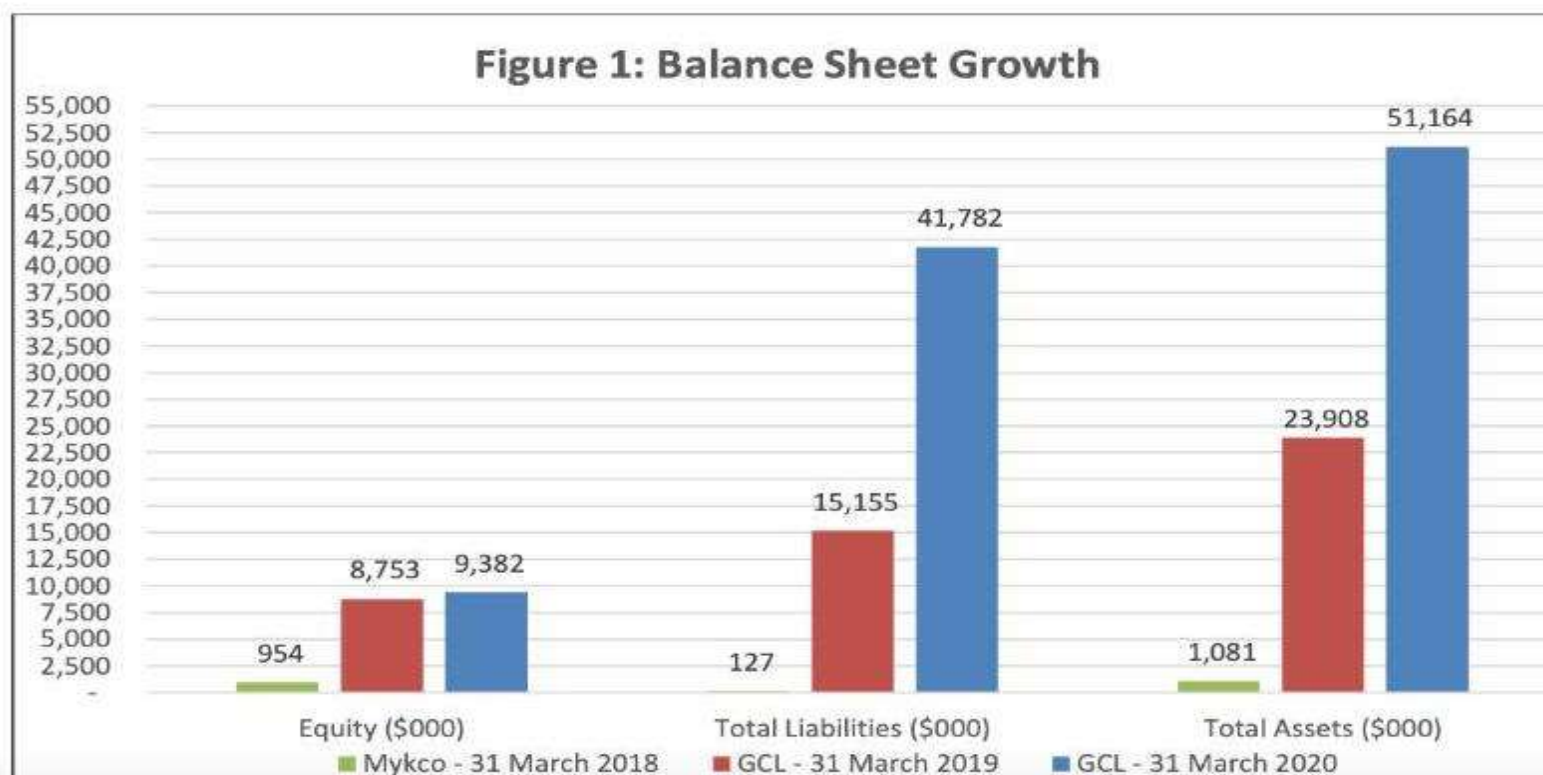
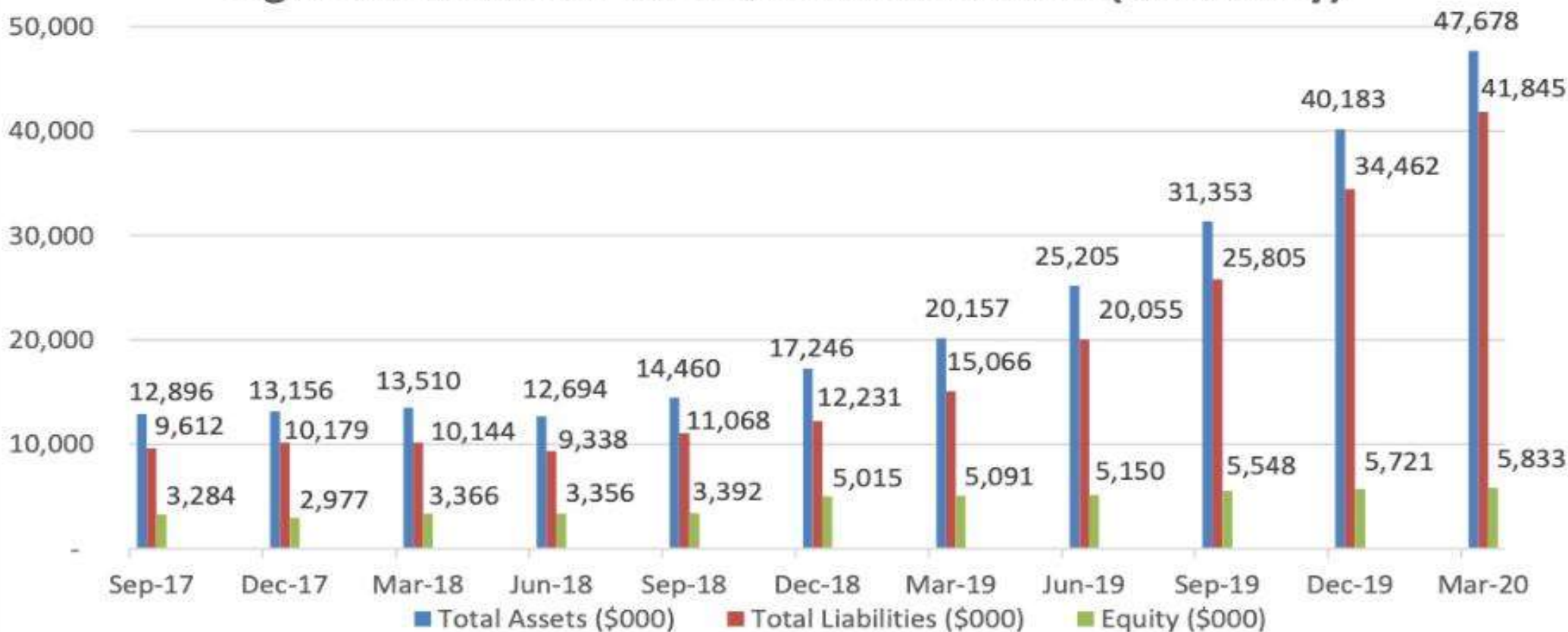
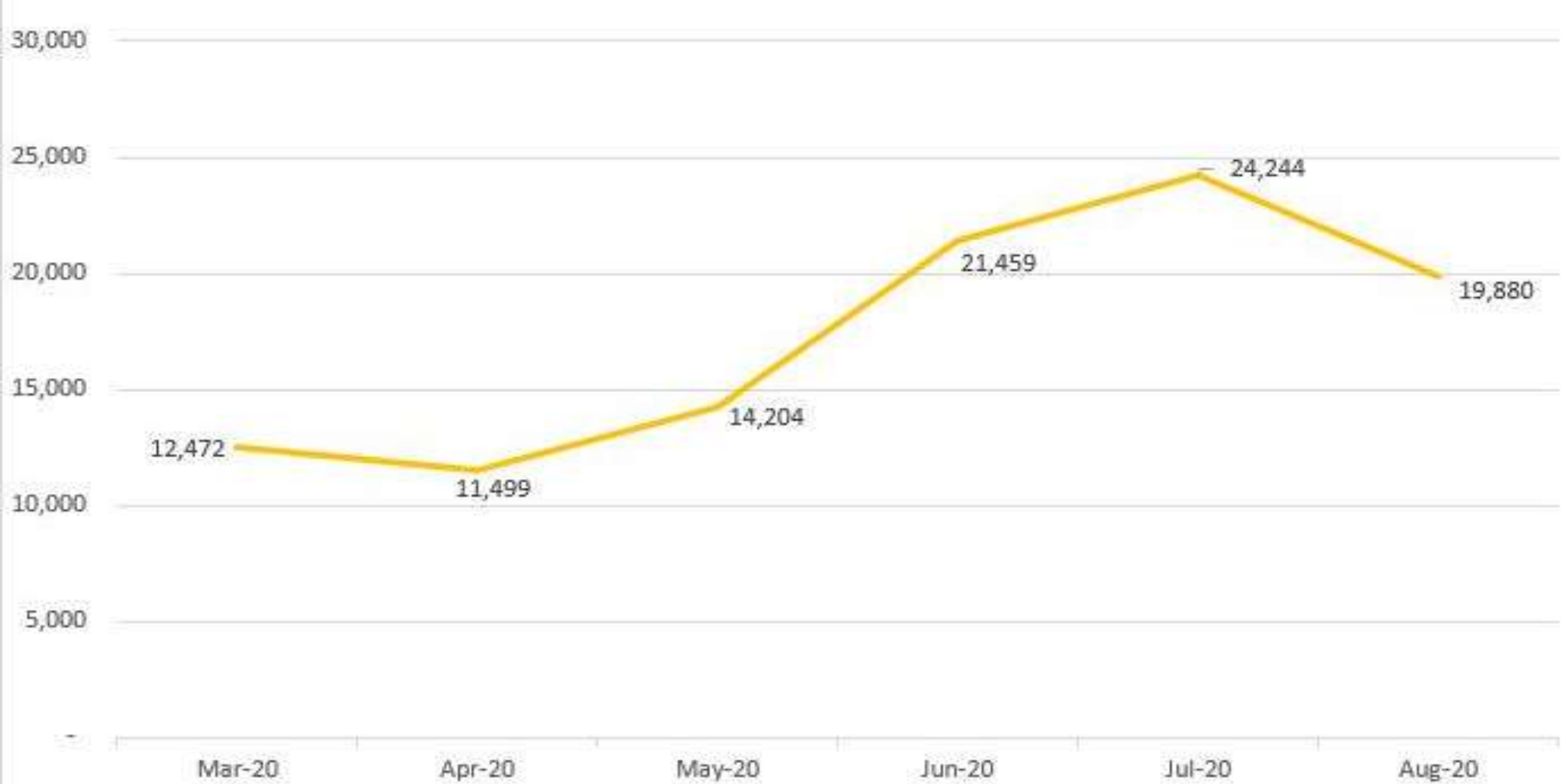


Figure 2: Growth in General Finance Limited (Subsidiary)

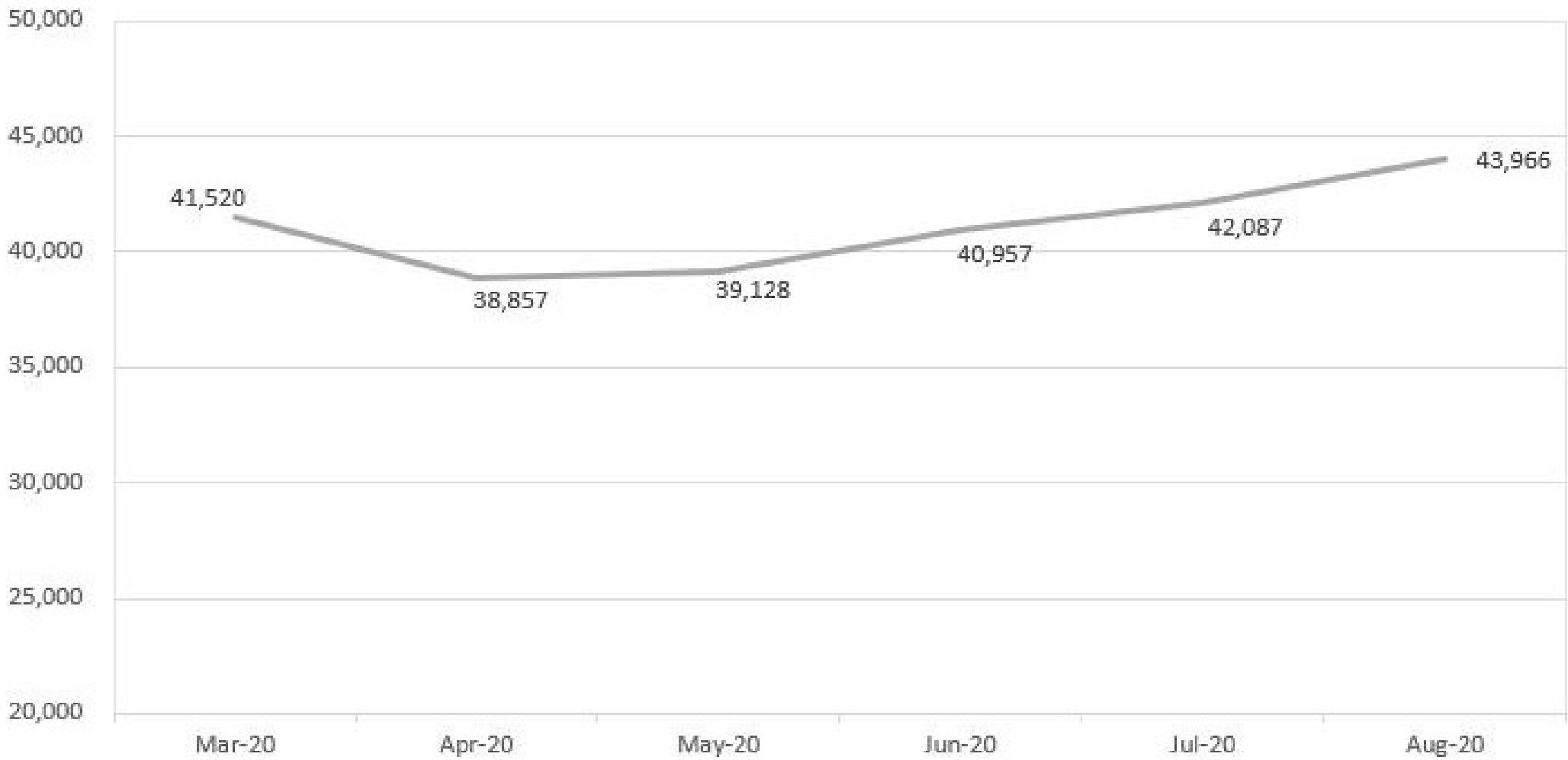

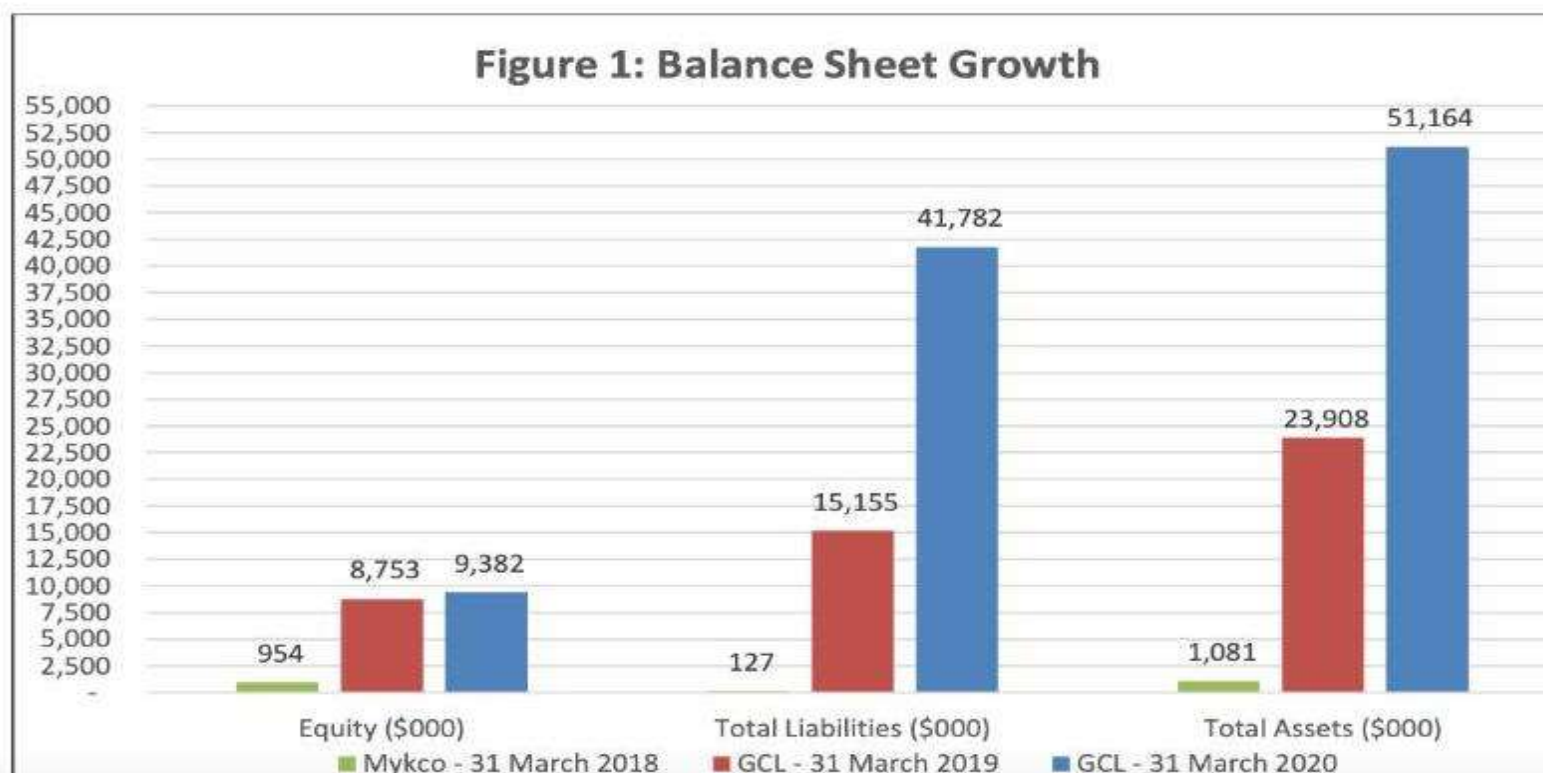
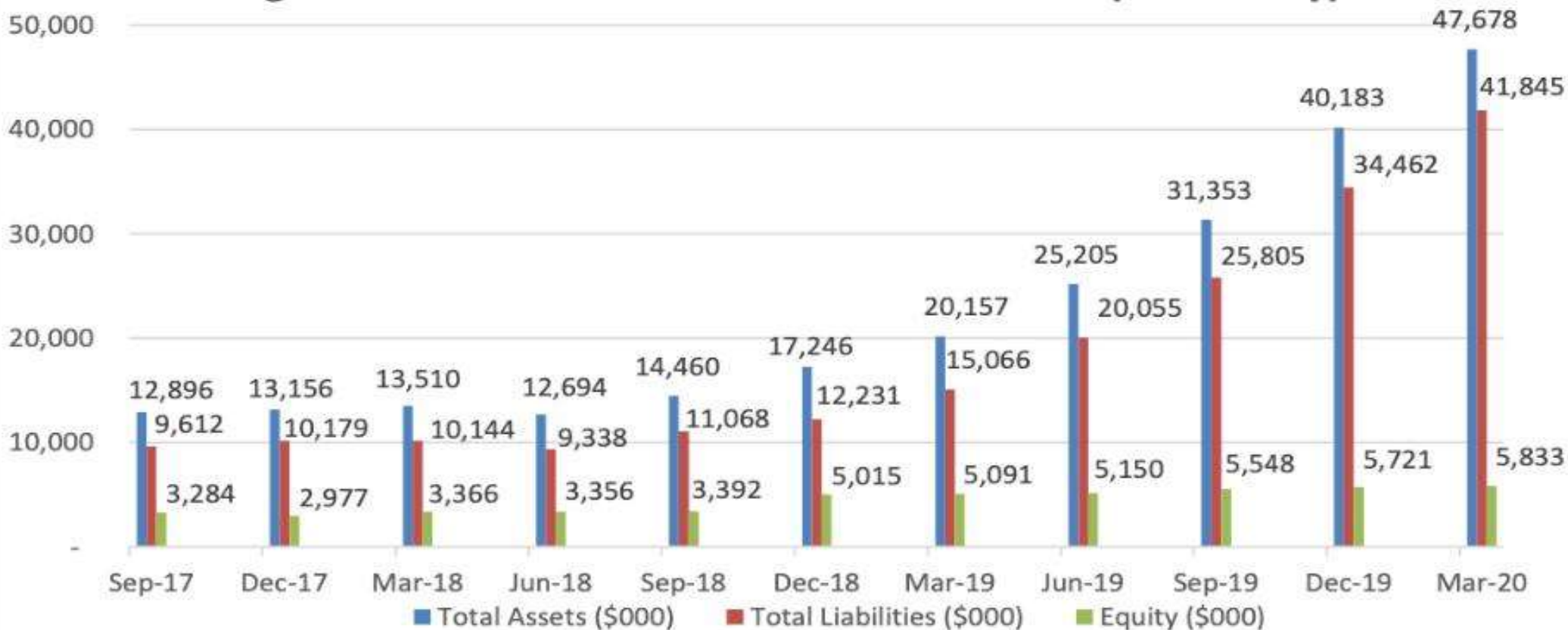
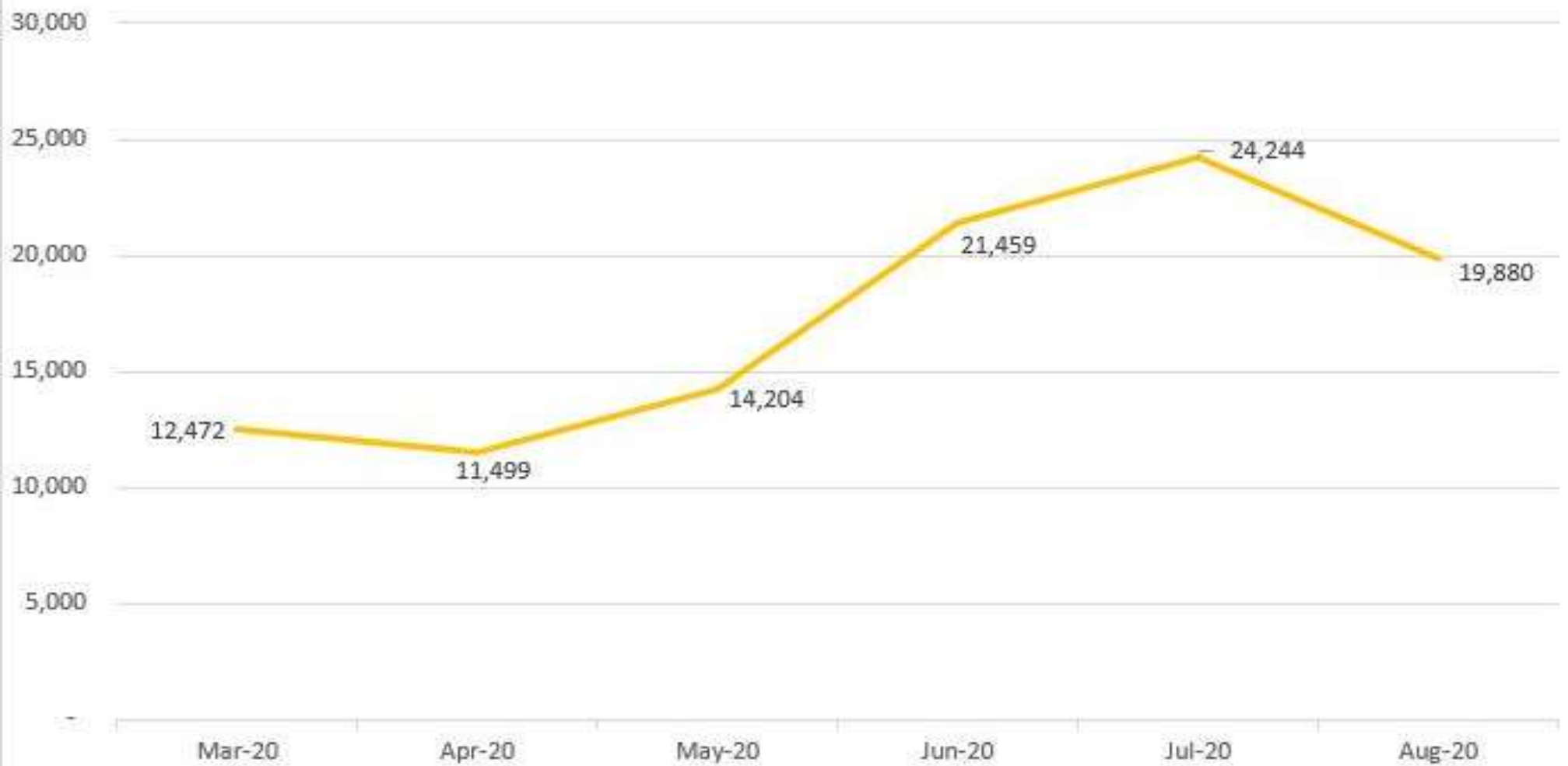


Figure 2: Growth in General Finance Limited (Subsidiary)

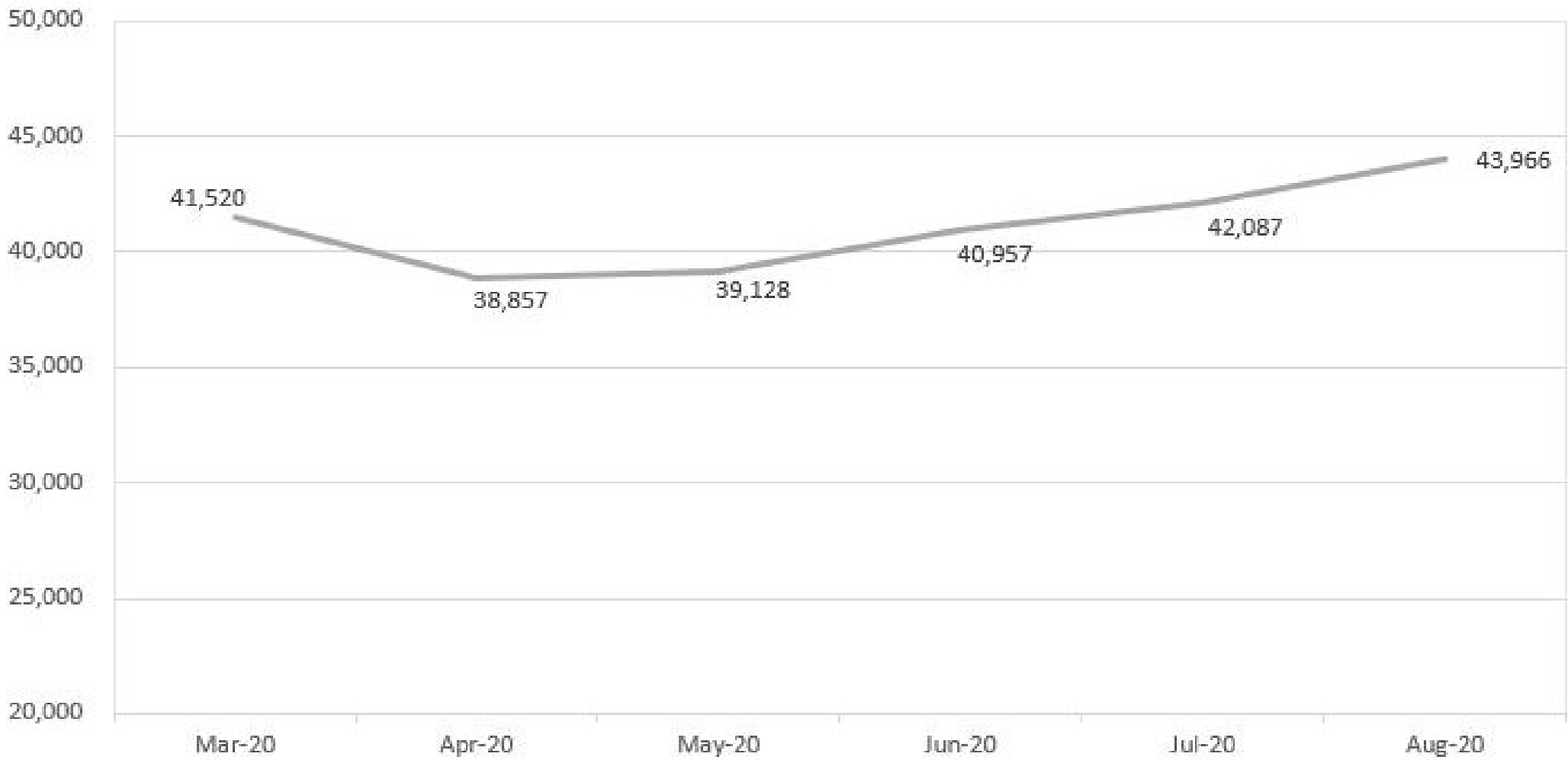

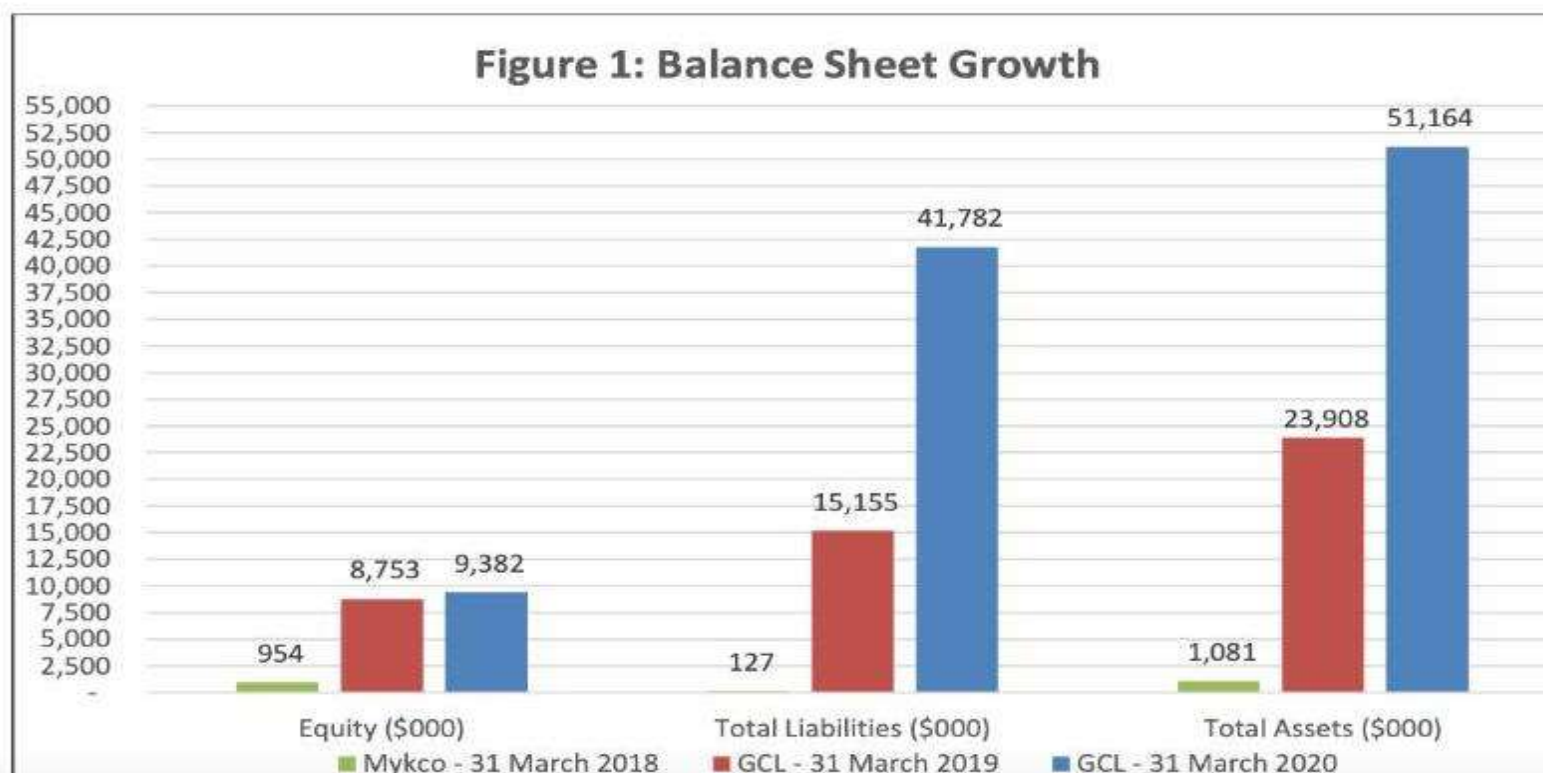
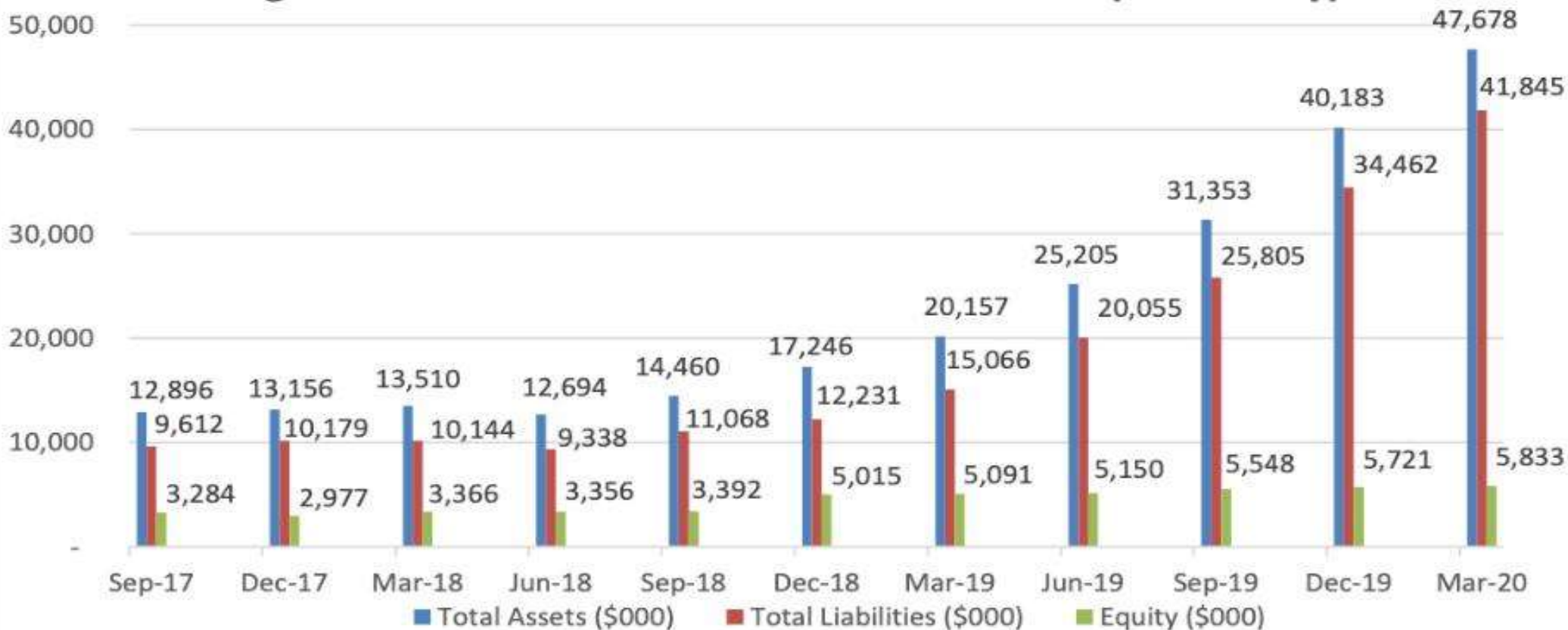
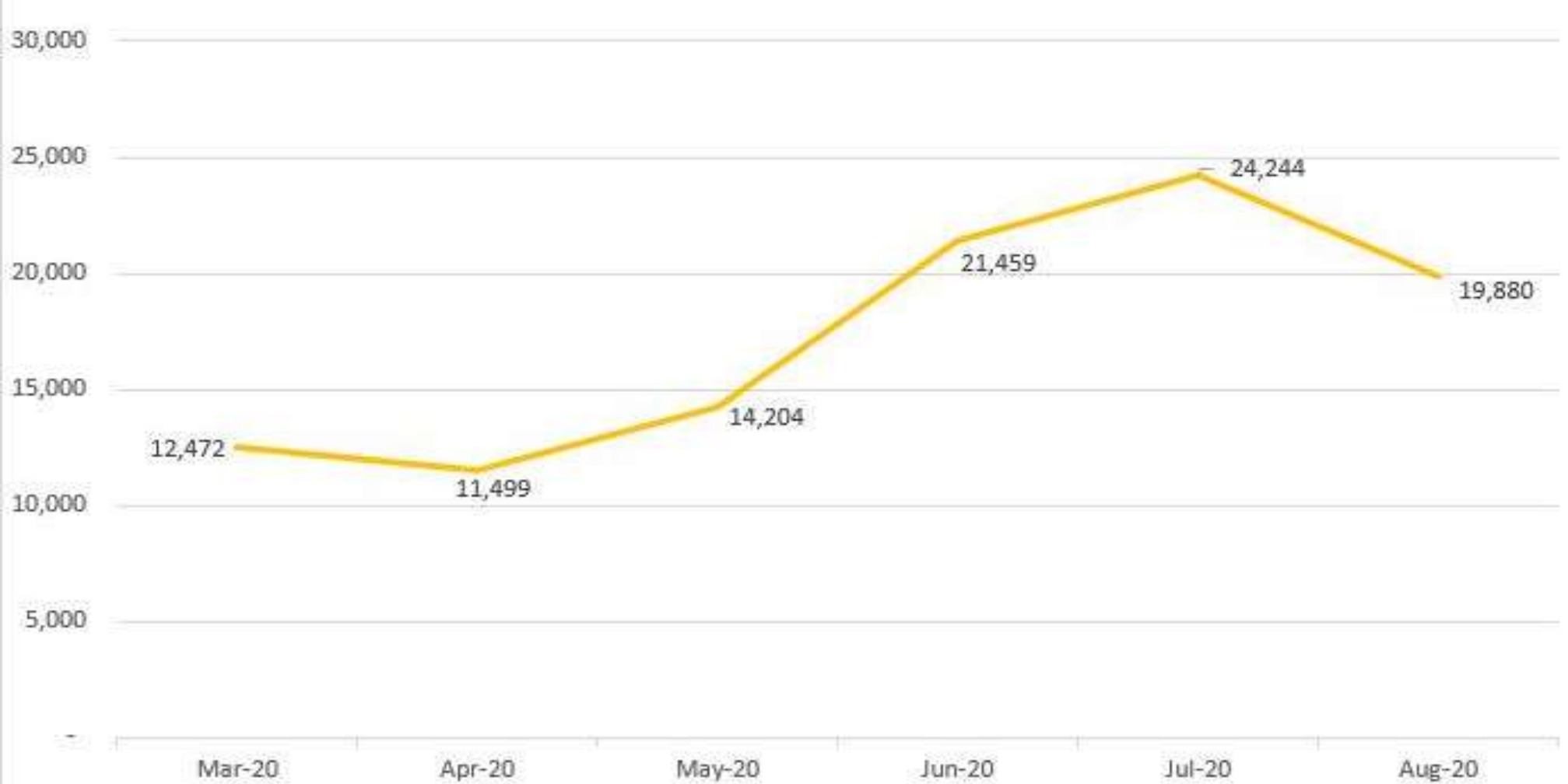


Figure 2: Growth in General Finance Limited (Subsidiary)

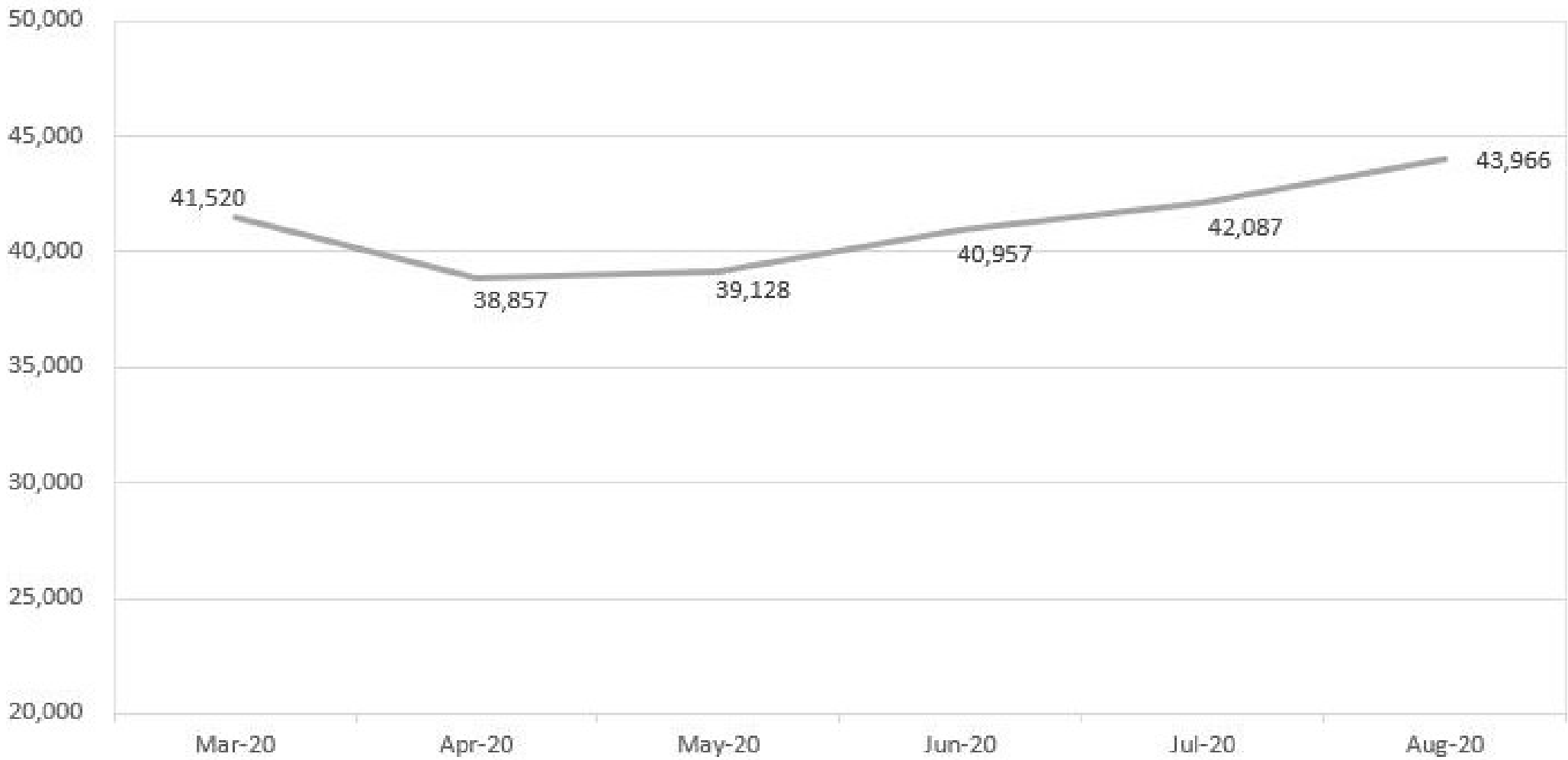

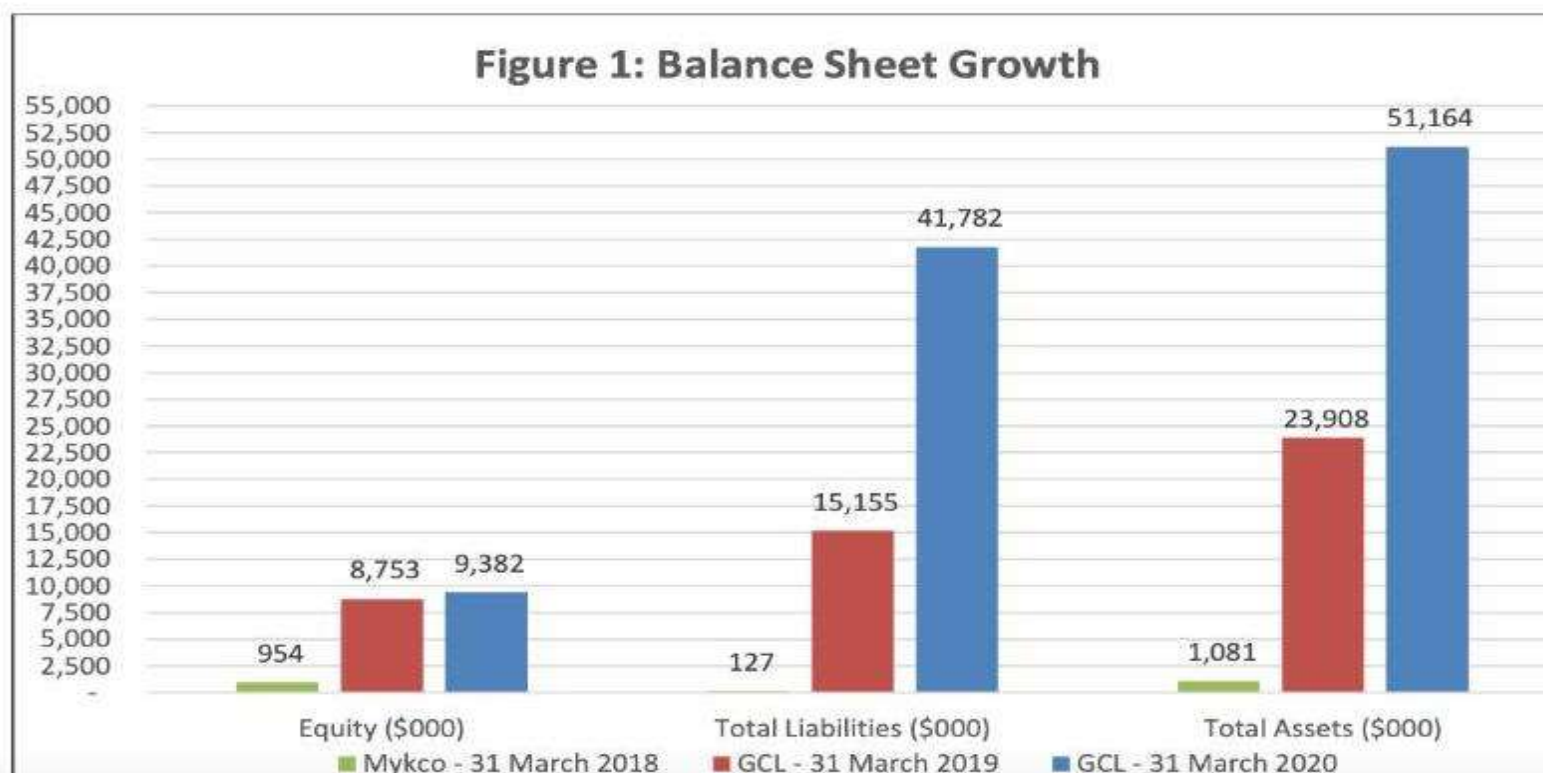
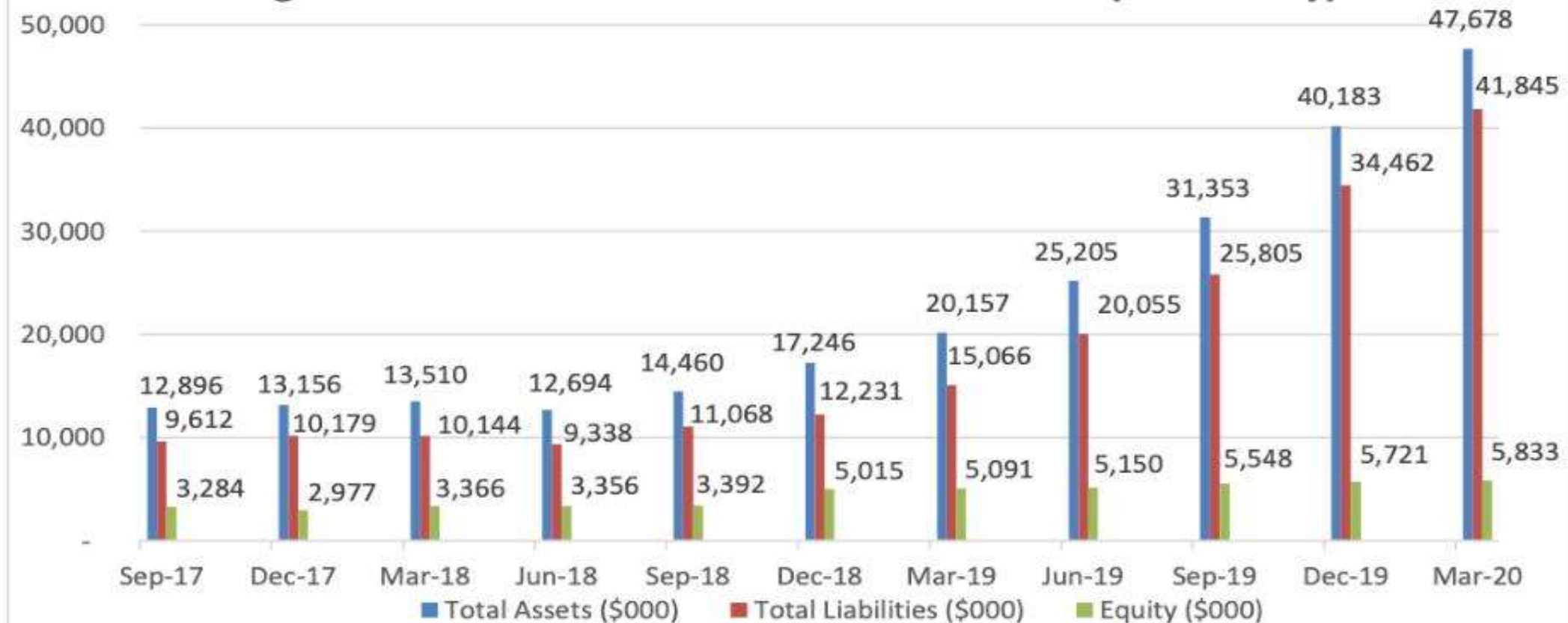
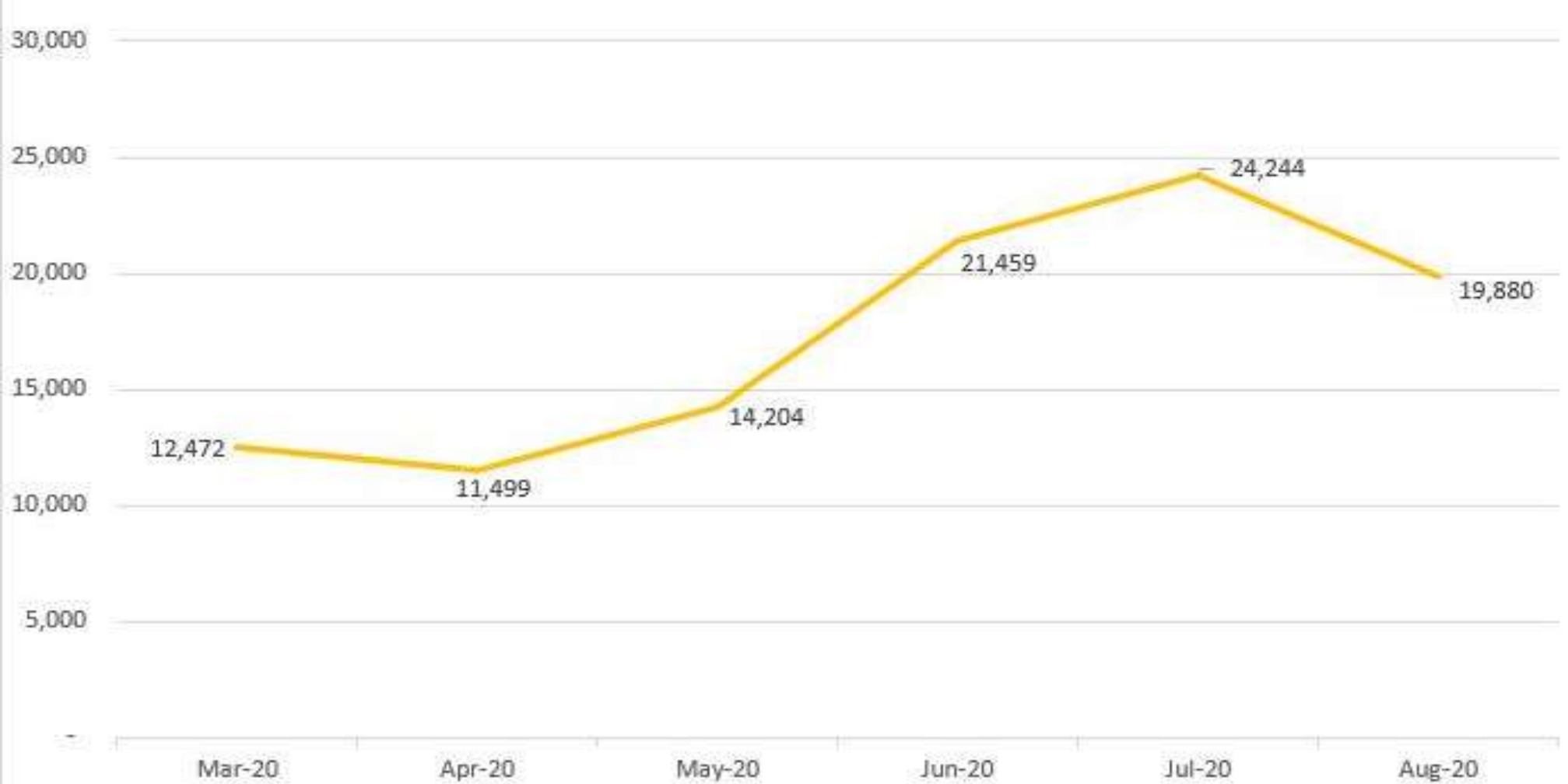


Figure 2: Growth in General Finance Limited (Subsidiary)

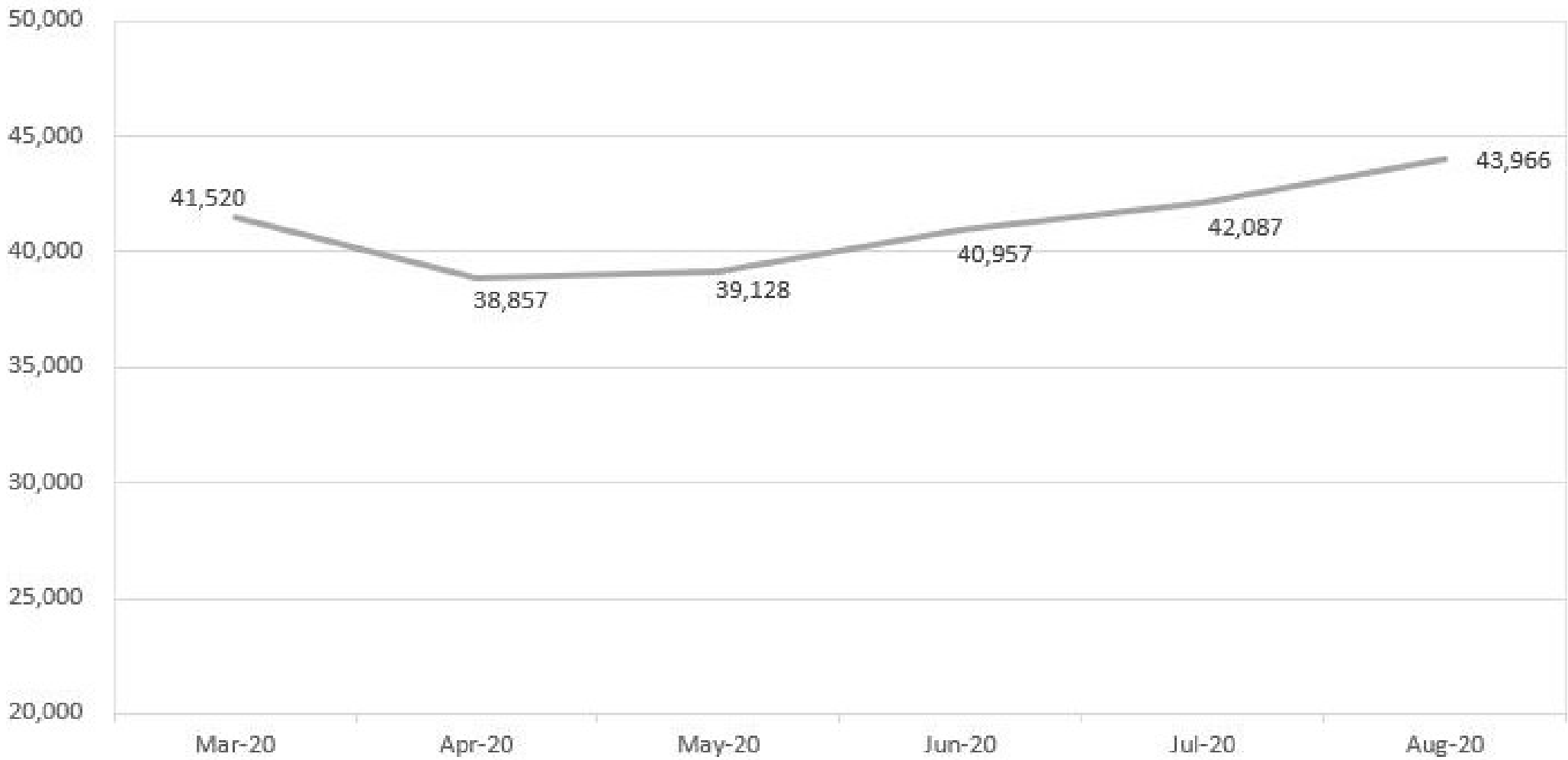
