## Smartshares NZ Top 10 ETF

### Fund update for the quarter ended 31 December 2022

This fund update was first made publicly available on 10 February 2023.

### What is the purpose of this update?

This document tells you how the Smartshares NZ Top 10 ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

Invests in New Zealand shares and is designed to track the return (before tax, fees and other expenses) of the S&P/NZX 10 Index.

Total value of the fund: \$137,106,445

The date the fund started: 7 November 2016

### What are the risks of investing?

#### Risk indicator for the Smartshares NZ Top 10 ETF



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

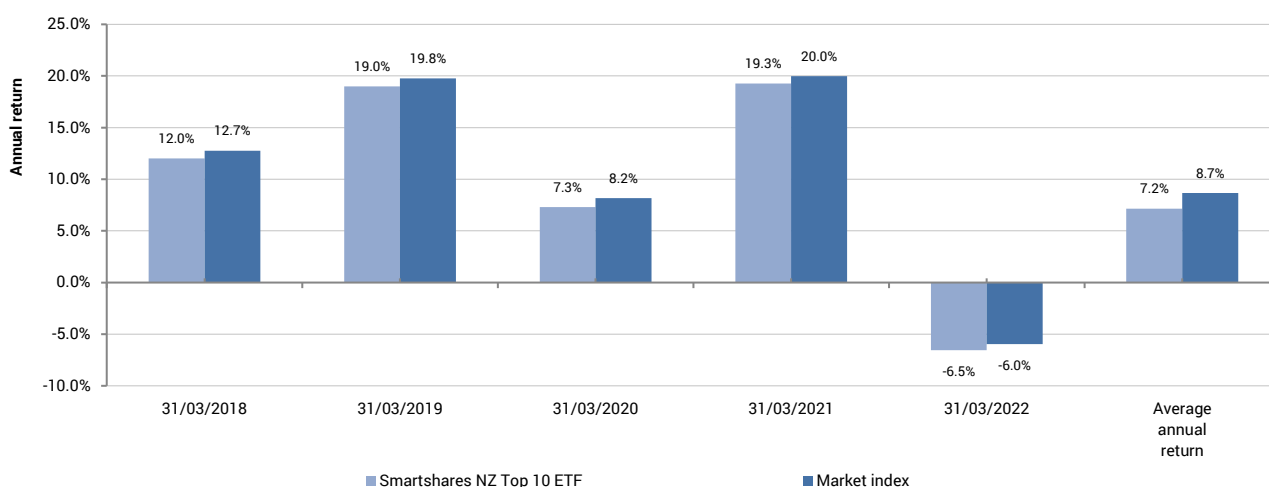

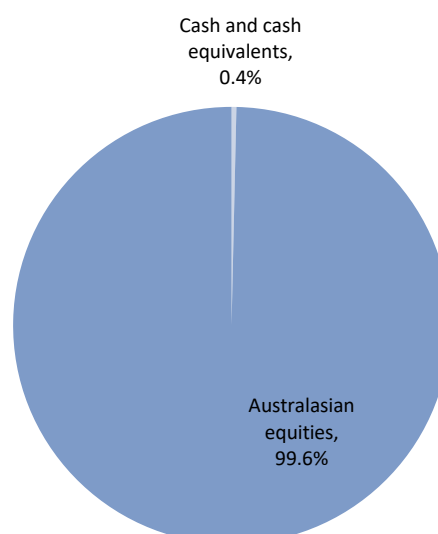
## Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara incurred a loss after fund charges were deducted of -\$1,042 (that is -10.42% of her initial \$10,000). This gives Tara a total loss after tax of -\$1,042 for the year.
