### Fund update for the quarter ended 30 September 2023

This fund update was first made publicly available on 30 October 2023.

### What is the purpose of this update?

This document tells you how the Smartshares NZ Top 10 ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

Invests in New Zealand shares and is designed to track the return (before tax, fees and other expenses) of the S&P/NZX 10 Index.

Total value of the fund: \$131,194,112

The date the fund started: 7 November 2016

### What are the risks of investing?

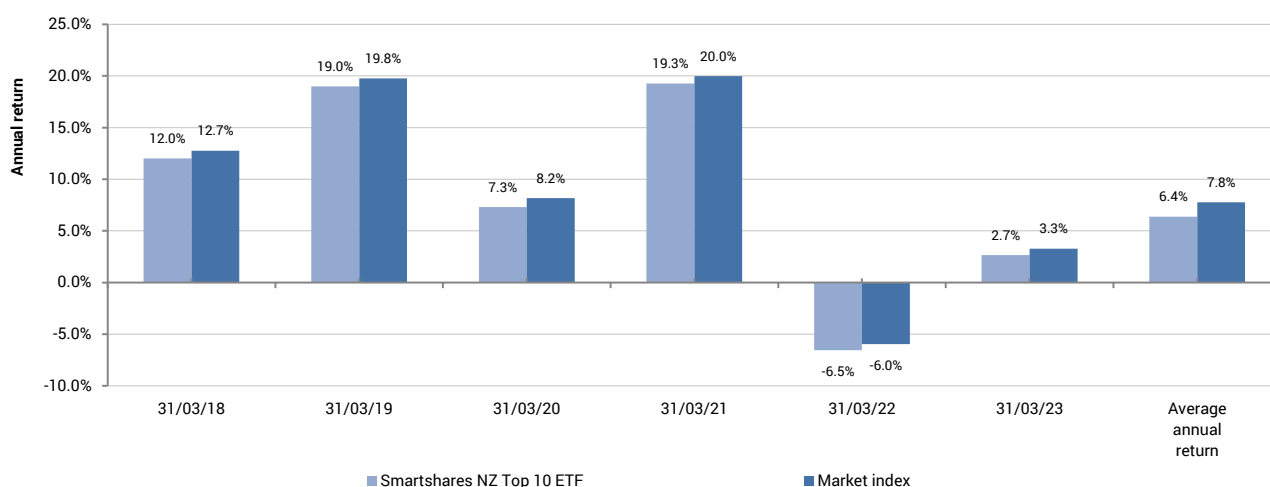

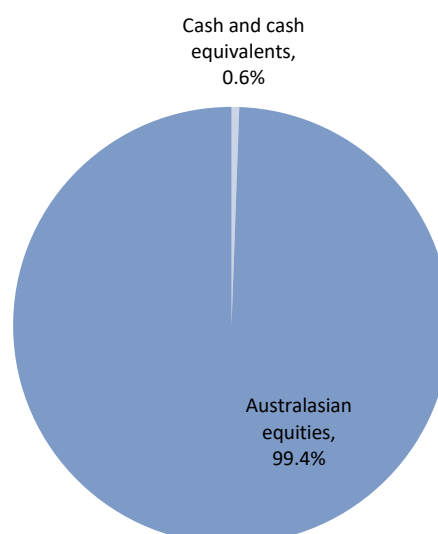
## Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$769 (that is 7.69% of their initial \$10,000). This gives Tara a total return after tax of \$674 for the year.
