Fund update for the quarter ended 31 March 2020

This fund update was first made publicly available on 1 May 2020.

What is the purpose of this update?

This document tells you how the Smartshares NZ Dividend ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Smartshares NZ Dividend ETF invests in financial products listed on the NZX Main Board and is designed to track the return on the S&P/NZX 50 High Dividend Index.

Total value of the fund: \$61,462,957

The date the fund started: 7 April 2015

What are the risks of investing?

Risk indicator for the Smartshares NZ Dividend ETF¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

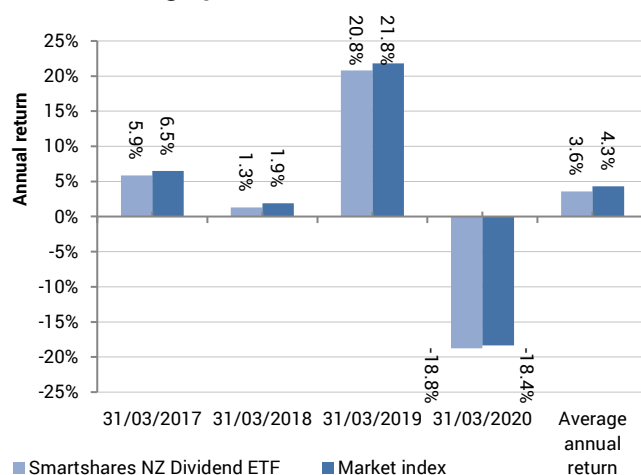

How has the fund performed?

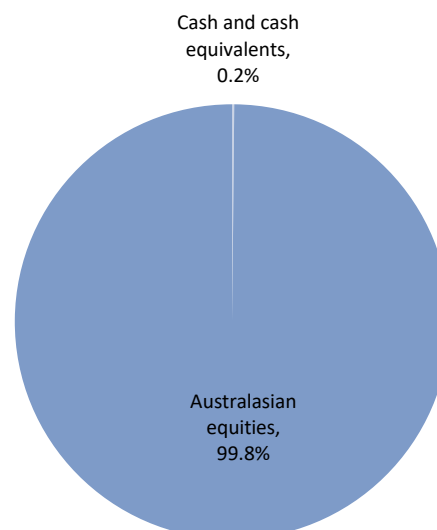
Example of how this applies to an investor

Tara had \$10,000 in the fund and did not make any further contributions. At the end of the year, Tara incurred a loss after fund charges were deducted of -\$1,877 (that is -18.77% of her initial \$10,000). This gives Tara a total loss after tax of -\$1,877 for the year.

Material changes

Notes

- 1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 1 month of market index returns.
