## **NUREN GROUP LIMITED**

### **QUARTERLY UPDATE ON ACTIVITIES FOR THE QUARTER TO 31 MARCH 2025**

#### **Key Highlights**

- Unaudited sales revenue for the Quarter ending 31 March 2025 amounted to \$ 2.0 million. (YTD: \$5.2 million).
- Sales revenue for the quarter was mainly from the domestic market with E-commerce sales contributing 47.2% and Media and Advertising fees contributed the remaining 52.8%.
- Cash at the end of the quarter was \$215.0k.
- The net cash outflow for the quarter was \$66.8k, comprising of:
  - 1) The net cash inflow from operating activities for the quarter was \$95.0k. During the quarter \$977.7k in cash receipts were received from customers. There are cash payments related to operating activities amounting to \$882.7k. These payments comprised:
    - a) Purchase of goods and services - \$405.5k.
    - b) Staff costs - \$72.6k.
    - c) Advertising and marketing costs - \$164.7k.
  - 2) The net cash outflow from investing activities for the quarter was \$130.9k. This is mainly due to the payment of physical non-current assets.
  - 3) The net cash outflow from financing activities for the quarter was \$30.9k. This is from the repayment of borrowings.

#### **Corporate Activities**

- There is no issuance of shares during the quarter ended 31 March 2025. As of 31 March 2025, the company had 154,500,000 listed shares on issue.

#### **Payments to Related Parties**

Cash payments for directors' remuneration during the quarter were \$79.8k.
