## We're on the Move and Becoming More Mobile

Following a recent review of our South East Queensland branch footprint, the Bank, along with Logan Community Financial Services Ltd, has made the decision to merge their existing Marsden **Community Bank®** Branch into the remaining four Logan Community Bank branches. Marsden **Community Bank®** branch will cease trading on 29th June 2018 at 5pm.

Logan Financial Services Ltd are aligned with the Bank's strategy of providing a more mobile and agile workforce and understand that the face of banking has, and is changing. The group are embracing this change and are currently in the final stages of recruiting a second Mobile Relationship Manager to drive their mobile presence. The merger of Marsden Branch will allow the Group to allocate resources to support the development and implementation of this strategy without significantly impacting our customers.

The decision to consolidate our branches also takes into consideration the proximity of our other branch locations in Browns Plains, 8, Browns Plains Road, (9 km), Loganholme, 54 Bryants Road, (11km) Beenleigh, 106 City Rd (14km) and Springwood, 34 Fitzgerald Ave (12km). As a result of the merger, Logan Community Financial Services Ltd will increase the mobile capabilities of our team and will have Mobile Relationship Managers available to meet with our customers to discuss their future Home Lending needs at a place and time that is convenient to them.

All customer accounts currently held at Marsden **Community Bank®** Branch will be transferred to the other Logan **Community Bank®** branches prior to 29 June 2018. Our customers' accounts will not be impacted by this change and they will have full access to all banking services across the entire Bendigo Bank network.

The friendly team from Marsden will continue to service customers from the Bank's other branches within the Logan team, remaining an important part of the local community.

Browns Plains **Community Bank®** Branch, Loganholme **Community Bank®** Branch, Beenleigh **Community Bank®** Branch and Springwood **Community Bank®** Branch are open Monday to Friday 9am to 5pm. Both our Loganholme and Springwood branches are open on a Saturday morning from 9am to 12pm. All branches feature an on-site ATM and a dedicated Mobile Relationship Manager, Home Loan specialist, Business Banker and Financial Planner.
