The Board has seven members as at 31 December 2024. Mr Zhang is the Chairman is Executive and considered not independent. Messrs. Wong and Huang are Executive Directors hence not independent. The remaining four directors, namely Messrs. Yin, Guo, Ong and Buchta are non-executive and considered as independent. The Board has nevertheless determined that the composition of the current Board represents an appropriate mix of directors that have a range of qualifications and expertise enabling them to understand and effectively deal with issues faced by the Company. The Board considers that the non-executive directors can effectively review and challenge the performance of management. The Board is satisfied that all directors bring an independent judgment to bear on Board decisions. In addition, each director is entitled to seek independent professional advice at the Company's expense on matters directly related to his director responsibilities, in accordance with Company's constitution.</p> <p>Moving into FY2024, due to the passing Dr John Chiplin, the Board will consider including another new non-executive and independent director, meaning an increased majority of independent directors.</p>
