2 We warrant the following to NSX.


- The issue of the securities to be quoted complies with the law and is not for an illegal purpose.

- Section 724 or section 1016E of the Corporations Act does not apply to any applications received by us in relation to any securities to be quoted and that no-one has any right to return any securities to be quoted under sections 737, 738 or 1016F of the Corporations Act at the time that we request that the securities be quoted.
