Rights Issue – Heritage Brands Limited (NSX code – HBA)

Heritage Brands Limited (“**Heritage Brands**” or the “**Company**”) is pleased to announce a pro rata non-renounceable rights issue to raise up to approximately \$4.7 million before expenses. Under the rights issue eligible shareholders will be offered 1 new ordinary share for every 2 ordinary shares held at a price of 0.4 cents (\$0.004) per new share (the “**Offer**”).

All shareholders who are registered as shareholders as at 7.00 pm on the record date of Tuesday, 8 October 2024 with a registered address in Australia or New Zealand will be entitled to participate in the rights issue.

Funds to be raised from the Offer will be used as follows:

- to add to the Company's working capital; and
- to meet the costs of the Offer.

Please note that the entitlements to new shares under the Offer are non-renounceable, which means that you may not sell or transfer your entitlements.

Heritage Brands will not prepare a prospectus or other disclosure document for the rights issue, as the Offer will be made under section 708AA of the Corporations Act 2001 (Cth). However, Heritage Brands will send an offer document, and a personalised entitlement and acceptance form, to eligible shareholders on or before 10 October 2024.

The following documents in relation to the rights issue are enclosed for release to the market:

- A copy of the offer document;
- A sample entitlement and acceptance form;
- An application for quotation of additional securities; and
- The text of a letter to be mailed to all eligible shareholders in accordance with the NSX Listing Rules.
