1. Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer: The Company anticipates an increase in operating cash receipts in Q12025 whilst maintaining a materially similar level of operating cash outflows. Q42024 cash receipts were materially lower than the year to date average and reflects the lumpy nature of the Company's larger contracts. In Q12025 the company anticipates material cash receipts from some of its announced orders including AUD 2.1m from three contracts (initial deposit from recently announced OMIC sale, final payment from Sabanci and final payment from Royal Netherlands Army) in addition to other receipts from smaller sales. The Company anticipates having sufficient operating cash flows for the next two quarters.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: A capital raise is not considered necessary at the moment to fund operating cash flows.
