**Notice under section 708A of the Corporations Act**

Dateline Resources Limited ACN 149 105 653 (ASX: DTR) (**Company**) hereby advises that a total of 21,580,607 fully paid ordinary shares in the Company (each, a **Share**) and 35,790,304 quoted options (each, a **Option**) were issued by the Company to sophisticated and professional investors on 10 October, 2024.

    - B. the rights and liabilities attaching to the Shares and options.
