**Takeover bid by Doray Minerals Limited for Mutiny Gold Limited – Form 604s**

We refer to the ASIC Form 604 'Notice of change of interests of substantial holder' (**Form 604**) dated 21 January 2015 in relation to the off-market takeover offer made by Doray for all the ordinary fully paid shares and listed options in Mutiny Gold Limited (**Mutiny**). Doray Minerals Limited (**Doray**) has been informed that the number of share acceptances received yesterday was overstated by 19,127,642 due to an administration error. A revised Form 604 is attached showing the correct number of acceptances and Doray's voting power as at 21 January 2015.

Doray is also pleased to advise that it has received acceptances under that off-market takeover offer in respect of 598,587,046 fully paid ordinary shares in Mutiny, taking its relevant interest in Mutiny to approximately 86.77%. In accordance with section 671B(1) of the *Corporations Act 2001* (Cth), we attach a copy of Form 604 in relation to these acceptances.

In relation to Doray's off-market takeover offer for all of the listed options in Mutiny, Doray is pleased to advise that it has received acceptances under that offer in respect of 78,973,916 listed options representing approximately 93.33% of the listed options in Mutiny.


