The business of the Meeting affects your shareholding and your vote is important.

This Notice should be read in its entirety. If Shareholders are in doubt as to how they should vote, they should seek advice from their professional advisors prior to voting.

The Directors have determined pursuant to Regulation 7.11.37 of the Corporations Regulations 2001 (Cth) that the persons eligible to vote at the Meeting are those who are registered Shareholders at 7:00 pm (AEDT) on Monday, 18 November 2024.

## **Live webcast**

The company is pleased to provide Shareholders with the opportunity to attend the Meeting through a live online webcast. The live webcast of Meeting will be available via Microsoft Teams. Details of the live webcast will be announced on the ASX closer to the Meeting date.

The business of the Meeting affects your shareholding and your vote is important. To vote in person, attend the Meeting on the date and at the place set out above. All resolutions will be decided on a poll. The poll will be conducted based on votes submitted by proxy and at the Meeting.

Shareholders will not be able to vote or ask questions in real time on the webcast. If you are planning to watch the webcast, you are encouraged to submit a proxy and any questions in advance of the Meeting. Please refer to the enclosed Proxy Form for instructions on how to lodge your proxy vote.

## **Business of the Meeting**

### **A. Consideration of reports**

The first item of business is to receive and consider the annual report, comprising the financial statements, the Directors' report, and the independent auditor's report of the Company for the financial year ended 30 June 2024 (**2024 Annual Report**).

All Shareholders can view the 2024 Annual Report on the Company's website at <https://quickfee.com/investors/annual-half-year-reports/>.

### **B. Questions and comments**

Following consideration of the 2024 Annual Report, the Chairman will give Shareholders a reasonable opportunity to ask questions about and, make comments on, the business of the Meeting, the management of the Company or about the Company generally.

The Company's external auditor for the period ended 30 June 2024, William Buck Audit (Vic) Pty Ltd (Auditor), will attend the Meeting and there will be a reasonable opportunity for Shareholders to ask the Auditor questions relevant to:

- (a) the conduct of the audit;
- (b) the preparation and content of the independent auditor's report;
- (c) the accounting policies adopted by the Company in relation to the preparation of the financial statements; and
- (d) the independence of the auditor in relation to the conduct of the audit.

The Chairman will also give the auditor a reasonable opportunity to answer written questions submitted by Shareholders that are relevant to the content of the independent auditor's report or the conduct of the audit.



## C. Items for approval

### Resolution 1 – Adoption of remuneration report

To consider and, if thought fit, to pass, with or without amendment, the following as a non-binding resolution of the Company:

*“That, for the purposes of section 250R(2) of the Corporations Act and for all other purposes, approval is given for the adoption of the remuneration report as contained in the Company’s annual financial report for the financial year ended 30 June 2024.”*

The remuneration report is contained in the 2024 Annual Report (available at <https://quickfee.com/investors/annual-half-year-reports/>). Please note that, in accordance with section 250R(3) of the Corporations Act, the vote on this resolution is advisory only and does not bind the Directors or the Company.

#### **Voting exclusion:**

*The Company will disregard any votes cast on this resolution by, or on behalf of, the following persons:*

- *a member of the Key Management Personnel (KMP) whose remuneration details are included in the remuneration report of the Company for the year ended 30 June 2024; or*
- *a Closely Related Party of such a KMP (including close family members and companies the KMP controls); or*
- *a person voting as proxy for a member of the KMP or any of their Closely Related Parties.*

*However, this does not apply to a vote cast in favour of the resolution by:*

- *a person as proxy or attorney for a person who is entitled to vote on the resolution, in accordance with the directions given to the proxy or attorney to vote on the resolution in that way; or*
- *the Chair as proxy or attorney for a person who is entitled to vote on the resolution, in accordance with an express authorisation in the proxy appointment to cast votes even if the resolution is connected directly or indirectly with the remuneration of KMP, and in accordance with a direction given to the Chair to vote on the resolution as the Chair decides.*

*“Key Management Personnel” and “Closely Related Party” have the same meaning as set out in the Corporations Act.*

### Resolution 2 – Re-election of Director – Bruce Coombes

To consider and, if thought fit, to pass the following as an ordinary resolution of the Company:

*“That for the purpose of 14.2 of the Company’s Constitution, ASX Listing Rule 14.4 and all other purposes, Bruce Coombes, a Director, retires by rotation, and being eligible for election, is re-elected as a Director of the Company.”*

## Resolution 3 – Ratification of Placement

To consider and, if thought fit, to pass the following as an ordinary resolution of the Company:

*“That, for the purposes of ASX Listing Rule 7.4 and for all other purposes, Shareholders ratify the issue of 42,500,000 fully paid ordinary shares (**Placement Shares**) under ASX Listing Rule 7.1 and ASX Listing Rule 7.1A by the Company at \$0.08 per share on 9 May 2024 to certain institutional and professional investors under a Placement (**Placement**) on the terms and conditions set out in the Explanatory Statement accompanying this Notice.”*

- *a person who participated in the Placement; or*
- *an associate of that person or those persons.*

*However, this does not apply to a vote cast in favour of the resolution by:*

- *a person as proxy or attorney for a person who is entitled to vote on the resolution, in accordance with the directions given to the proxy or attorney to vote on the resolution in that way; or*
- *the Chair as proxy or attorney for a person who is entitled to vote on the resolution, in accordance with a direction given to the Chair to vote on the resolution as the Chair decides; or*
- *a holder acting solely in a nominee, trustee, custodial or other fiduciary capacity on behalf of a beneficiary provided the following conditions are met:*
  - *the beneficiary provides written confirmation by the holder that the beneficiary is not excluded from voting, and is not an associate of a person excluded from voting, on the resolution; and*
  - *the holder votes on the resolution in accordance with directions given by the beneficiary to the holder to vote in that way.*

## Resolution 4 – Approval of Director participation in the Placement

To consider and, if thought fit, pass the following as an ordinary resolution of the Company:

*“That, for the purposes of ASX Listing Rule 10.11 and for all other purposes, approval is given for the issue of up to 4,375,000 fully paid ordinary shares by the Company at \$0.08 per share (**Director Placement Shares**) to Dale Smorgon (and/or his nominee/s) in addition to the 42,500,000 Placement Shares as part of the Placement, on the terms and conditions set out in the Explanatory Statement accompanying this Notice.”*

*The Company will disregard any votes cast on this resolution by or on behalf of:*

- *Dale Smorgon; or*
- *an associate of Dale Smorgon;*
- *a person who is expected to participate in, or who will obtain a material benefit as a result of, the proposed issue (except a benefit solely by reason of being a holder of ordinary securities in the entity) and/or an associate of that person or those persons.*

*However, this does not apply to a vote cast in favour of the resolution by:*

### **Voting exclusion:**

*The Company will disregard any votes cast on this resolution by or on behalf of:*

- *a person referred to in ASX Listing Rules 10.14.1, 10.14.2 or 10.14.3 (including Bruce Coombes and each other Director of the Company) who are eligible to participate in the QuickFee PROP, and/or an associate of that person or those persons; or*
- *a member of the Key Management Personnel as at the time the resolution is voted on at the Meeting or any of their Closely Related Parties, as a proxy.*

- *a holder acting solely in a nominee, trustee, custodial or other fiduciary capacity on behalf of a beneficiary provided the following conditions are met:*
  - *the beneficiary provides written confirmation by the holder that the beneficiary is not excluded from voting, and is not an associate of a person excluded from voting, on the resolution; and*
  - *the holder votes on the resolution in accordance with directions given by the beneficiary to the holder to vote in that way.*

*As required by the Corporations Act, no member of the Company’s Key Management Personnel or a Closely Related Party of any such member may vote as proxy on this resolution unless:*

- *the person votes as proxy appointed by writing that specifies how the person is to vote on this resolution; or*
- *the person is the Chair of the meeting and votes as a proxy appointed by writing that expressly authorises the Chair to vote on this resolution even though that resolution is connected with the remuneration of a member of the Company’s Key Management Personnel.*

**Resolution 8 – Approval of additional share issue capacity under ASX Listing Rule 7.1A**



**Voting exclusion:**

*Note: As at the date of this Notice, the Company is not proposing to make an issue of Equity Securities under Listing Rule 7.1A.2. On that basis, no Shareholders are excluded from voting.*

## Entitlement to attend and vote

In accordance with regulation 7.11.37 of the *Corporations Regulations 2001* (Cth), the Board has determined that persons who are registered holders of Shares of the Company as at 7:00 pm (AEDT) on Monday, 18 November 2024 will be entitled to attend and vote at the Meeting as a Shareholder.

If more than one joint holder of shares is present at the Meeting (whether personally, by proxy or by attorney or by representative) and tenders a vote, only the vote of the joint holder whose name appears first on the register will be counted.

### Voting at the Meeting

In accordance with clause 13.16(a) of the Company's Constitution, and notwithstanding clause 13.14 of the Company's Constitution, voting on all resolutions will be conducted by way of a poll.

### Voting by proxy

To vote by proxy, please complete and sign the enclosed Proxy Form and return by the time and in accordance with the instructions set out on the Proxy Form.

In accordance with Section 249L of the Corporations Act, Shareholders are advised that:

- each Shareholder has a right to appoint a proxy;
- the proxy need not be a Shareholder of the Company; and
- a Shareholder who is entitled to cast two (2) or more votes may appoint two (2) proxies and may specify the proportion or number of votes each proxy is appointed to exercise. If the member appoints two (2) proxies and the appointment does not specify the proportion or number of the member's votes, then in accordance with Section 249X(3) of the Corporations Act, each proxy may exercise one-half of the votes.

Shareholders and their proxies should be aware that:

- if proxy holders vote, they must cast all directed proxies as directed; and
- any directed proxies which are not voted will automatically default to the Chair, who must vote the proxies as directed.

# Explanatory Statement

This Explanatory Statement has been prepared to provide information which the Directors believe to be material to Shareholders in deciding whether or not to pass the resolutions.

## 1 Resolution 1 – Adoption of remuneration report

### 1.1 General

Section 250R(2) of the Corporations Act requires that the section of the Directors' report dealing with the remuneration of Directors and KMP of the Company (**remuneration report**) be put to the vote of Shareholders for adoption by way of a non-binding vote. The vote on this Resolution 1 is advisory only and does not bind the Directors or the Company. However, the Board will take the outcome of the vote into account in setting remuneration policy for future years.

The remuneration report sets out the Company's remuneration arrangements for the Directors and senior management of the Company. The remuneration report is part of the Directors' report contained in the annual financial report of the Company for a financial year.

Shareholders can view the full remuneration report in the 2024 Annual Report which is available on QuickFee's website at <https://quickfee.com/investors/annual-half-year-reports/>.

Following consideration of the remuneration report, the Chairman of the Meeting will give Shareholders a reasonable opportunity to ask questions about, or make comments on, the remuneration report.

### 1.2 Board recommendation

The Directors abstain, in the interests of good governance, from making a recommendation in relation to this Resolution 1.

### 1.3 Voting exclusion statement

A voting exclusion applies to Resolution 1, as set out on page 3 of this Notice.

### 1.4 Voting consequences

A company is required to put to its shareholders a resolution proposing the calling of another meeting of shareholders to consider the appointment of Directors of the company (**Spill Resolution**) if, at consecutive Meetings, at least 25% of the votes cast on a remuneration report resolution are voted against adoption of the remuneration report and at the first of those Meetings a Spill Resolution was not put to vote. If required, the Spill Resolution must be put to vote at the second of those Meetings.

If more than 50% of votes cast are in favour of the Spill Resolution, the company must convene a shareholder meeting (**Spill Meeting**) within 90 days of the second Meeting.

All of the Directors of the Company who were in office when the Directors' report (as included in the Company's annual financial report for the most recent financial year) was approved, other than the Managing Director of the Company (if any), will cease to hold office immediately before the end of the Spill Meeting but may stand for re-election at the Spill Meeting.

Following the Spill Meeting those persons whose election or re-election as Directors of the Company is approved will be the Directors of the company.

## **2 Resolution 2 – Re-election of Director – Bruce Coombes**

---

### **2.1 General**

ASX Listing Rule 14.5 provides that an entity which has directors must hold an election of directors at each annual general meeting. The Constitution sets out the requirements for determining which Directors are to retire by rotation at an annual general meeting. Bruce Coombes, who has served as a Director since 15 February 2018, retires by rotation and seeks re-election.

Bruce Coombes qualified as a Chartered Accountant in 1985 and has spent his entire career within or providing solutions to the accounting profession. Bruce is a founder of both QuickFee AU and QuickFee US, having overseen the business from its start-up phase through to its IPO until 30 June 2022 after which Bruce transitioned to the role of Managing Director, Australia.

Previously a partner in the accounting firm, Macquarie Partners (now part of Deloitte), Bruce introduced outsourcing as a solution for Australian accounting firms. The business he created, Accountants Resourcing, was ultimately acquired by a major financial institution.

If re-elected the Board does not consider Bruce Coombes will be an independent Director.

### **2.2 Board recommendation**

The Board (excluding Bruce Coombes) supports the re-election of Bruce Coombes and unanimously recommend Shareholders vote in favour of this Resolution 2.

### 3 Resolution 3 – Ratification of Placement

---

#### 3.1 General

As announced by the Company on 3 May 2024, the Company successfully completed a placement to certain institutional and professional investors (**Placement**) of 42,500,000 new fully paid ordinary shares at an issue price of \$0.08 per share (**Placement Shares**) to raise \$3.4 million (before costs).

The Company now seeks Shareholder ratification pursuant to ASX Listing Rule 7.4 for the previous issue of 42,500,000 of the Placement Shares issued pursuant to the Company's existing capacity under ASX Listing Rules 7.1 and 7.1A on 9 May 2024.

#### 3.2 ASX Listing Rules

Broadly speaking, ASX Listing Rule 7.1 provides that a company must not, subject to a number of exceptions, issue or agree to issue Equity Securities during any 12-month period in excess of 15% of its issued capital at the commencement of that 12-month period without Shareholder approval (**15% Placement Capacity**).

Additionally, ASX Listing Rule 7.1A enables a company to seek shareholder approval by special resolution passed at an annual general meeting to have the capacity to issue up to that number of Equity Securities equivalent to an additional 10% of the number of ordinary securities on issue by way of placement over a 12-month period (**10% Placement Capacity**). This is in addition to the existing 15% Placement Capacity permitted by ASX Listing Rule 7.1.

The Placement was undertaken within the aggregate of the Company's 15% Placement Capacity and 10% Placement Capacity.

The Placement does not fit within any of the exceptions to ASX Listing Rule 7.1, and as it has not yet been approved by the Company's Shareholders, it effectively uses all of the Company's 15% Placement Capacity and part of the Company's 10% Placement Capacity, reducing the Company's capacity to issue further securities without Shareholder approval under ASX Listing Rules 7.1 and 7.1A for the 12-month period following the issue date of the Placement Shares.

ASX Listing Rule 7.4 allows shareholders of a listed entity to ratify an issue of Equity Securities after it has been made or agreed to be made. If they do, the issue is taken to have been approved under ASX Listing Rules 7.1 and 7.1A and so does not reduce the entity's capacity to issue further Equity Securities without shareholder approval under that rule.

The Company wishes to retain maximum flexibility to manage its future capital requirements in the best interests of Shareholders without having to obtain Shareholder approval for such issues under ASX Listing Rules 7.1 and 7.1A.

To this end, Resolution 3 seeks Shareholder ratification of the Placement under ASX Listing Rule 7.4.

If Shareholders approve Resolution 3 and therefore ratify the Placement in respect of the 42,500,000 Placement Shares issued under ASX Listing Rules 7.1 and 7.1A, those shares will be deemed to have been issued with Shareholder approval and will no longer be deducted from the Company's Placement Capacity under Listing Rules 7.1 and 7.1A. ## 4 Resolution 4 – Approval of Director participation in the Placement

As described in section 3.1 above, the Company successfully completed the Placement of 42,500,000 Placement Shares on 3 May 2024.

Shareholder approval is being sought under Resolution 4 to permit Dale Smorgon, Non-executive Chairman of the Company (and/or his respective nominees) to participate in the Placement and subscribe for up to 4,375,000 new fully paid ordinary shares each at an issue price of \$0.08 per share (the **Director Placement Shares**) in addition to the 42,500,000 Placement Shares the subject of Resolution 3 on the same terms as all other Placement participants, other than the delay in timing of the issue due to the requirement for Shareholder approval.

### 4.2 ASX Listing Rules

ASX Listing Rule 10.11 provides that unless one of the exceptions in Listing Rule 10.12 applies, a listed entity must not issue or agree to issue Equity Securities to:

- 10.11.1 a related party;
- 10.11.2 a person who is, or was at the time in the 6 months before the issue or agreement, a substantial (30%+) holder in the entity;
- 10.11.3 a person who is, or was at any time in the 6 months before the issue or agreement, a substantial (10%+) holder in the entity and who has nominated a Director to the board of the entity pursuant to a relevant agreement which gives them a right or expectation to do so;
- 10.11.4 an associate of a person referred to in ASX Listing Rules 10.11.1 to 10.11.3; or
- 10.11.5 a person whose relationship with the entity or a person referred to in Listing Rules 10.11.1 to 10.11.4 such that, in ASX's opinion, the issue or agreement should be approved by its shareholders,

unless it obtains the approval of its shareholders.

Dale Smorgon (and/or his respective nominee/s) will subscribe for the Director Placement Shares the subject of this Resolution 4 on the same terms and conditions as the Placement Shares issued by the Company to non-related party participants. Therefore, the Company considers that the proposed participation in the Placement by Dale Smorgon (and/or his respective nominee/s), and the Company's issue of Director Placement Shares to him (and/or his respective nominees) falls within the arm's length exception set out in Section 210 of the Corporations Act.

## Resolution 5 – Ratification of issue of ordinary shares to Win Finance No. 506 Pty Ltd

---

### 5.1 General

The Company has been offering Australian legal disbursements (**DF**) funding to personal injury law firms since 2014, to fund disbursement costs for personal injury cases for up to 30 months. To date, DF receivables have been primarily funded from QuickFee's internal cash resources, with its Northleaf Capital Partners debt facility providing funding for DF loans up to 5% of Northleaf's total pledged receivables, equating to approximately A\$2 million.

On 21 December 2023, the Company finalised an agreement (**Wingate Agreement**) with the Wingate Corporate Investments group for a A\$10 million funding facility to support growth of the DF product. This new facility will provide the Company with up to a total of A\$10 million to allow for continued growth in the DF loan book.

As part of the consideration payable by the Company for the establishment of the Wingate Agreement, the Company agreed to issue 5,671,351 warrants (**Wingate Warrants**) to Wingate entity Win Finance No. 506 Pty Ltd, each Wingate Warrant exercisable into one ordinary share of the Company by 15 December 2027 for nil consideration.

The Wingate Warrants were subsequently exercised on 14 June 2024 and converted into 5,671,351 ordinary shares in the Company (**Wingate Shares**), which were issued on 19 June 2024.

A summary of the material terms of the Wingate Warrants is set out in section 5.3 below.

### 5.2 ASX Listing Rules

Broadly speaking, ASX Listing Rule 7.1 provides that a company must not, subject to a number of exceptions, issue or agree to issue Equity Securities during any 12-month period in excess of 15% of its issued capital at the commencement of that 12-month period without Shareholder approval (**15% Placement Capacity**).

Additionally, ASX Listing Rule 7.1A enables a company to seek shareholder approval by special resolution passed at an annual general meeting to have the capacity to issue up to that number of Equity Securities equivalent to an additional 10% of the number of ordinary securities on issue by way of placement over a 12-month period (**10% Placement Capacity**). This is in addition to the existing 15% Placement Capacity permitted by ASX Listing Rule 7.1.

ASX Listing Rule 7.4 allows shareholders of a listed entity to ratify an issue of Equity Securities after it has been made or agreed to be made. If they do, the issue is taken to have been approved under ASX Listing Rule 7.1 and so does not reduce the entity's capacity to issue further Equity Securities without shareholder approval under that rule.

The issue of the Wingate Shares falls within exception 16 of Listing Rule 7.2, which requires the Company to seek shareholder approval under ASX Listing Rule 7.4, which in turn requires that the issue did not breach ASX Listing Rule 7.1 and that the Company was in compliance with the ASX Listing Rules when it entered into the agreement to issue the Wingate Shares. An issue made in accordance with ASX Listing Rule 7.1A can be approved subsequently under Rule 7.4; such issues do not breach ASX Listing Rule 7.1.

To this end, Resolution 5 seeks Shareholder ratification of the issue of the Wingate Shares under ASX Listing Rule 7.4. The effect of Resolution 5 will be to allow the Company to issue the Wingate Shares without using the Company's 15% Placement Capacity or 10% Placement Capacity.

If Shareholders approve Resolution 5 and therefore ratify the issue under ASX Listing Rule 7.4 of the 5,671,351 Wingate Shares, those warrants will be deemed to have been issued with Shareholder approval and will no longer be deducted from the Company's Placement Capacity under ASX Listing Rules 7.1 and 7.1A. This will effectively be increasing the number of Equity

Securities the Company can issue without Shareholder approval over the 12-month period following the issue date.

If Shareholders do not approve Resolution 5, and therefore do not ratify the issue of the Wingate Shares, the Wingate Shares will be deducted from the Company's 15% Placement Capacity and 10% Placement Capacity, effectively decreasing the number of Equity Securities the Company can issue without Shareholder approval over the 12-month period following the issue date.

## Resolution 6 – Approval to issue Performance Rights to Bruce Coombes

### 6.1 General

The Company has an existing employee incentive scheme called the QuickFee Performance Rights and Option Plan (**PROP**), under which certain eligible employees and Directors of the Company (**Eligible Participants**) may be granted Performance Rights and Options from time to time.

The PROP was adopted prior to QuickFee listing on the ASX in July 2019 and relies on the former exception to ASX Listing Rule 7.2, Exception 9(a), available in respect of an employee incentive scheme established before a listed entity was listed. A minor amendment to the PROP was made as at 8 November 2021 to facilitate employees electing to receive some or all of their short term incentive awards or other bonus or salary payments in the form of performance rights or options under the PROP where invited to do so by the Company. A further minor amendment to the PROP was made as at 9 September 2023 for changes to the Corporations Act 2001 (Cth) (“Act”) and to address the requirements of Division 1A of Part 7.12 of the Act.

The summary of the material terms of the PROP is set out in the explanatory notes to Resolution 7 below and in Annexure A, and a copy of the rules of the PROP is available upon request from the Company.

Resolution 6 seeks Shareholder approval to issue to Bruce Coombes, Executive Director of the Company up to a maximum of 700,000 Performance Rights under the PROP.

Bruce Coombes is a Director of the Company and is therefore a related party of the Company for the purposes of ASX Listing Rule 10.14.1.

The grant of the Performance Rights to Bruce Coombes is proposed following a detailed review by the Board of his remuneration. Details of his remuneration for the financial year ended 30 June 2024 (**FY24**) are set out in the remuneration report of the 30 June 2024 Annual Financial Report of the Company.

In the Board’s view, the Performance Rights being granted to Bruce Coombes link the ultimate value of the Performance Rights to the continued growth of the Company and therefore provide an incentive for him to ensure the Company continues to deliver sustainable growth. The grant of the Performance Rights will provide Bruce Coombes, who is considered to be key to the future success of the Company, with the opportunity to receive new Shares in order to reward his contributions to the Company achieving the long-term strategic objectives set by the Board and the overall future success of the Company.

The Performance Rights will be granted as part of Bruce Coombes’ remuneration package for the financial year ended 30 June 2025 (**FY25**) under the PROP.

### 6.2 ASX Listing Rules

ASX Listing Rule 10.14 provides that a listed entity must not permit any of the following persons to acquire Equity Securities under an employee incentive scheme:

- 10.14.1 a Director of the entity;
- 10.14.2 an associate of a Director of the entity; or
- 10.14.3 a person whose relationship with the entity or a person referred to in ASX Listing Rule 10.14.1 or 10.14.2 is such that, in ASX’s opinion, the issue or agreement should be approved by its shareholders,

unless it obtains the approval of its shareholders.

The issue of Performance Rights to Bruce Coombes falls within ASX Listing Rule 10.14.1 above and therefore requires the approval of Shareholders under ASX Listing Rule 10.14.



Resolution 6 seeks the required shareholder approval to the issue of Performance Rights under and for the purposes of ASX Listing Rule 10.14.

If Resolution 6 is passed and approval is given for the issue of the Performance Rights under ASX Listing Rule 10.14, the Company will be able to proceed with the issue of Performance Rights to Bruce Coombes. Approval will not be required under ASX Listing Rule 7.1, and the issue of Performance Rights to Bruce Coombes will not count towards the Company's 15% Placement Capacity under ASX Listing Rule 7.1 or 10% Placement Capacity under ASX Listing Rule 7.1A. Separate approval will also not be required under ASX Listing Rule 10.11 (which provides a general restriction against issuing securities to Directors without shareholder approval).

If Resolution 6 is not passed, and approval is not given for the issue of the Performance Rights under ASX Listing Rule 10.14, the Company will not be able to proceed with the issue of Performance Rights to Bruce Coombes and the Board may consider alternative remuneration arrangements in lieu of the issue of Performance Rights.

The issue of Performance Rights to Bruce Coombes under this Resolution 6 requires the approval of Shareholders under ASX Listing Rule 10.14, and once approved the Performance Rights are issued under ASX Listing Rule 7.2 exception 14. Any securities issued under ASX Listing Rule 7.2 exception 14 and approved by Shareholder are not be included in the maximum number of securities proposed to be issued under the PROP in accordance with ASX Listing Rule 7.2 exception 13 (which is subject to Shareholder approval under Resolution 7 of this Notice).

Tranche 1 and Tranche 2 Performance Rights expire on 30 June 2027.

The Performance Rights will be otherwise issued on the terms set out in the PROP, a summary of which is set out in Annexure A.

## 7 Resolution 7 – Approval of Performance Rights and Option Plan (PROP)

### 7.1 General

The Company has an existing employee incentive scheme called the QuickFee Performance Rights and Option Plan (**PROP**), under which certain eligible employees and Directors of the Company (**Eligible Participants**) may be granted Rights and Options from time to time.

The PROP was adopted prior to QuickFee listing on the ASX in July 2019 and relies on the former exception to ASX Listing Rule 7.2, Exception 9(a), available in respect of an employee incentive scheme established before a listed entity was listed. A minor amendment to the PROP was made as at 8 November 2021 to facilitate employees electing to receive some or all of their short term incentive awards or other bonus or salary payments in the form of performance rights or options under the PROP where invited to do so by the Company. A further minor amendment to the PROP was made as at 9 September 2023 for changes to the Corporations Act 2001 (Cth) (“Act”) and to address the requirements of Division 1A of Part 7.12 of the Act.

The summary of the material terms of the PROP is set out below and in Annexure A, and a copy of the rules of the PROP is available upon request from the Company.

Resolution 7 seeks Shareholder approval to:

- (a) approve and adopt the PROP, and authorise the Directors to do all things necessary to operate the PROP, including making such modifications as the Directors consider appropriate to take account of any applicable regulatory requirements and best practice; and
- (b) authorise Directors to establish and do all things necessary to operate such further plans for the benefit of employees in different jurisdictions based on the PROP, subject to such modifications as may be necessary or desirable to take account of overseas securities laws, exchange control and tax legislation, provided that any ordinary shares of the company made available under such further plans are treated as counting against any limits on individual or overall participation in the PROP.

### 7.2 ASX Listing Rules

ASX Listing Rule 7.2 exception 13 excludes from the restrictions in Listing Rules 7.1 and 7.1A the issue of any securities to employees under the PROP, provided that the PROP is renewed every 3 years.

If Resolution 7 is passed, the Company will be able to proceed with the issue of Options and Performance Rights under the PROP to Eligible Participants over a period of 3 years from the date of approval without impacting existing 15% Placement Capacity permitted by ASX Listing Rule 7.1.

If Resolution 7 is not passed, issues of Options or Performance Rights under the PROP may still occur but will be counted as part of the company’s existing 15% Placement Capacity.



**7.3 Information required by ASX Listing Rule 7.2 exception 13**

## 8 Resolution 8 – Approval of additional share issue capacity under ASX Listing Rule 7.1A

### 8.1 General

ASX Listing Rule 7.1A enables an Eligible Entity (as defined below) to seek shareholder approval by special resolution passed at an annual general meeting to have the capacity to issue up to that number of Equity Securities equivalent to an additional 10% of the number of ordinary securities on issue by way of placement over a 12-month period (**10% Placement Capacity**). This is in addition to the existing 15% Placement Capacity permitted by ASX Listing Rule 7.1.

An Eligible Entity is one that, as at the date of the relevant meeting:

- (a) it is not included in the S&P/ASX 300 Index; and
- (b) it has a market capitalisation of \$300 million or less (excluding restricted securities and securities quoted on a deferred settlement basis).

As at the date of the finalisation of this Notice, the Company is an Eligible Entity as it is not included in the S&P/ASX 300 and it has a market capitalisation of approximately \$22 million. The additional 10% Placement Capacity and Resolution 8 is conditional on the Company continuing to be an Eligible Entity at the date of the Meeting. If the Company is an Eligible Entity as at the date of the Meeting, and Resolution 8 is passed, the Company will have the benefit of the 10% Placement Capacity even if it subsequently ceased to be an Eligible Entity in the following 12 months.

An Equity Security is a share, a unit in a trust, a right to a share or unit in a trust or option, an option over an issued or unissued security, a convertible security, or, any security that ASX decides to classify as an equity security.

Any Equity Securities issued under the 10% Placement Capacity must be in the same class as an existing class of quoted Equity Securities.

As at the date of this Notice, the Company currently has one class of quoted Equity Securities on issue, being the Shares (ASX Code: QFE).

Accordingly, Resolution 8 is seeking approval of ordinary Shareholders by special resolution for the issue of such number of Equity Securities as calculated under the formula in ASX Listing Rule 7.1A.2, at an issue price as permitted by ASX Listing Rule 7.1A.3 to such persons as the Board may determine, on the terms as described in this Explanatory Memorandum.

At the date of this Notice, the Company has on issue 336,716,758 fully paid ordinary shares and a capacity to issue:

- (a) 2,872,786 Equity Securities under ASX Listing Rule 7.1; and
- (b) 28,181,402 Equity Securities under ASX Listing Rule 7.1A.

The actual number of Equity Securities that the Company will have capacity to issue under ASX Listing Rule 7.1A will be calculated at the date of issue of the Equity Securities in accordance with the formula prescribed in ASX Listing Rule 7.1A.2.

The effect of Resolution 8 will be to allow the Directors to issue Equity Securities under ASX Listing Rule 7.1A during a 10% placement period, without using the Company's 15% Placement Capacity under ASX Listing Rule 7.1.

## 8.2 Information required by ASX Listing Rule 7.3A

For the purposes of ASX Listing Rule 7.3A, the following information is provided in relation to this Resolution 8:

### (a) Period for which the approval will be valid

An approval under ASX Listing Rule 7.1A will commence on the date of the Meeting and expire on the first to occur of the following:

- (i) the date that is 12 months after the date of the Annual General Meeting at which the approval is obtained;
- (ii) the time and date of the next Annual General Meeting; and
- (iii) the time and date of the approval by Shareholders of any transaction under ASX Listing Rule 11.1.2 (a significant change in the nature or scale of activities) or ASX Listing Rule 11.2 (disposal of the main undertaking).

### (b) Minimum price at which the Equity Securities may be issued under Listing Rule 7.1A

Any Equity Securities issued under ASX Listing Rule 7.1A must be an existing quoted class of Equity Securities and issued for cash consideration. The minimum price at which the Equity Securities will be issued will be no less than 75% of the volume weighted average price of Equity Securities in that class, calculated over the 15 ASX trading days on which trades in that class are recorded immediately before:

- (i) the date on which the price at which the Equity Securities are to be issued is agreed; and
- (ii) if the Equity Securities are not issued within 10 ASX trading days of the date in paragraph (i), the date on which the Equity Securities are issued.

### (c) Purposes for which the funds raised by an issue of Equity Securities under Listing Rule 7.1A may be used

As previously noted, any Equity Securities issued under Listing Rule 7.1A.2 must be issued for cash consideration. Accordingly, the Company intends to use the funds raised towards an acquisition of new assets or investments (including expenses associated with such acquisition), continued expenditure on the Company's current business operations and projects, continued development of the Company's current assets and/or general working capital.

### (d) Risk of voting dilution

If Resolution 8 is approved by Shareholders and the Company issues Equity Securities under the 10% Placement Facility, the existing ordinary Shareholders face the risk of economic and voting dilution as a result of the issue of Equity Securities which are the subject of this resolution, to the extent that such securities are issued, including:

- (i) the market price of Equity Securities in that class may be significantly lower on the issue date than on the date on which this approval is being sought; and
- (ii) the Equity Securities may be issued at a price that is at a discount to the market price for those Equity Securities on the issue date, which may have an effect on the amount of funds raised by the issue of the Equity Securities.

The following table gives examples of the potential dilution of existing ordinary Shareholders on the basis of the current market price of shares and the current number of ordinary securities for variable "A" in the formula in ASX Listing Rule 7.1A.2 as at the date of the Notice.

The table also shows:

The identity of allottees of Equity Securities that may be issued (subject to Shareholder approval of Resolution 8) have not been determined as at the date of this Notice but may include existing Shareholders and/or parties who are not currently Shareholders and are not related parties or associates of the Company. Any potential allottees will be determined on a case-by-case basis having regard to factors including, but not limited to, the following:

- (i) the purpose of the issue;
- (ii) the methods of raising funds available to the Company (including but not limited to, rights issue or other issues in which existing security holders can participate), while balancing interest from potential allottees with the interests of existing Shareholders;
- (iii) the effect of the issue of Equity Securities on the control of the Company and balancing the interests of existing Shareholders. Allocation will be subject to takeover thresholds;
- (iv) the financial situation and solvency of the Company and its need for working capital at any given time;
