## SUSPENSION FROM OFFICIAL QUOTATION

The securities of Calliden Group Limited (the "Company") will be suspended from quotation at the close of trading today, Friday, 12 December 2014 in accordance with Listing Rule 17.2, following lodgement of the Federal Court of Australia orders with the Australian Securities and Investments Commission approving the scheme of arrangement by which Steadfast Group Ltd will acquire all of the issued shares in the Company.

**Application for suspension of trading**

Calliden Group Limited ('Calliden') (ASX:CIX) requests ASX to suspend trading of Calliden shares from close of trading today, being Friday 12 December 2014.

As announced to the ASX yesterday, the Federal Court of Australia yesterday made orders approving the scheme of arrangement under which Steadfast Group Ltd will acquire all of the issued shares in Calliden ('Scheme'). A copy of the Court's orders has now been lodged with the Australian Securities and Investments Commission and the Scheme has become legally effective.

In accordance with Listing Rule 17.2:


- **(Reasons for the suspension)** The Scheme has now become legally effective and all of the issued shares in Calliden will be transferred to Steadfast on the 'Implementation Date', being 23 December 2014. Calliden has disclosed to its shareholders in the Scheme Booklet and subsequent ASX announcements that it will apply for its shares to be suspended from trading from the close of trading today.
- **(Length of suspension)** The suspension is expected to last until Calliden is removed from the official list of ASX. On a date after the 'Implementation Date', Calliden will apply for the termination of the official quotation of Calliden shares on the ASX and for Calliden to be removed from the official list of ASX.
- **(The event it expects to happen that will end suspension)** The termination of the official quotation of Calliden shares on ASX and the removal of Calliden from the official list of ASX will be the event that will end the suspension.
