**SECONDARY TRADING NOTICE PURSUANT TO SECTION 708A(5) OF THE CORPORATIONS ACT 2001 ("Act")**

On 2 February 2017, Blackham Resources Limited ("**the Company**") issued a total of 1,000,000 fully paid ordinary shares in the capital of the Company. The shares were issued by the Company pursuant to the exercise of Blackham options by a consultant.

    - ii. The rights and liabilities attaching to the Shares.
