**Notice under section 708A(5)(e) of the Corporations Act 2001 (Cth)**

Pantoro Gold Limited (ACN 003 207 467) (**ASX: PNR**) (**Company**) gives this notice under section 708A(5)(e) of the Corporations Act 2001 (Cth) (the **Act**).

On 9 June 2025 the Company allotted 1,367,974 ordinary fully paid shares (**Shares**) on exercise of options with an exercise price of US\$1.0812 per Share (approximately A\$1.68 per Share) to Nebari Partners LLC (**Nebari**). The Shares were issued under the Company's Listing Rule 7.1 capacity.

The Company advises that:
