## GOLD-RICH ALTERATION ZONE IDENTIFIED AT ANTLER DEPOSIT

***Gold mineralisation identified outside the existing high-grade Copper Antler Resource and close to planned underground mining infrastructure development***

### Highlights

- Ongoing geological review of the Antler Copper Project has led to the identification of previously unrecognised gold mineralization associated with an intensely altered zone outside of the current mine plan and Resource model
- The intense alteration and gold mineralization is interpreted to be part of the hydrothermally altered stratigraphic footwall and stringer zone of the Antler Deposit
- Analysis of drill core from the altered zone has revealed elevated gold grades over 550m of strike and 1000m dip extent
- A significant portion of the altered zone is located close to planned underground development and will be included in the Resource update, to be completed in the coming months and the DFS to be completed in Q4 2025
- This mineralised zone has the potential to enhance the Antler Copper Project's mineable inventory, economic returns and funding options

### New World's Managing Director, Nick Woolrych, commented:

*"As Antler rapidly proceeds to development, the identification of significant gold mineralization within the stringer zone at Antler represents an exciting potential new source of value for the Company. We are currently in the process of a detailed exploration review and field work programs following the 2024 drilling programs, with one of the world's leading VMS experts appointed to assist. This exciting development is a direct result of this work.*

**New World Resources (“NWC”, “New World” or the “Company”)** is pleased to report the identification of significant additional gold mineralization associated with the footwall alteration and stringer zone, a domain of the Antler Deposit which has been extensively explored for its base metal potential. As a result of the ongoing exploration review, recent sampling and analysis of drill core from outside the previously reported massive sulphide domains and in the newly identified stringer zone has revealed elevated gold grades over 550m of strike and 1000m dip extent, all of which falls outside the current mine plan. To date, the best gold intercepts identified in the alteration zone include:

- ANT0023: 7.0m @ 2.03 g/t Au, 3.95m @ 1.53 g/t Au, and 1.85m @ 0.68 g/t Au;
- ANT0009 : 1.17m @ 7.53 g/t Au;
- ANT0017: 4.35m @ 1.84 g/t Au and 2.50m @ 2.28 g/t Au;
- ANT0055: 3.30m @ 2.18 g/t Au;
- ANT0022: 4.0m @ 1.70 g/t Au, and 3.2m @ 1.23 g/t Au ; and,
- ANT0077 : 0.9m @ 3.46 g/t Au, 2.0m @ 3.69 g/t Au, and 2.0m @ 1.38 g/t Au.

The Company is currently undertaking further work to define the extent, continuity, and grade of the gold mineralization, and how any such mineralisation may be included in future mine plans. This includes additional sampling and analysis, as well as geological modelling, all of which will be incorporated into the Resource model update currently being developed.

Additional alteration zone assays will be reported in Q1 2025 when assays are completed.

## Background

The Antler Resource model has evolved from the initial two-lode interpretation to a more detailed understanding incorporating an alteration zone and distinct mineralization domains (alteration, stringer sulphide, massive and semi-massive sulphide, etc) in an overturned setting. This shift reflects a deeper understanding of the deposit's geological morphology and controls on mineralization. The recognition of the alteration zone as a significant contributor to the resource base is a key development. This zone, previously underestimated, hosts substantial gold mineralization within the structural hanging wall to the Antler Deposit. This mineralization appears to be outside the previously defined two-lode model, opening up new exploration targets and resource expansion potential.

## Resource Update

The ongoing Resource estimation work, using the updated geological model and domaining, is expected to provide a more accurate and comprehensive assessment of the overall confidence and robustness of the Antler Copper Project and Resource growth and exploration potential.

The JORC Mineral Resource Estimate (MRE) for the Antler Deposit currently comprises: **11.4Mt @ 2.1% Cu, 5.0% Zn, 0.9% Pb, 32.9g/t Ag and 0.36g/t Au (11.4Mt @ 4.1% Cu-equivalent)**. This makes the Antler Deposit one of the highest-grade copper deposits in the world (on a copper-equivalent basis), and the inclusion of additional gold mineralisation at grades significantly higher than currently modelled is material to the Project economics and development funding opportunities.

The identification of gold mineralization in the structural hanging wall and the evolving understanding of the deposit's controls suggest significant potential for further resource expansion through ongoing exploration. Exploration programs will be designed to test the potential for further resource expansion.

The updated Resource estimate will be incorporated into the ongoing economic evaluation of the Project, culminating in the release of the DFS by the end of 2025.

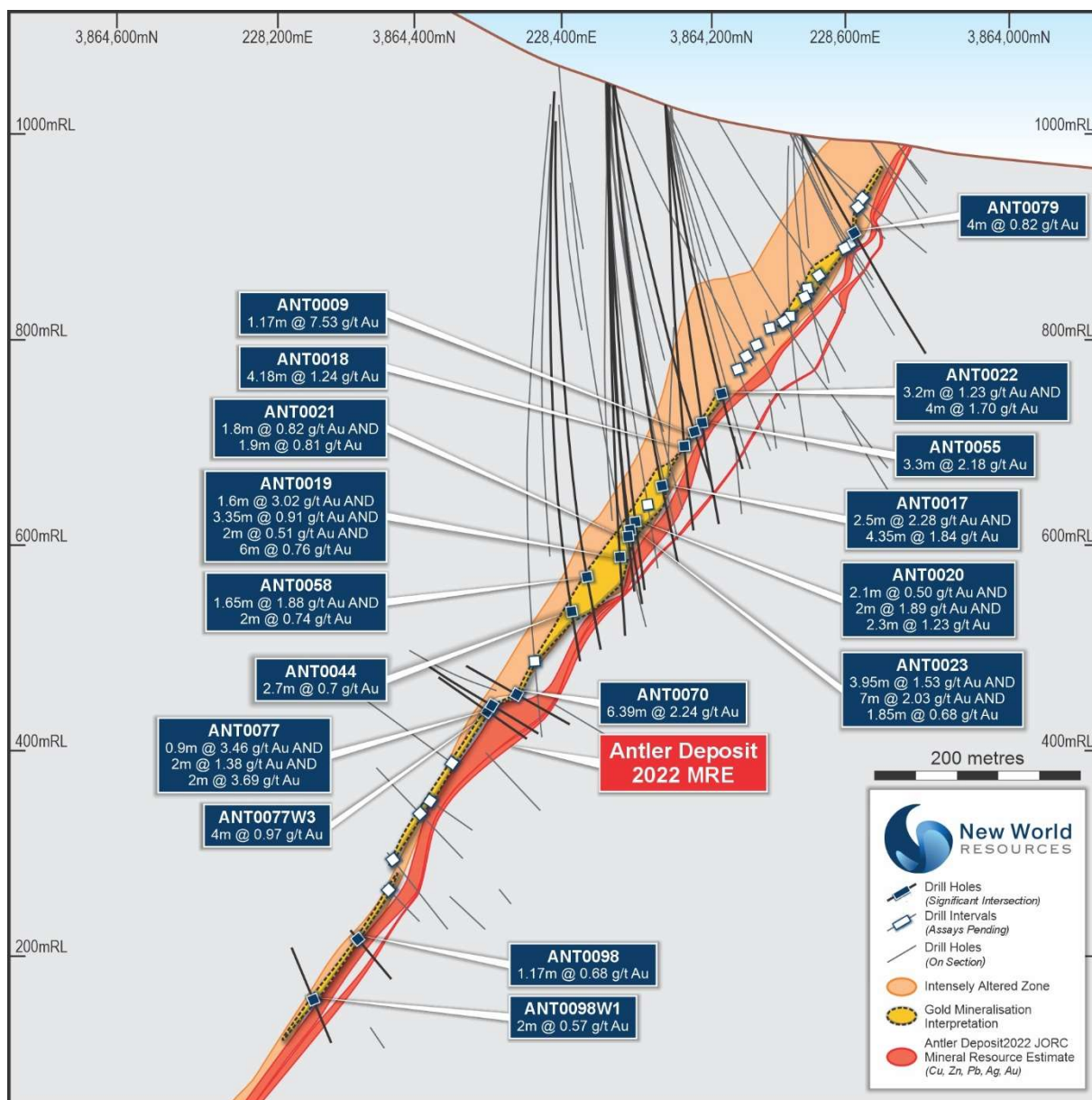


Figure 1 cross section through “Main Shoot” area, Highlighting significant zones of intensely altered and potentially gold mineralized stringer zone

## Antler Copper Project – Project Summary

The Antler Copper Project is located in a sparsely populated part of northern Arizona, approximately 200km south-east of Las Vegas and 350km north-west of Phoenix. New World currently bases its operations 40km to the north of the Project, in the city of Kingman, which has a population of approximately 35,000. The area is very well serviced with large scale infrastructure and there are multiple mining operations in the region.

A PFS, released on 17 July 2024, evaluated the development of an underground mining operation, together with construction of a processing plant, pastefill plant, a fully-lined dry-stack tailings storage facility and associated infrastructure.

The JORC Mineral Resource Estimate (MRE) for the Antler Deposit currently comprises: 11.4Mt @ 2.1% Cu, 5.0% Zn, 0.9% Pb, 32.9g/t Ag and 0.36g/t Au (11.4Mt @ 4.1% Cu-equivalent). This makes the Antler Deposit one of the highest-grade copper deposits in the world (on a copper-equivalent basis).

The Antler Deposit remains open at depth and along strike. The Company is committed to ongoing local and regional exploration and is currently continuing to drill to test numerous priority targets. Additional discovery could potentially extend the life of the mining operation at Antler and/or result in a larger production profile, both of which would likely further enhance the already very robust economics of developing the Antler Project.

### Copper Equivalent Calculations

Copper equivalent grades have previously been calculated based on the parameters set out in New World’s announcements to the ASX on 12 May, 3 August, 31 August, 22 September and 2 and 25 November 2020, and 18 January, 19 March, 8 April, 20 May, 21 June, 15 and 29 July, 16 August, 22 September, 13 October, 5 and 30 November 2021 and 20 January, 1 March, 20 April, 14 July 26 September, 11 October and 5 December 2022 and 18 March and 17 July 2024.

For the JORC Mineral Resource Estimate for the Antler Copper Deposit: copper equivalent grades were calculated based on the following assumed metal prices that closely reflect the spot prices prevailing on 10 October 2022; namely: copper – US\$7,507/t, zinc – US\$3,011/t, lead – US\$2,116/t, silver – US\$20.26/oz and gold – US\$1,709/oz. Potential metallurgical recoveries have been included in the calculation of copper equivalent grades. These recoveries have been based on metallurgical testwork that New World had conducted. This metallurgical testwork is continuing, but recoveries are expected to be in the order of: copper – 87.2%, zinc – 88.9%, lead – 59.1%, silver – 50.3% and gold – 70.0%. New World believes that all elements included in the metal equivalent calculation have a reasonable potential to be recovered and sold.

The following formula was used to calculate the copper equivalent grade, with results rounded to one decimal point: Resource Cu equiv. (%) = (Cu% x 0.872) + (Zn% x 0.889 x 3,011/7,507) + (Pb% x 0.591 x 2,116/7,507) + (Ag oz/t x 0.503 x 20.26/7,507 x 100) + (Au oz/t x 0.700 x 1,709/7,507 x 100)

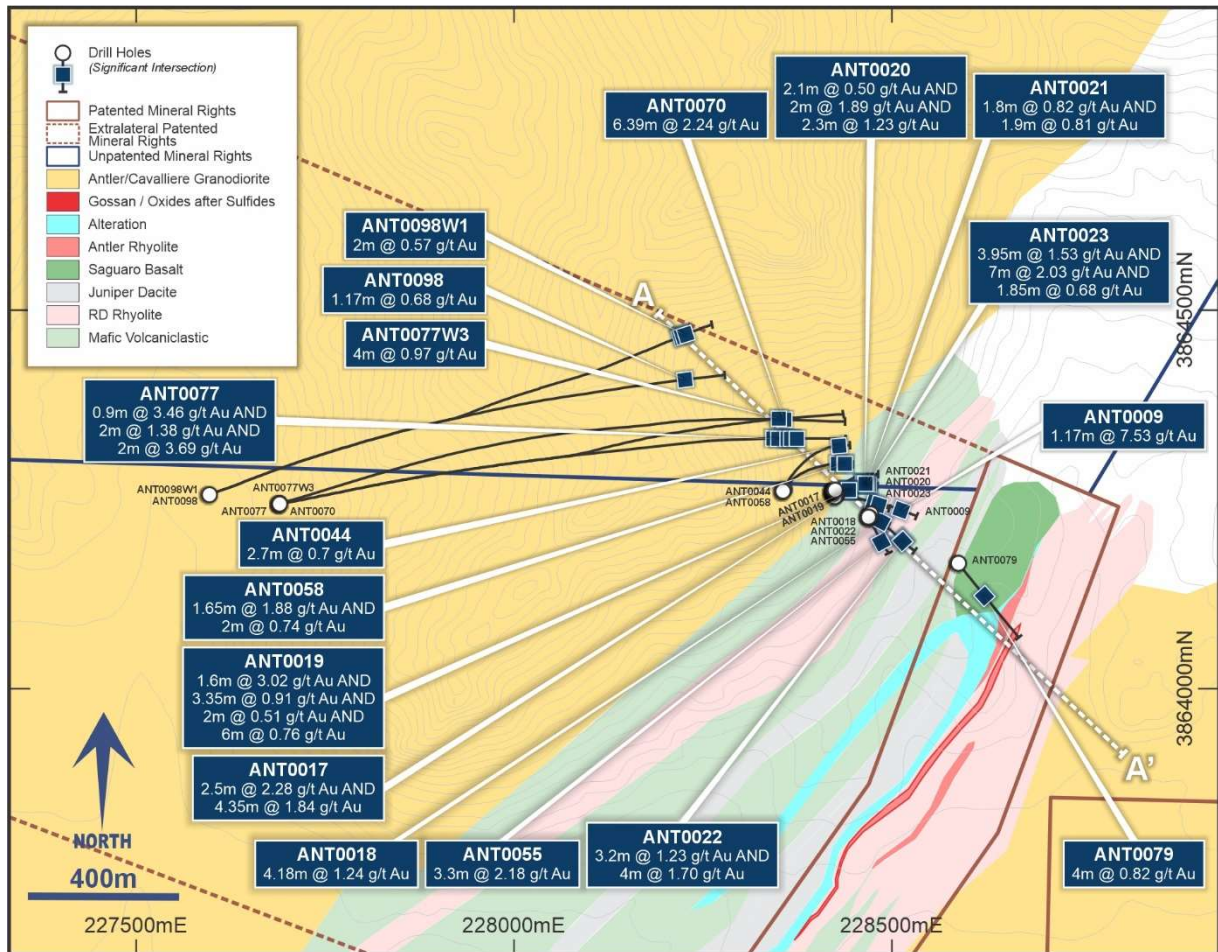


Figure 2. Drill hole plan showing the location of the previously unsampled diamond core drilling and the significant drill results.
