## Enlitic Signs Expansion and Extension Contract with Unilabs

### Highlights

- Secured an expansion and extension agreement totalling \$2.1 million USD over 5 years with Unilabs, a prominent international provider of diagnostic services
  - Agreement replaces and extends the existing subscription with Unilabs' Telemedicine Clinic (TMC) business which delivered a 10% increase in radiology efficiency
  - Enlitic<sup>(R)</sup> intends to expand its current scope by deploying ENDEX<sup>(TM)</sup> software to additional Unilabs territories within their expansive network of 180 imaging centres across multiple countries

**Enlitic, Inc. (ASX: ENL)** ("the Company") is pleased to announce that it has expanded its Subscription License Agreement with leading diagnostic services provider Unilabs Laboratoire d'analyses médicales ("Unilabs") to provide its ENDEX software to Unilabs' radiology business.

Unilabs is one of Europe's largest diagnostics companies with a network of over 180 imaging centres, conducting more than 5 million imaging exams annually. Unilabs will implement Enlitic's ENDEX software across their radiology business to normalise its medical image data to a consistent clinical nomenclature and to connect relevant clinical content across its different clinic systems.

The new Agreement incorporates the remainder of Enlitic's 2021 contract with Unilabs' TMC business which resulted in a 10% increase in radiologist productivity, with faster reporting and the ability to handle higher exam volumes.

**Michael Sistenich, CEO of Enlitic**, said "We are expanding our relationship with the Unilabs business to enable them to find the answers to their customers' problems. Unilabs' mantra of "CARE BIG" is reflected in this agreement as, together, we strive to make effective decisions and deliver an outstanding experience for patients. Enlitic's proven track record with TMC will broaden to provide efficiency benefits to Unilabs imaging diagnostic services, solving imaging problems at the source, and making a difference to their medical imaging workflow."
