# HERITAGE APPROVAL FOR DRILLING AT LEINSTER SOUTH

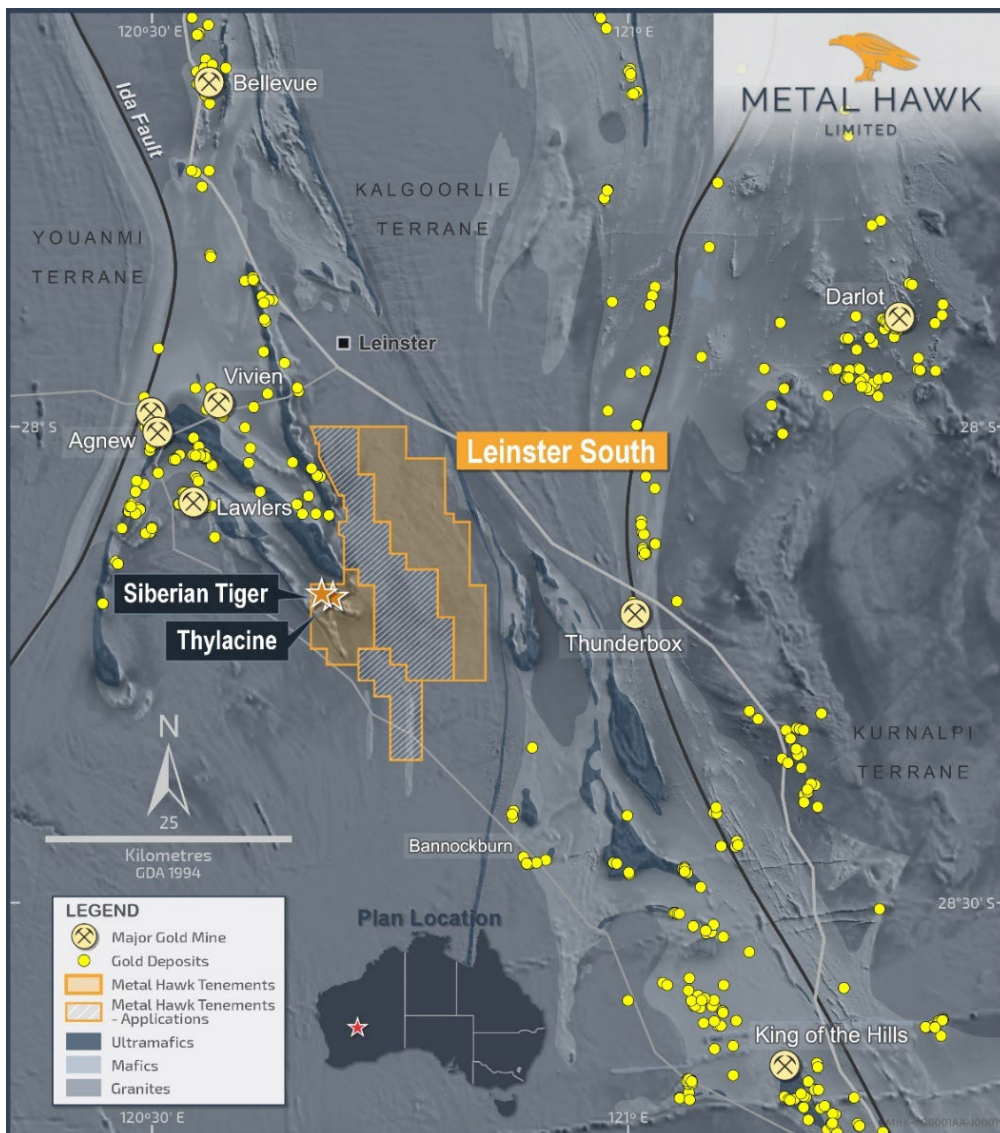

Metal Hawk Limited (**ASX: MHK**, “**Metal Hawk**” or the “**Company**”) is pleased to provide an update for the Leinster South Project, located in the world-class Agnew-Lawlers region, Western Australia. The Aboriginal heritage survey report has been completed and approval is granted for the Company’s initial ~5,000m reverse circulation (RC) drilling program at Leinster South. Earthworks are scheduled to commence imminently and drilling will commence immediately thereafter.

Following multiple discoveries of high-grade surface gold at Leinster South in 2024, preparations are nearing completion for an extensive maiden drilling program. The initial campaign will include up to 50 RC holes targeting the previously untested gold-bearing quartz vein systems at the Thylacine and Siberian Tiger prospects. The RC rig is due to arrive on site late next week and will commence work at Thylacine, where initial drilling will aim to effectively bedrock-test the multiple stacked and steeply dipping outcropping gold-bearing veins.

**Metal Hawk’s Managing Director Will Belbin commented:**

*“We are very pleased to get this final tick of approval for drilling and the team is eager to get the RC program underway at Leinster South. This is the most highly anticipated early-stage drilling program I’ve been involved with and it is a very exciting time for Metal Hawk shareholders. Our preparations are almost complete and we are looking forward to a very active period ahead.”*
