The Company has executed a funding agreement with The Lind Partners, LLC for funding via convertible note placements and agreed monthly equity placements of ordinary shares. The Company received shareholder approval to issue share placements to satisfy monthly prepayments of between \$50,000 to \$250,000 over a term to June 2020. The full terms of the funding facility are detailed in the notice of shareholder meeting dated 23 July 2018.
