ICM Limited ('ICM'), 34 Bermudiana Road, Hamilton, HM11, Bermuda.

ICM Limited acts as discretionary investment manager for Zeta Resources Limited (the 'Fund'). For the purposes of this report, ICM indicates the aggregated interest held by the fund. ICM does not itself own any securities of the issuer but exercises control or direction over certain securities of the issuer (as indicated in item 3.2 below) as the investment manager of the Fund.

- 2.2 State the date of the transaction or other occurrence that triggered the requirement to file this report and briefly describe the transaction or other occurrence.**

The requirement to file this report was triggered on the 28<sup>th</sup> February 2023, when ICM, on behalf of the Fund, sold 400,000 shares through open market transactions on the TSX.

The Fund is a joint actor of ICM with respect to the Shares of the Issuer.

Since the last report filed by ICM on the 9<sup>th</sup> December 2022, ICM, on behalf of the Fund, has sold an aggregate of 6,427,200, representing a net decrease of 3.01% of the issuers 213,791,261 issued and outstanding Shares, as reported by the issuer in its Quarter 3 2022 Financial results on 9 November 2022 ('**Outstanding Shares**').

As at 9 March 2023, ICM, on behalf of the Fund, exercised control and direction over an aggregate of 22,277,545 shares, representing approximately 10.42% of the issued and outstanding shares of the Issuer.


