Amended - enCore Energy Announces Filing of S-K 1300 Technical Report Summaries

Boss Energy Limited (ASX: BOE|OTCQX: BQSSF) advises that enCore Energy Corp (NASDAQ:EU|TSXV: EU) (enCore) has published the filing of Technical Report Summaries ("TRS") prepared in accordance with U.S. Securities & Exchange Commission Regulation S-K 1300 of the Securities Exchange Act ("S-K 1300") for four of its key uranium projects, including the Alta Mesa Uranium Project and the Mesteña Grande Uranium Project, which together are known as the "**Alta Mesa Uranium Project**". Boss has a 30 per cent stake in the combined Alta Mesa Project.

The ASX release lodged earlier today by Boss contained a link to the Technical Report on the Alta Mesa Uranium Project.

enCore is the operator and 70 per cent-owner of the Alta Mesa Uranium Project, which is located in Texas. Alta Mesa is ramping up to an annualised production rate of 1.5 million pounds U₃O₈. Boss' share of this production is 30 per cent.
