



## Empire Energy Share Purchase Plan Offer Opens

Empire Energy Group Limited (**Empire**) is pleased to announce the opening today, 23 May 2025, of the Empire Share Purchase Plan Offer (**SPP Offer**) to raise up to \$3 million.

The launch of the SPP Offer follows the successful completion of a placement to institutional and sophisticated investors at an issue price of A\$0.16 per share to raise \$27.75 million (before costs) (**Institutional Placement**), as announced on 16 May 2025.

Shareholders on Empire's register with a registered address in Australia and New Zealand as at 7.00pm (Sydney time) on Thursday, 15 May 2025 will be eligible to participate in the SPP Offer. Shareholders who hold shares on behalf of, or who act for the account or benefit of, persons who reside outside Australia or New Zealand including persons who are in the United States, are not entitled to participate in the SPP Offer.

Eligible Shareholders have the opportunity to subscribe for up to \$30,000 fully paid, ordinary shares in Empire (**New Shares**) at an issue price of \$0.16 per New Share (being the same price paid by investors in the Institutional Placement), without incurring any brokerage costs or other transactions costs.

Subject to shareholder approval, participants under the Institutional Placement will be issued one attaching unlisted option for every two New Shares subscribed for (**Attaching Options**). The Attaching Options will be exercisable at \$0.24 and expire two years from the date of allotment. It is intended that, subject to shareholder approval, participants in the SPP will also be entitled to receive Attaching Options on the same terms as the Institutional Placement.

The offer and issue of Attaching Options to investors under the Placement and SPP will be made under a prospectus to be issued by Empire in due course.

## Letter from the Chairman

Dear Shareholder

On behalf of the Directors, I am pleased to offer you the opportunity to participate in Empire Energy Group Limited's (the **Company**) share purchase plan (**SPP**), which was announced to the ASX on Friday, 16 May 2025 and follows shortly after the successful placement of fully paid ordinary shares to institutional and sophisticated investors (**Placement Shares**) which raised \$27.75 million (**Placement**). The Company also received a commitment from Directors to invest in fully paid ordinary shares for an additional \$250,000 (**Director Shares**) (subject to Shareholder approval) (**Director Placement**).

The SPP provides each Eligible Shareholder the opportunity to subscribe for up to \$30,000 worth of new, fully paid, ordinary shares in the Company (**SPP Shares**, together with the Placement Shares and Director Shares as **New Shares**) at an Issue Price of \$0.16 per SPP Share (**Issue Price**), without incurring brokerage or other transaction costs, on the terms set out in this Booklet and free Attaching Options, which are subject to Shareholder approval and the issue of a prospectus. The total amount to be raised under the SPP is expected to be up to \$3 million and is not underwritten. The Company may decide to scale back applications under the SPP, or to increase or cap the size of the SPP, at its absolute discretion.

The SPP Shares are being offered at the same price at which Placement Shares were issued to investors under the Placement. The Issue Price represents a discount of:

- 22.0% to the Company's last traded share price on 14 May 2025; and
- 18.8% to the Company's 5-day volume weighted average price of shares (including trade on 14 May 2025) immediately prior to the trading halt; and
- 13.2% to the Company's 15-day volume weighted average price of shares (including trade on 14 May 2025).

The funds raised under the Placement and the SPP, along with existing cash and undrawn funding under the Macquarie facility (if required), will finance the fracture stimulation and flow testing of Carpentaria-5H, Beetaloo Basin NT, to fund installation of the Carpentaria gas plant and in-field infrastructure, working capital and costs of the Placement and the SPP.

As also announced on Friday, 16 May 2025, investors that participated in the Placement and the Director Placement and Eligible Shareholders who participate in the SPP will receive 1 free attaching option for every 2 New Shares allotted (**Attaching Options**) subject to Shareholder approval. Each Attaching Option confers on the holder the right to subscribe for one Share at an exercise price of \$0.24, expiring 24 months from the date of issue. New Shares issued will rank *pari passu* with existing fully paid ordinary shares on issue.

The offer and issue of Attaching Options will be made pursuant to a distinct offer under a prospectus to be sent to eligible persons in due course. **Persons eligible to receive Attaching Options will be required to return a completed Entitlement and Acceptance Form accompanying the prospectus in order to receive their Attaching Options.** If the Company does not, for any reason, proceed with the issue of Attaching Options (whether due to regulatory restrictions or otherwise), no participant in the SPP will be entitled to receive, or call for the return of, any subscription monies paid by them under the SPP.

## 9. What are the rights attached to SPP Shares issued under the SPP?

SPP Shares will rank equally with other Shares as at the date of issue.

## 10. What do I do if I am a Custodian?

  - (c) are not in the United States and are not acting for the account or benefit of a person in the United States.
- 2.2 The SPP is also extended to Eligible Shareholders who are Custodians, in accordance with clauses 3.2 and 4.5 below.
- 2.3 The SPP is not made to Shareholders with a registered address outside of Australia or New Zealand.

## **3. Joint holders/Custodians**

- 3.1 If two or more persons are registered on the Register as jointly holding Shares, they are taken to be a single registered holder of Shares for the purposes of determining whether they are an Eligible Shareholder and a certification given by any of them is taken to be a certification given by all of them.

- 4.4 Eligible Shareholders who receive more than one offer under the SPP (for example, because they hold Shares in more than one capacity or in different registered holdings) may apply on different Application Forms for SPP Shares but may not apply for SPP Shares with an aggregate value of more than \$30,000.
- 4.5 If you wish to subscribe for SPP Shares as a Custodian for one or more Eligible Beneficiary, you must also complete and submit a Custodian Certificate that contains further certifications and details (required under the terms of the ASIC Instrument) before your application will be accepted. ## 6. Number of SPP Shares to be issued

## **12. Dispute resolution**

- 12.1 The Company may settle, in any manner it determines, any difficulties, anomalies, or disputes which may arise in connection with, or by reason of, the operation of the SPP whether generally or in relation to any participant or any application for SPP Shares, and its decision shall be conclusive and binding on all participants and other persons to whom the determination relates.
