### **THURAYA WE CONTRACT - FIRST ORDER COMPLETED**

Beam Communications Holdings Limited ('Beam') is pleased to confirm that it has now completed the initial order from Thuraya for WE units, the total contract value of which exceeds A\$4,300,000.

Commencing in 2016, Beam designed and manufactured the WE product under contract with Thuraya, culminating in the major shipments during October and November 2018. Beam delivered the final small number of terminals on 30 November.

Thuraya's formal launch and promotion of the product to the international market, including new airtime and purchase plans, is scheduled to occur later this month and is anticipated to generate strong customer interest in the dual hotspot LTE device. Naturally, once channel demand begins to accelerate, Beam would anticipate additional orders from Thuraya in 2019.
