



ORDINARY BUSINESS

FINANCIAL AND OTHER REPORTS

ITEM 1

To receive and consider the Financial Report, Directors' Report and Auditor's Report for the Company and its controlled entities for the financial year ended 30 June 2015.

RE-ELECTION OF DIRECTORS


To consider and, if thought fit, separately to pass the following ordinary resolutions:

ITEM 2 – RESOLUTION 1

That Mr William Deane, who retires in accordance with Clause 79.1 of the Constitution, and, being eligible, offers himself for re-election, is re-elected as a Director of the Company.

Board Recommendation

The Board, other than Mr Deane, considers that it is in the best interests of shareholders that Mr Deane remains on the Board and recommends that you vote **IN FAVOUR** of Mr Deane's re-election.



ITEM 3 – RESOLUTION 2

That Ms Caroline Trotman, who retires in accordance with Clause 79.1 of the Constitution, and, being eligible, offers herself for re-election, is re-elected as a Director of the Company.

Board Recommendation

*The Board, other than Ms Trotman, considers that it is in the best interests of shareholders that Ms Trotman remains on the Board and recommends that you vote **IN FAVOUR** of Ms Trotman's re-election.*

REMUNERATION REPORT

To consider and, if thought fit, to pass the following non-binding ordinary resolution:

ITEM 4 – RESOLUTION 3

That the Remuneration Report contained in the Directors' Report for the financial year ended 30 June 2015 be adopted.

Board Recommendation

*The Board recommends that you vote **IN FAVOUR** of adopting the Remuneration Report.*

The Company does not pay any executives or employees excessively and the Board is confident that remuneration levels reflect the market.

No comment has been received by the Board at or following the 2014 AGM that any changes should be made to the principles contained in the Remuneration Report or that any specific changes should be made to remuneration payments.

The Board considers that all remuneration payments made by the Company are reasonable and appropriate having regard to the need to engage and retain capable executives and staff to manage the Company's operations.

CONTINGENT BUSINESS – SPILL RESOLUTION

The following resolution will be put to the meeting only if 25% or more of the eligible votes cast on Resolution 3 are cast against the adoption of the Remuneration Report.

To consider and, if thought fit, to pass the following ordinary resolution:

ITEM 5 – RESOLUTION 4

That a meeting (spill meeting) of the Company be held within 90 days of the date of this Annual General Meeting at which:

- (a) Messrs William Beerworth and William Deane, Dr Christopher Clark and Ms Caroline Trotman, being the Directors (other than the Managing Director) when the resolution to make the 2015 Directors' Report was passed, cease to hold office immediately before the end of the spill meeting; and
- (b) resolutions to appoint persons to offices that will be vacated immediately before the end of the spill meeting be put to the vote at the spill meeting.

Board Recommendation

The Board recommends that, if the spill resolution is put, you vote **AGAINST IT**.

In the Board's view, there is no demonstrated basis for a spill meeting and it would be extremely disruptive to the Company.

The statutory policy to provide a spill resolution is based on communicated dissatisfaction with or an objection to some aspect of the Remuneration Report that has not been corrected or dealt with by the Company.

No such dissatisfaction or objection has ever been communicated to the Company.

EXPLANATORY NOTES

These Explanatory Notes form part of the NOM and are intended to assist your consideration of the business proposed at the Annual General Meeting (AGM).

ORDINARY BUSINESS

ITEM 1 – FINANCIAL AND OTHER REPORTS

The Corporations Act requires the annual financial report and the reports of the Directors and of the Auditor to be laid before the AGM. The Constitution provides for those reports and the financial statements to be received and considered at the AGM.

Neither the Corporations Act nor the Constitution requires a vote of shareholders at the AGM on the reports or financial statements.

However, you will be given a reasonable opportunity to comment or raise questions on the reports and the financial statements and on the business and management of the Company.

You may also ask questions of the Company's Auditor who will attend the AGM.

ITEM 2 - RESOLUTION 1 – RE-ELECTION OF MR WILLIAM DEANE

Under the Constitution of the Company, one third of the Directors must retire at each AGM and no Director can hold office for more than three years or past the third AGM following the Director's appointment, whichever is the longer.

Mr William Deane will retire and, being eligible, seeks re-election as a Director.

Mr Deane's qualifications and experience are as follows:

BA (Sydney) and LLB (Bond).

Mr Deane is a director of Exto Partners Pty Ltd, a Sydney-based private investment company formed in 2003.

Mr Deane is a director of several of Exto Partners' investee companies and is experienced at building high growth companies.

He practised as a corporate lawyer in Australia with Ashurst (formerly Blake Dawson), and in the United States with Skadden Arps and Sidley Austin. As a lawyer, he focussed on equity capital markets and mergers and acquisitions.

Board Recommendation

*The Board, other than Mr Deane, considers that it is in the best interests of shareholders that Mr Deane remains on the Board and recommends that you vote **IN FAVOUR** of Mr Deane's re-election.*

ITEM 3 - RESOLUTION 2 – RE-ELECTION OF MS CAROLINE TROTMAN

Under the Constitution of the Company, one third of the Directors must retire at each AGM and no Director can hold office for more than three years or past the third AGM following the Director's appointment, whichever is the longer.

Ms Trotman will retire and, being eligible, seeks re-election as a Director.

Ms Trotman's qualification and experience are as follows:

BA (Canberra) and MBA (Macquarie).


Ms Trotman is a senior executive with extensive experience in the marketing of services, including education, and is currently Director of Marketing and Chief Operating Officer at technology start-up Swiipezy Pty Ltd.

Ms Trotman was previously Executive Director of Executive Education at the Australian Graduate School of Management, and Deputy Vice Chancellor International and Development at Macquarie University.

Prior to those roles Ms Trotman ran her own marketing consultancy; was for 6 years Global Director of Marketing for Accenture's government business division; and was Director of Marketing for each of Bankers Trust, AT Kearney, and Deloitte.

Board Recommendation

*The Board, other than Ms Trotman, considers that it is in the best interests of shareholders that Ms Trotman remains on the Board and recommends that you vote **IN FAVOUR** of Ms Trotman's re-election.*



ITEM 4 - RESOLUTION 3 – ADOPTION OF REMUNERATION REPORT

The Corporations Act requires the Directors to prepare the Remuneration Report set out in the Annual Report.

The Act also requires the Directors to put to the AGM a resolution to adopt the Remuneration Report. It provides that the vote on the resolution is advisory only and does not bind the Directors or the Company.

Shareholders will be given a reasonable opportunity to comment or raise questions on the Remuneration Report at the AGM.

Board Recommendation

*The Board recommends that you vote **IN FAVOUR** of adopting the Remuneration Report.*

The Company does not pay any executives or employees excessively and the Board is confident that remuneration levels reflect the market.

No comment has been received by the Board at or following the 2014 AGM that any changes should be made to the principles contained in the Remuneration Report or that any specific changes should be made to remuneration payments.

The Board considers that all remuneration payments made by the Company are reasonable and appropriate having regard to the need to engage and retain capable executives and staff to manage the Company's operations.

CONTINGENT BUSINESS

ITEM 5 - RESOLUTION 4 - SPILL RESOLUTION

BACKGROUND

Under the Corporations Act, if 25% or more of eligible votes are cast against the adoption of the Remuneration Report at two consecutive AGMs, the shareholders at the second AGM are required to vote on a resolution (**spill resolution**) that another shareholder meeting (**spill meeting**) be held within 90 days of the AGM at which the Directors (other than the Managing Director) when the resolution to make the Directors' Report was passed cease to hold office, but they may stand for re-election.

COMMENT ON THE 25% VOTE AGAINST THE 2014 REMUNERATION REPORT

At the Company's 2014 AGM, more than 25% of the eligible votes were cast against the adoption of the Remuneration Report.

The Directors were obliged to consider objections to the 2014 Remuneration Report when preparing the 2015 Remuneration Report, so the Chair immediately asked those voting against the resolution at the 2014 AGM to explain the reasons for their dissenting vote.

None were prepared to speak or provide reasons.

SPILL RESOLUTION

If 25% or more of the eligible votes cast at this AGM are against Resolution 3, the spill resolution must be considered and voted on by the shareholders at this AGM.

If less than 25% of the eligible votes cast are against the adoption of the Remuneration report, the spill resolution will not be put to the meeting.

If the spill resolution is put and more than 50% of the eligible votes cast are in favour of the resolution, the Company will hold the spill meeting within 90 days (by 25 February 2016). Messrs Beerworth, Deane, Dr Clark and Ms Trotman will cease to hold office immediately before the end of that meeting but will be eligible to stand for re-election.

Board Recommendation

*The Board recommends that, if the spill resolution is put, you vote **AGAINST IT**.*

In the Board's view, there is no demonstrated basis for a spill meeting and it would be extremely disruptive to the Company.

The statutory policy to provide a spill resolution is based on communicated dissatisfaction with or an objection to some aspect of the Remuneration Report that has not been corrected or dealt with by the Company.

No such dissatisfaction or objection has ever been communicated to the Company.

VOTING INFORMATION

GENERAL

The required quorum for the meeting is at least three members present in person or by proxy.

Voting will be decided on a show of hands unless a poll is demanded by the Chair or a member or members entitled to do so before the vote is taken or before or immediately after the declaration of the result on a show of hands.

On a show of hands, every member will have one vote.

On a poll, each member will have one vote for each share held by that member and in respect of which that member is entitled to vote.

If shares are jointly held and more than one of the joint holders vote, only the vote of the holder whose name appears first in the register of members will be counted.

MAJORITY REQUIRED

All of the resolutions are ordinary resolutions.

Each resolution will be passed if more than 50% of votes cast by shareholders entitled to vote on the resolution are cast in favour of the resolution.

ENTITLEMENT TO VOTE

The Company has determined, in accordance with regulation 7.11.37 of the Corporations Regulations that, for the purpose of entitlement to vote at the Annual General Meeting, shares will be taken to be held by those who hold them at 7:00pm on 24 November 2015.

VOTING OPTIONS

A. In Person

Shareholders may vote by attending the AGM and casting their votes in person.

B. Proxy or Attorney

If you are entitled to vote at the meeting, you may appoint one or two proxies.

If you appoint two proxies:

- you may appoint each proxy to represent a specified proportion of your voting rights; or
- if you do not specify the proportion or number of your votes that each proxy may exercise, each proxy may exercise half of your votes.

A proxy need not be a shareholder of the Company.

A Proxy Form accompanies this Notice of Meeting; please follow the instructions on the form.

The Proxy Form must be signed by you or by your attorney.

Proxies given by corporations must be signed under seal or under the hand of a duly authorised officer or attorney.

To be valid, the form appointing the proxy and the power of attorney or other attorney (if any) under which it is signed (or an attested copy) must be either lodged at the Registered Office of the Company or received at the facsimile number appearing on the Proxy Form by 10:00am Australian Eastern Summer Time on 24 November 2015.

Unless you specifically direct a proxy how to vote, the proxy may vote as the proxy thinks fit, or abstain from voting.

C. Direct

A direct vote allows shareholders to vote on Resolutions considered at the AGM by lodging their votes with the company prior to the AGM, without the need for the shareholders to attend the meeting or appoint a proxy.

You must mark either "For", "Against" or "Abstain" for each item of business on the voting form for a valid direct vote to be recorded on that item.

Please note that a shareholder who has cast a direct vote may attend the AGM; however, their attendance and registration cancels the direct vote unless the shareholder instructs the Company or the share registry otherwise.

To be valid, the voting form must be either lodged at the Registered Office of the Company or received at the facsimile number appearing on the Proxy Form by 10:00am Australian Eastern Summer Time on 24 November 2015.

VOTING BY CORPORATIONS

In order to vote at the meeting (other than by proxy – see above for instructions), a corporation that is a shareholder must appoint a person to act as its representative.

The appointment must comply with the Corporations Act. A letter of representation must be either lodged with the registrar prior to the commencement of the meeting, or the representative must bring to the meeting evidence of his or her appointment including any authority under which it is signed.

PROXY VOTING BY CHAIR

The Chair of the meeting will vote undirected proxies **IN FAVOUR** of Resolutions 1, 2, and 3, and **AGAINST** Resolution 4.

VOTING EXCLUSIONS

Resolutions 3 & 4

The Company will disregard any votes cast on Resolutions 3 or 4 by or on behalf of any of the Company's key management personnel (**KMP**) details of whose remuneration are included in the Remuneration Report or a closely related party of such a KMP unless the vote is cast by:

- (a) a person as proxy for a person entitled to vote and in accordance with a direction on the proxy form; or
- (b) the Chair as proxy for a person entitled to vote whether or not that person has directed the Chair how to vote.

All your securities will be voted in accordance with your directions.

Vote Directly

Voting 100% of your holding: Mark either the For, Against or Abstain box opposite each item of business. Your vote will be invalid on an item if you do not mark any box OR you mark more than one box for that item.

Voting a portion of your holding: Indicate a portion of your voting rights by inserting the number of securities you wish to vote in the For, Against or Abstain box or boxes. The sum of the votes cast must not exceed your voting entitlement.

Appoint a Proxy to Vote on Your Behalf

Voting 100% of your holding: Direct your proxy how to vote by marking one of the boxes opposite each item of business. If you do not mark a box your proxy may vote or abstain as they choose (to the extent permitted by law). If you mark more than one box on an item your vote will be invalid on that item.

Voting a portion of your holding: Indicate a portion of your voting rights by inserting the percentage or number of securities you wish to vote in the For, Against or Abstain box or boxes. The sum of the votes cast must not exceed your voting entitlement or 100%.

Appointing a second proxy: You are entitled to appoint up to two proxies to attend the meeting and vote on a poll. If you appoint two proxies you must specify the percentage of votes or number of securities for each proxy, otherwise each proxy may exercise half of the votes.
