Employee Rights Plan – Appendix 2A and Appendix 3G

IMDEX Limited ACN 008 947 813 (IMDEX or Company) advises that the Company has issued:

- 3,956,292 IMDEX shares to qualifying participants pursuant to performance rights which have vested under the FY18 Employee Rights Plan, being for the performance period commencing 1 July 2017 and ending 30 June 2020.
