The Company has issued 414,371 fully paid ordinary shares to participants in the Company's Long Term Incentive Plan as a result of the vesting of various tranches of performance rights and these shares are held subject to a 12 month holding lock. In addition, a further 1,003,512 Performance Rights have been issued.
