	Answer: Yes. The Company continues to incur expenditure in relation to ongoing feasibility studies, which will be ongoing in the coming quarter.

Answer: Yes. Post quarter end the Company is seeking to place \$1.3m worth of Shortfall Shares under the Entitlement Issue announced to the ASX on 29 October 2024. The Company has firm commitments for \$1.3m which is in addition to the \$0.3m received from the Entitlement Issue in the December 2024 quarter.

Answer: Yes. The Company will continue to advance feasibility studies increasing the confidence of the project, which the Board believes will allow additional capital to be raised in the future.
