

## **Update of number of securities quoted on ASX, Voting Rights and Capital**

1 June 2017

The attached form provides an update to the number of CDIs quoted on the ASX. It reflects the net transfers to the CDI register from 1 May 2017 to 26 May 2017 (the latter date being the CDI consolidation record date), the CDI consolidation and new CDIs issued on 30 May 2017 as part of the merger with Janus Capital Group, Inc.

On 31 May 2017, Janus Henderson Group plc's capital consisted of 200,406,138 shares with voting rights. Janus Henderson Group plc holds nil shares in Treasury.

The above figure, 200,406,138, may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, Janus Henderson Group plc.
