Answer: The Company anticipates that the commencement of revenue inflows in the quarter ending 30 September, 2023, plus the \$540,000 received in the first week of July, 2023 from the exercise of options exercised, and approximately \$650,000 from R+D tax rebates claimed, will provide adequate near-term funding for the business.
