	<p>Answer: No, the Company's exploration-based expenditures are variable by nature and are adjusted to fit the Company's available funds as required from time to time. The Company deliberately has flexibility built into its forward work programs, and spending commitments will not be made without certainty of the Company's ability to meet those commitments when they fall due.</p> <p>The Company is seeking a JV / funding partner for several projects providing suitable terms are able to be obtained.</p>

	<p>Answer: Yes, the Company is currently evaluating potential capital raising and other alternatives.</p> <p>The Company also holds a substantial shareholding position of 10 billion shares approximately in Lakes Blue Energy NL (ASX-LKO), and these shares are now quoted on ASX. At the current share price for LKO shares on ASX these LKO shares have a value of approximately \$10 m. The Company disposed of 125 million shares in LKO off market at \$0.0008 during the quarter for proceeds of \$100,000.</p> <p>Based on its track record, and that of its Directors, the Company is confident that its future treasury management and capital raising initiatives will continue to be successful.</p>

	<p>Answer: Yes, in addition to the capital raisings already undertaken in the 12 months ended 30 June 2022, the Directors remain confident in the Company's projects, the value of its shareholding in Lakes Blue Energy, and in the Company's ability to continue to raise capital as required to fund the business.</p>
