Mighty Kingdom is extremely excited to introduce this IP to gaming audiences and expand the world set up by the film.

Currently in development, the original game will capture the anxiety-ridden exploration of Carnifex. Set against the equally beautiful and brutal backdrop of the Australian landscape, the game will be a narrative-driven experience as players are stalked by the iconic terrifying species.

The game is set for release in FY23 across PC and console.
